WATER TRANSFER POLICY OF 2004

1. Water for delivery within Kansas Bostwick Irrigation Districts (district) remains under the control of the landowner or landowners as recorded in the Office of the Register of Deeds in the county of the assessed classified acres and as Certified in the district office for Reclamation Reform Act (RRA) purposes

2. Landowners as described above, may reassign control of all or a portion of the water allocated to their property, by written notice delivered no less than 10 days before such transfer is to take place, to the office of the Kansas Bostwick Irrigation District. Control of allocated water reassigned by the owner or owners must identify the person or entity to receive the water and use the assigned water. The person or entity to transfer water to must have a tenant relationship with the landowner as recorded in the district office for RRA purposes.

3. Water may only be reassigned once during the irrigation season.

4. No reassignment will be allowed once releases from the reservoirs ceased ending the watering season.

5. During years of full supply (base supply deliveries) no reassignment will be Allowed .

6. Upon the boards discretion, transfers from above Lovewell Reservoir to below Lovewell Reservoir or from below Lovewell Reservoir to above Lovewell Reservoir may be restricted or not allowed.

Changes & additions to this policy may be made by the Board of Directors at any meeting called to transact business.
