CERTIFICATE OF APPROPRIATION FOR BENEFICIAL USE OF WATER

APPLICATION No. 385
PRIORITY DATE July 16, 1948

WHEREAS, It has been determined by the undersigned that construction of the appropriation diversion works has been completed, that water has been used for beneficial purposes and that the appropriation right has been perfected, all in conformity with the conditions of approval of the above-numbered application and in conformity with the laws of the State of Kansas,

NOW, THEREFORE, Be It Known that GUY E. GIBSON, the duly appointed, qualified and acting Chief Engineer-Director of the Division of Water Resources of the Kansas State Board of Agriculture, by authority of the laws of the State of Kansas, and particularly K.S.A. 82a-714, does hereby certify that, subject to vested rights and prior appropriation rights, the appropriator is entitled to make use of surface water in the Republican River to be diverted at a point located near the center of Section 7, Township 1 North, Range 9 West, Webster County, Nebraska, at a diversion rate not in excess of 314,160 gallons per minute (700 c.f.s.) and in a quantity not to exceed 102,521 acre-feet per calendar year for irrigation use, on lands in the Kansas Bostwick Irrigation District No. 2 served by the Courtland Canal System in Jewell and Republic Counties in Kansas.

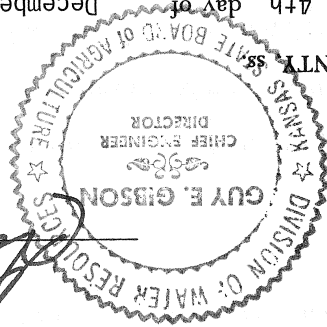
