Kenny,

We are concerned about halting the releases without a better understanding of whether this can be worked out. However, I do understand your concern about waiting until an agreement is finalized, when we are all fairly certain that the agreement can be reached. Therefore, if we can get to an agreement in concept we would feel comfortable with a temporary pause in the releases pending a final agreement being reached. I understand that the Bureau is working with you on the contracting issue, and that they are working on the accounting methodology. With these worked out and your agreement to use 2012 water first, we could have that agreement in principle. I'm expecting to hear back from Aaron later today. Please let me know if you have any additional thoughts.

Jim,

Thanks for the update.

It seems what is practical to one party is complicated to another. We are working with the Bureau on their concerns for making this work. I have had discussions with Mike Ryan and Aaron Thompson. Aaron told me he had requested a shutdown (my word) of the releases for a couple days to try to work this out. I have a Regular Board meeting scheduled for tomorrow morning and am hopeful I can have something positive to report for their action at that time. Even if things move rapidly it will surely take a few days to be completed. If the flow could be stopped or slowed it would surely be helpful.

I have read your correspondence back and forth between Mr. Barfield and Mr. Dunnigan. Regarding carry over water, it seems that letting today's problems be sufficient for today is the best we can do. I am hopeful a workable avenue may be found at a later date.

Kenny,

Brian asked me to get back to you with some additional comments. We have had a chance to review your letter dated May 3, 2013, and we are encouraged by the opportunity to work with you to allow for the use of water in Harlan County Lake. Your practical approach is consistent with what Nebraska had been working toward. I have spoken with Aaron today to exchange our viewpoint and to hear what they think. I understand the Bureau has some concerns about the need for a special contract and payment for the water. Those are not Nebraska's concerns, and if you and the Bureau work that out, then we are optimistic that your proposal can work.

The only other thing that needs to be determined is how the Bureau will account for the 2013 Compact water relative to the previously stored water. We need to make sure the Bureau accepts your plan to use the previously stored water first, and exhaust that supply, before using any 2013 Compact water. I don't think this should be very complicated, but we just need to agree up front on how that will work.

As to carrying over water until 2014, Nebraska has been willing to discuss that, but needs some assurance from Kansas that Nebraska will not be liable for any accounting impacts as a result of the carry over. To date Kansas has been unwilling to offer that assurance. I assumed that the Kansas Division of Water Resources was working closely with you on these matters, but maybe I assumed incorrectly. Your plan would buy time for you and Mr. Barfield to discuss that matter. Perhaps you can reach some agreement that we could not with Mr. Barfield. If you cannot make any progress, then under your plan the 2013 Compact water held in Harlan County Lake would probably need to be released before the end of 2013 if you have not used it for irrigation.

Thanks again for your letter.
