

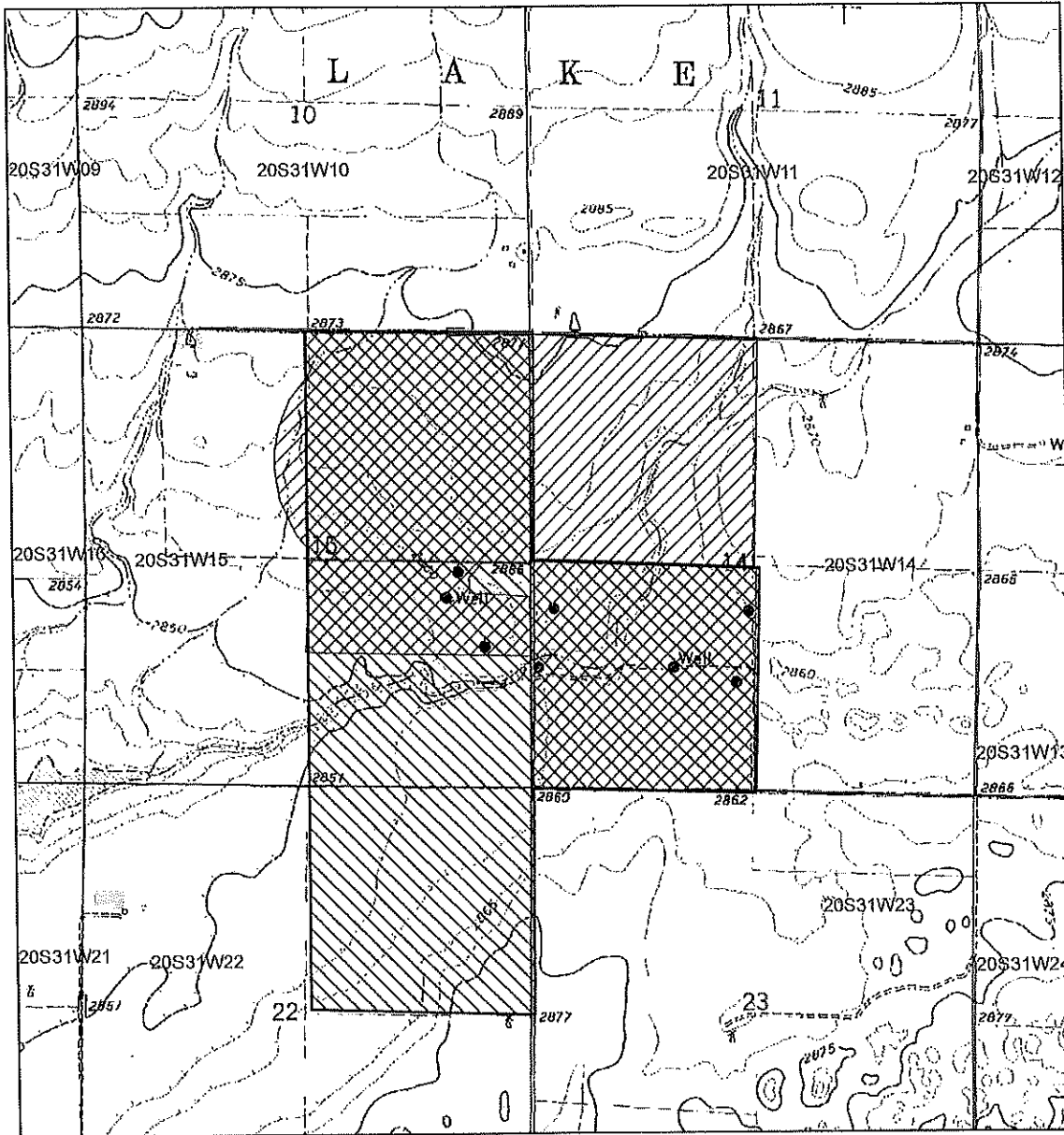

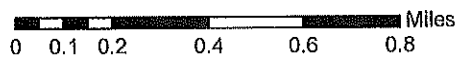
# Change in Place of Use for Water Rights 7767, 9309, 10443, 12741, 16826, 19192
