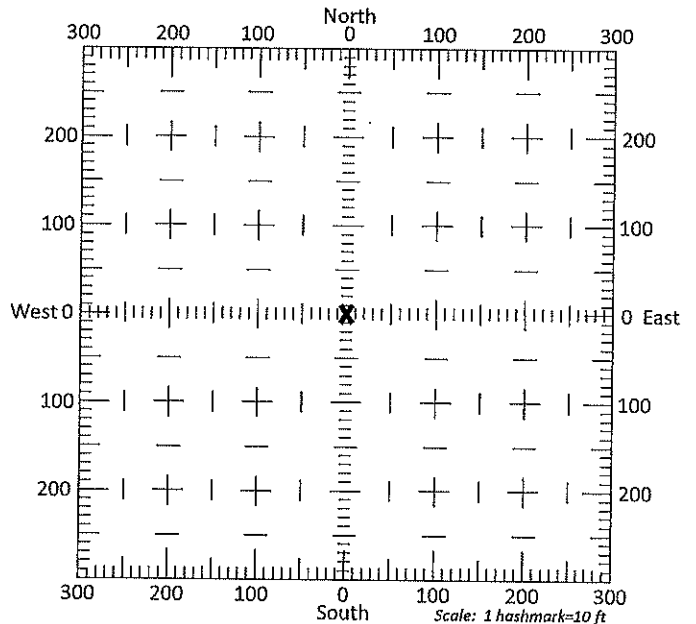

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law*, K.S.A. 82a-701 *et seq.*, and rules and regulations promulgated thereunder, With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 23123.



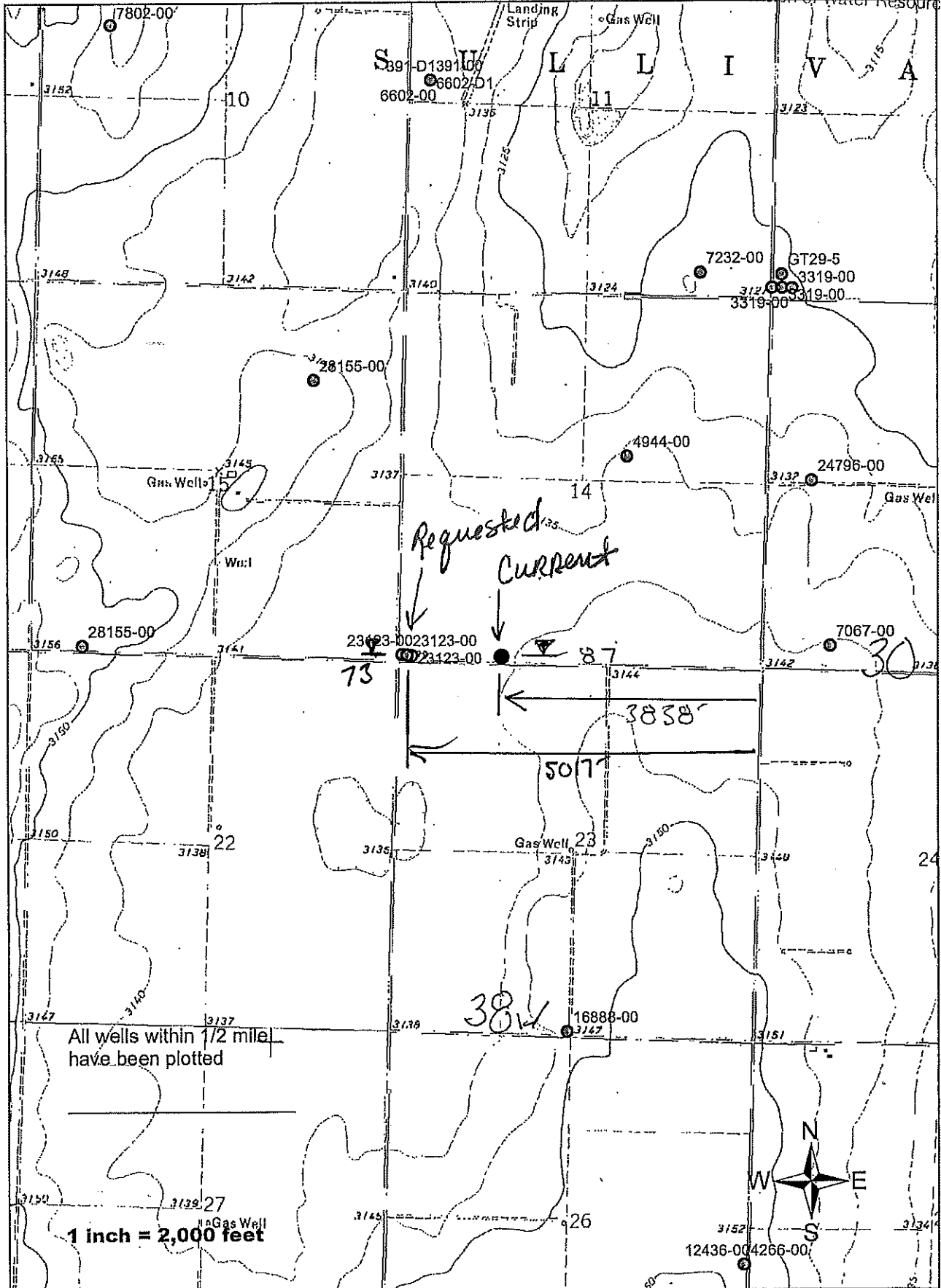

We are delaying action for 15 days on the change application to allow you time to review and provide a recommendation if you feel one is warranted.

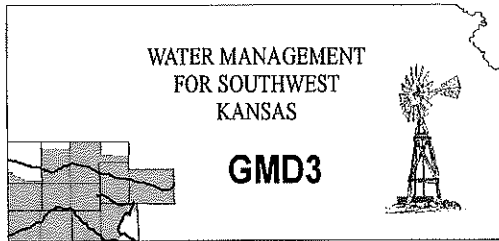

**WR was approved to move to this PD 08/26/15. Applicant did not have good production from the new well and this application is to move the well back to the original PD.**

Is a waiver needed: No.
