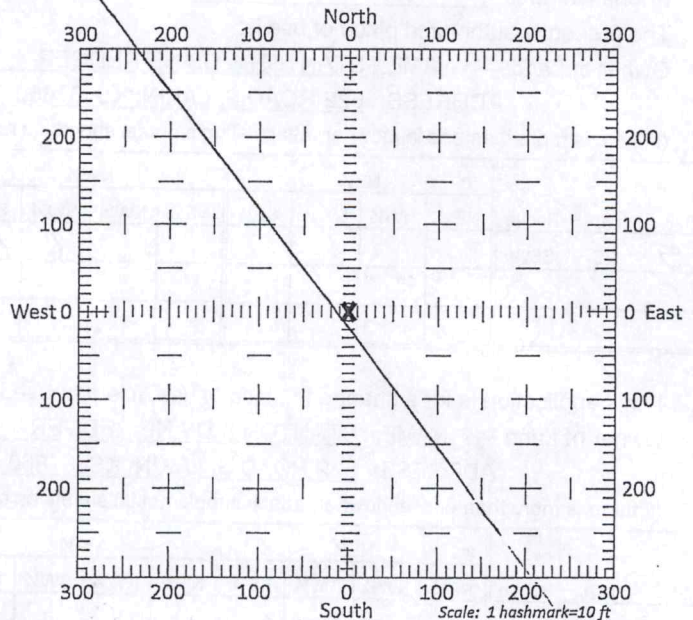

SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et. seq.*, and rules and regulations promulgated thereunder. With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 17878-01.

1. A change application was received on APRIL 18, 2019 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

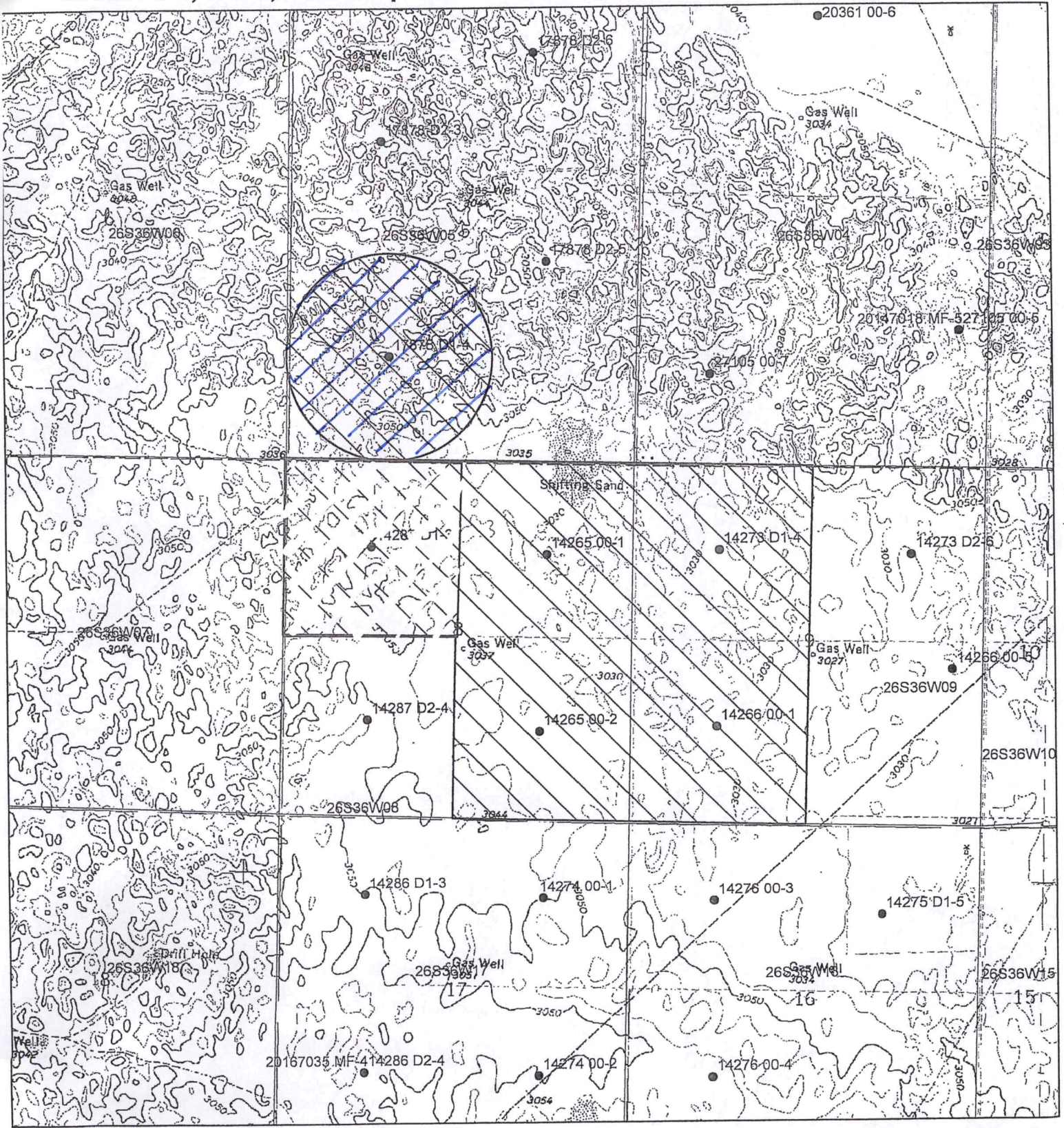

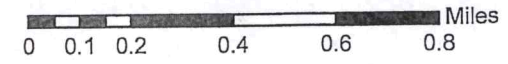

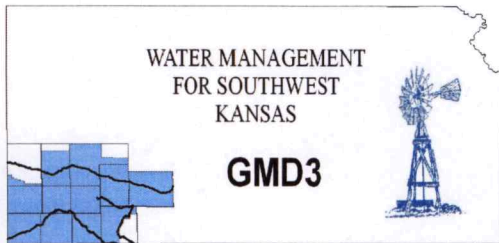


Change in Place of Use for Water Right 17878 D1 Sections 5, 8 & 9, Township 25 South, Range 36 West, Kearny County



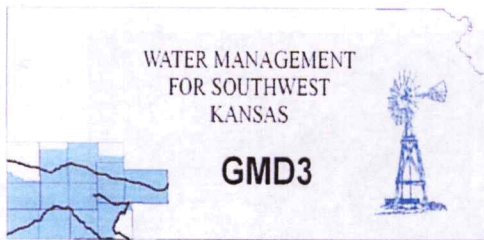


