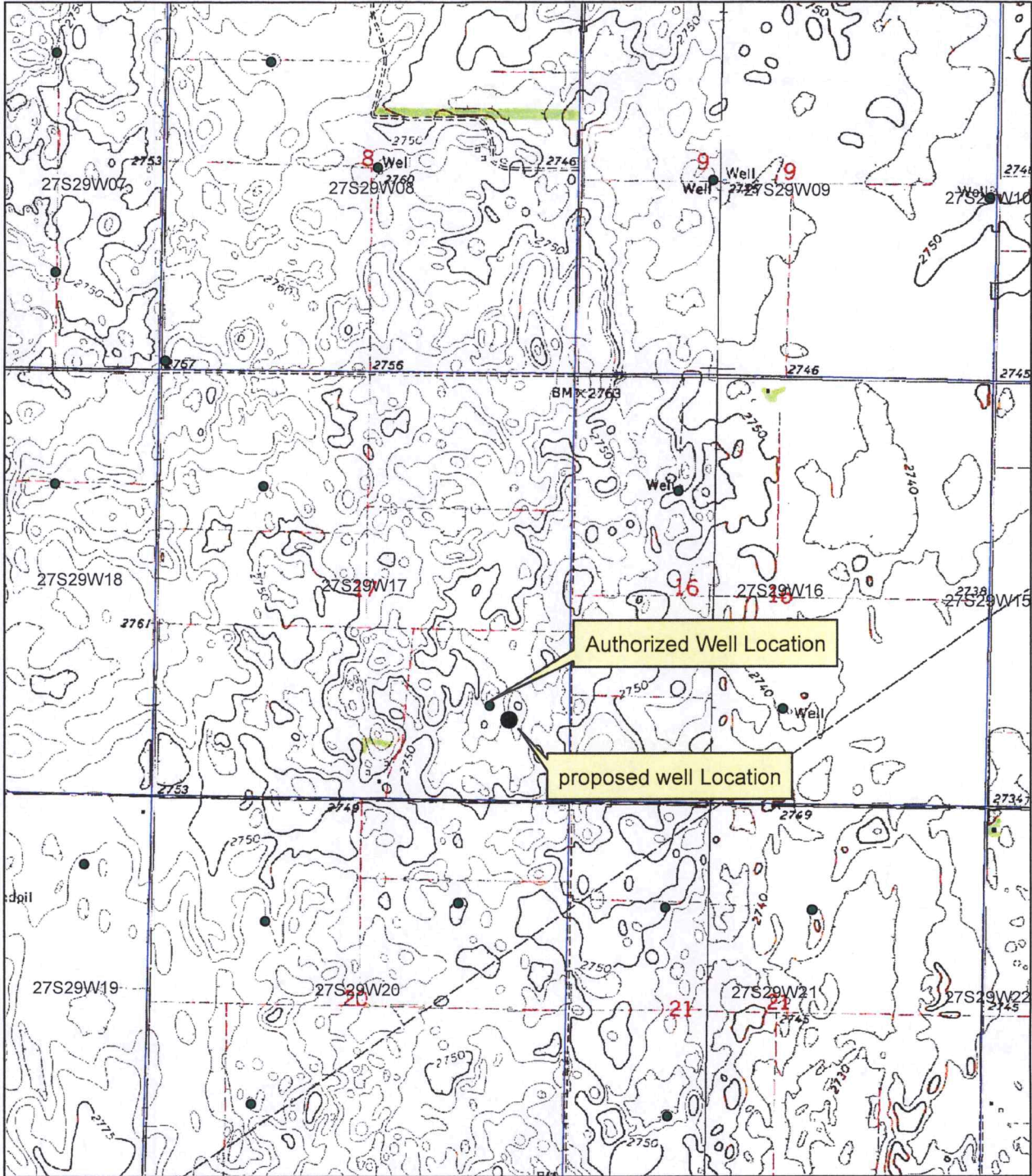




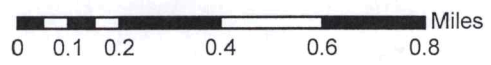




# Change in Point of Diversion for Water Right 18975 < 27535 Section 17, Township 27 South, Range 29 West, Gray County
