Liberty Midstream Pipeline LLC – Term and Temporary Permit Applications for Trench Dewatering

Dear Ms. Baum.

Liberty Midstream Pipeline LLC (Liberty) plans to construct the Liberty Pipeline Project (Project), which is an approximately 720-mile, 24-inch diameter crude oil/condensate pipeline and associated appurtenances originating in Guernsey, Wyoming and terminating in Cushing, Oklahoma. Construction is currently scheduled to begin in Kansas in the second quarter of 2020 with an in-service date of the first quarter of 2021.

Based on communications with the Kansas Department of Agriculture and the Groundwater Management District Offices, the attached applications are grouped by respective permitting limitations (e.g., term, temporary, length of permit). Application Group A contains term permit applications for dewatering locations in Groundwater Management District (GMD) 1, GMD 4, and all other locations outside of or considered non-GMDs. Application Group B contains term permit applications for dewatering locations in the Upper Smoky Hill and Pawnee Valley Expansion Intensive Groundwater Use Control Areas (IGUCAs). Application Group C contains temporary permit applications for dewatering locations in GMD 5.

There are currently a total of 977 dewatering locations across all three group permit applications. Table 1 breaks down permit application information for the Project. Each application group have respective application forms, crossing tables containing location information and crossing IDs, and Project maps. The mapping provided herein is in response to the location question in Section 7 of the application forms.

Installation of the new pipeline will require excavating a trench typically 5 to 7 feet deep, and in some cases up to 10 feet deep, in which to place the pipeline. Groundwater intrusion into the trench may occur, requiring dewatering. The precise location(s) of where construction dewatering will occur along the Project corridor is currently unknown and is subject to change. Discharge rates will vary between locations depending upon trench length, pump size, number of pumps, water depth and inflow rate, and surface runoff control. In order to calculate the filing fee, an estimated average discharge rate of 250 gallons per minute was used to determine the proposed maximum annual amount of water use. However, the maximum annual amount of water use is also subject to change based upon field conditions.
