PROPOSED PLACE OF USE

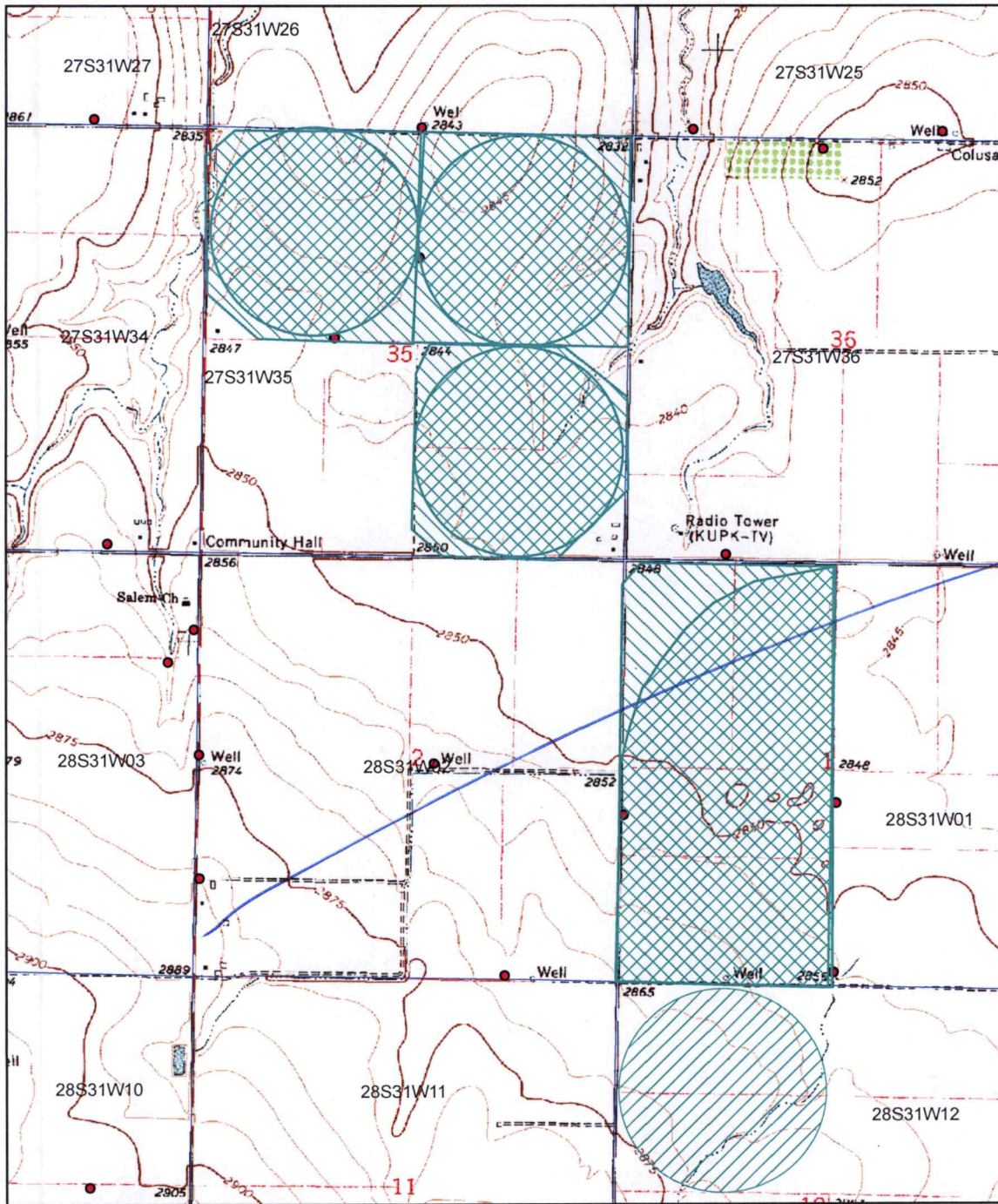

# Change in place of use for water right 21985

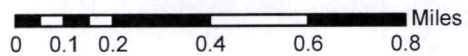


Authorized place of use



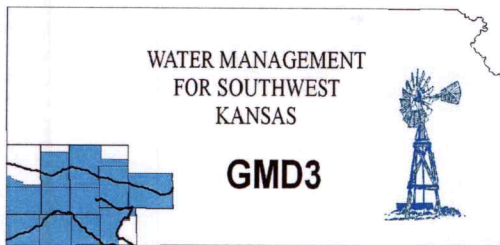
Proposed place of use
