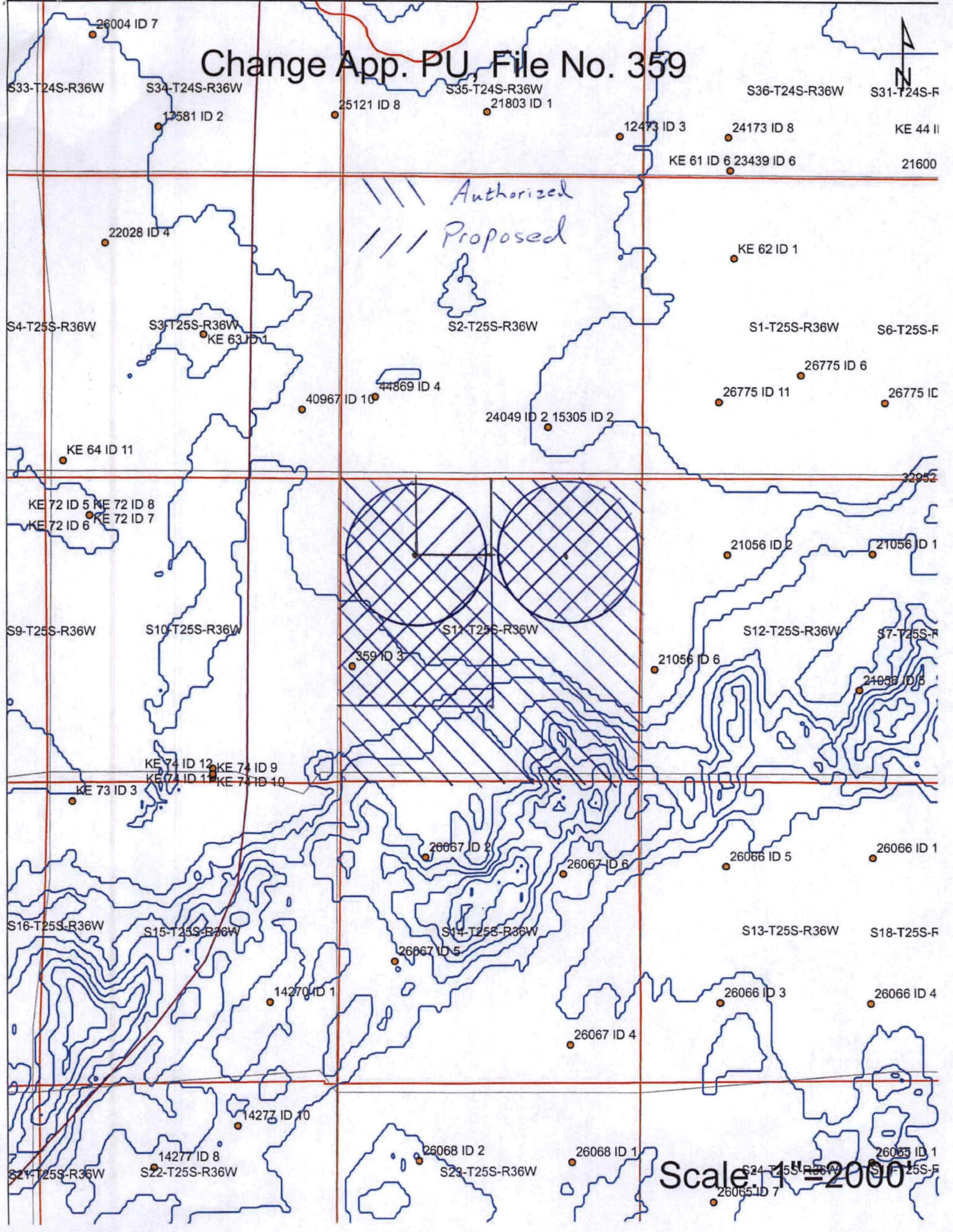




# Change App. PU, File No. 359


