Any use of water that is not as authorized by the water right or permit to authorize water **before** the chief engineer approves this application is a violation of the Kansas Water Appropriation Act for which criminal or civil penalties may be assessed. Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse. If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.

In the event that all applicants cannot appear before one notary public, they may as necessary sign separate copies of the application before any notary public conveniently available to them. All copies signed in this manner shall be considered to be valid parts of the application.

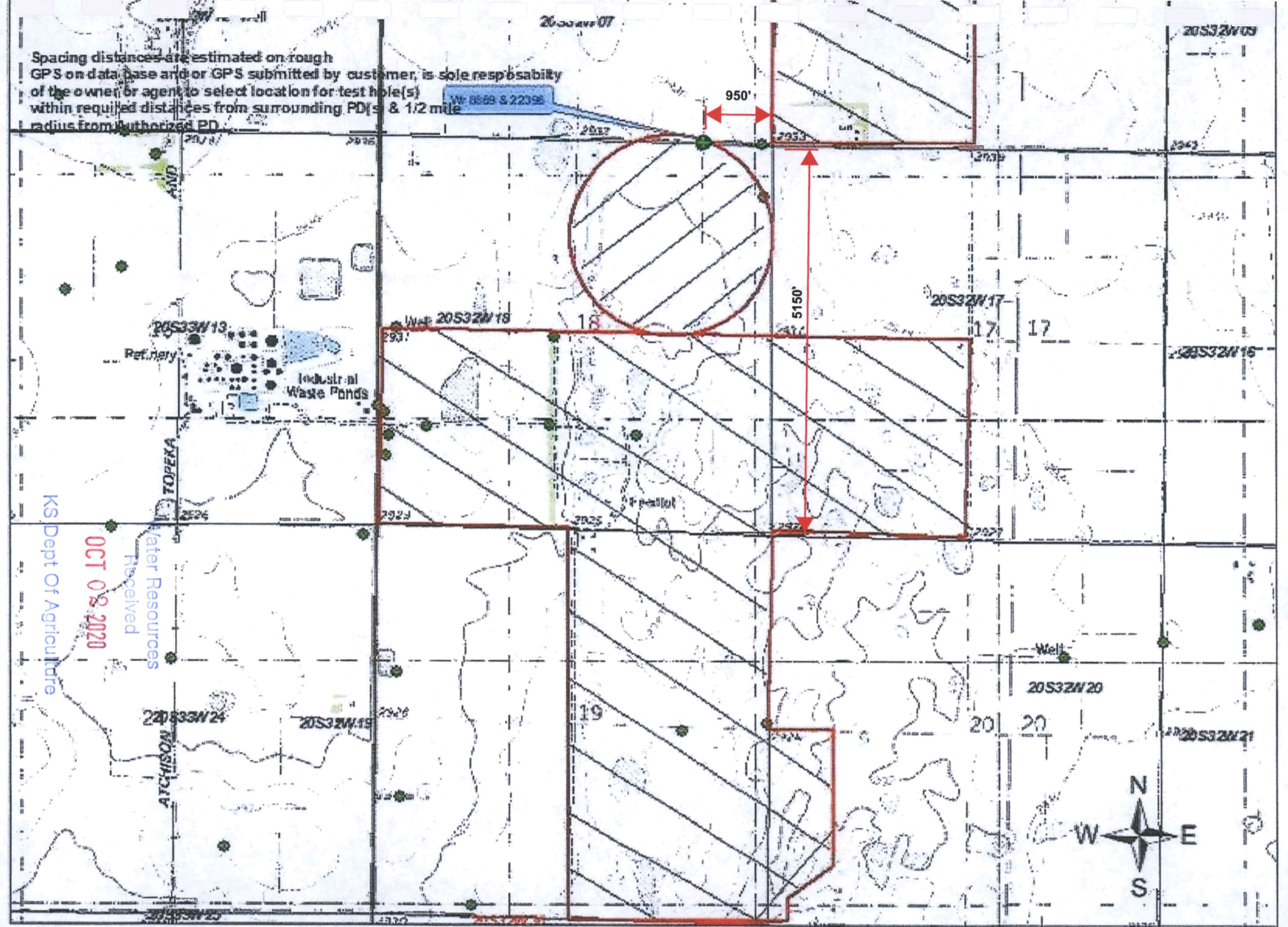

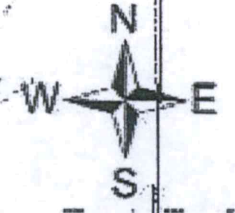

This permit is effective June 5, 2019, supersedes the previously issued water pollution control permit A-UASC-C017, and expires June 4, 2024.

Facility Summary

This is an existing facility for 83,000 head (83,000 animal units) of beef cattle weighing more than 700 pounds, 6,500 head (650 animal units) of swine weighing 55 pounds or less, and 4,615 head (1,846 animal units) of swine weighing more than 55 pounds, for a total of 85,496 animal units. The facility has a total of approximately 682 acres of drainage area. The facility is proposing to add 18,370 head (18,370 animal units) of cattle weighing greater than 700 pounds, an additional wastewater retention structure, and the addition of approximately 133 acres open lot pens, resulting in 101,370 head (101,370 animal units) of beef cattle weighing more than 700 pounds with no increase in swine animal units for a total of 103,866 animal units and a total drainage area of approximately 815 acres.
