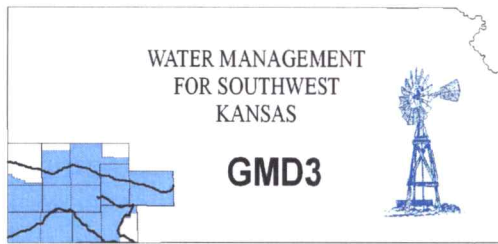


-  Authorized Point of Diversion


