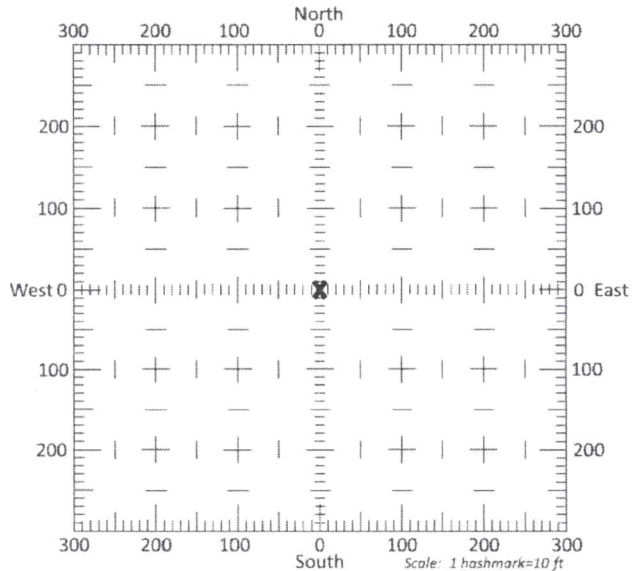

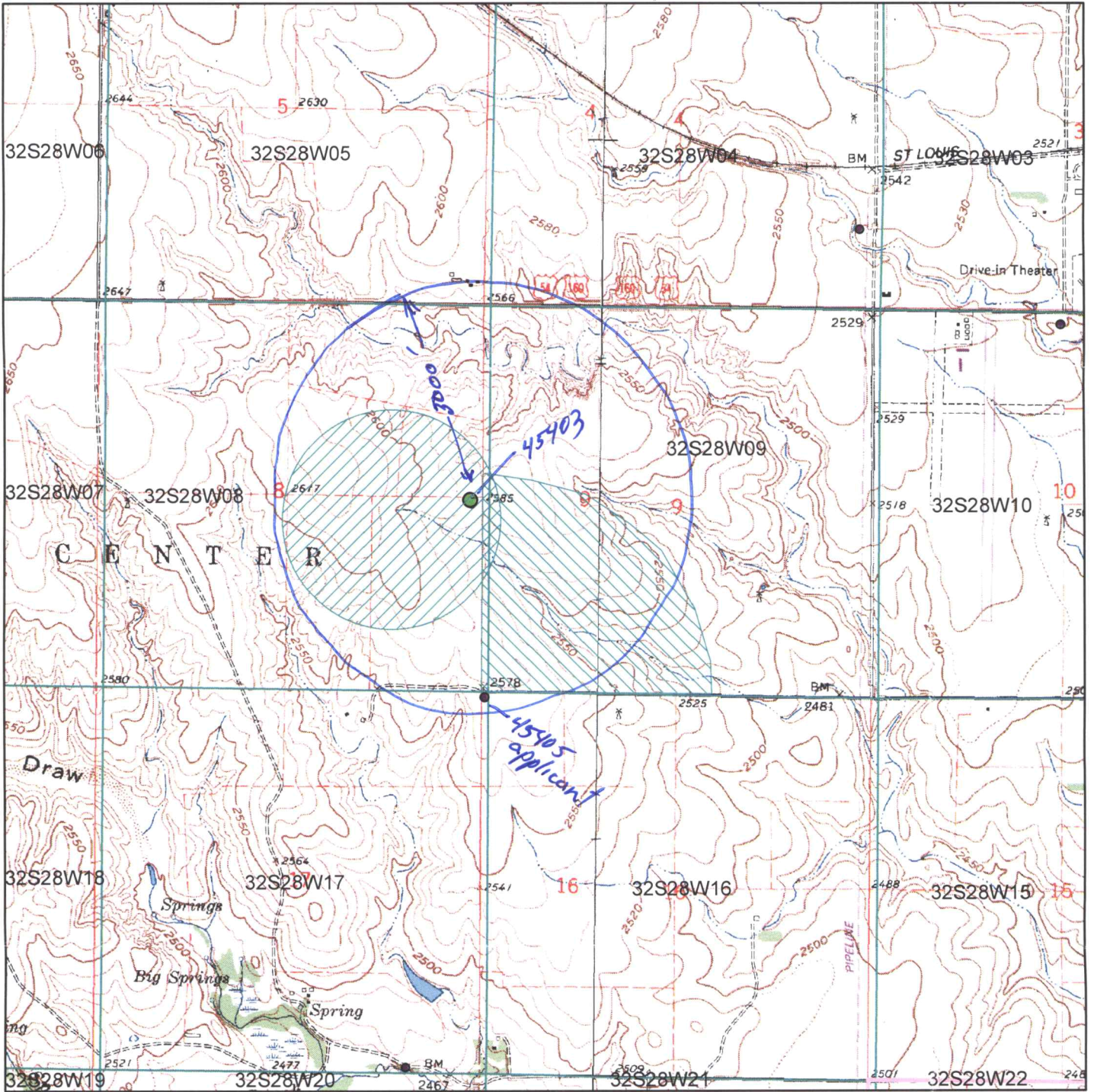

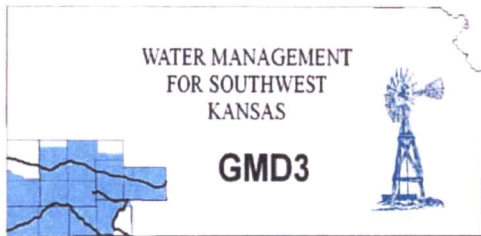
Change in place of use application for water right 45403


