RE: Water Right File No. 11,742

Gary and Beth Wilbur owners of the referenced water right have filed an application for approval to change the points of diversion authorized for irrigation use under the referenced file. The application was filed in this office on December 17, 2021.

The referenced water right is in good standing as per K.S.A. 82a-718, and appears to be in compliance with K.S.A. 82a-732. It appears the application complies with K.A.R. 5-5-2a, *Complete change application*.

The right is authorized two (2) wells with a blanket rate of 650 gallons per minute (GPM), (1.45 c.f.s.) for the diversion of 320 acre-feet to irrigate 160 acres in the Northwest Quarter (NW¹/₄) of Section 7, Township 17, Range 36 West, Wichita County. The WRIS database, lists the wrong authorized GPM and additional GPM. The correction is a database only correction. The previous Order in 2017 is correct.

The well proposed to remain the same will update its description to one well located in Lot 1 of the Northwest Quarter of the Northwest Quarter (NW¼ NW¼) of Section 7, more particularly described as being near a point 4,887 feet North and 5,216 feet West of the Southeast corner of said section, in Township 17 South, Range 36 West, Wichita County.

From the Southeast corner of Section 7, the well authorized at 5,248 feet North and 4,180 feet West, identified as ID No. 4, will be caped and a new well drilled at 1,053 feet North and 4,013 feet West, in Lot 4 of the Southwest Quarter of the Southwest Quarter (SW¼ SW¼). The well will move approximately 4,167 feet to the South. The requirement that wells not be more than 1,320 feet from the originally authorized point of diversion, which was located 3,536 feet North and 4,872 feet West from the Southeast corner of Section 7, results in a move of approximately, 2,640 feet, so it would appear a waiver of Part (d) of K.A.R. 5-21-3, is needed as allowed by Part (f) of the regulation.

The right is not in a special use area, the source of supply has been determined for ID No. 4, as the Ogallala formation (Code 211). A review of the logs with the rights well depths of approximately 200 feet and a static water level in August of 2014 of 160, and information in KGS Bulletin No. 126, for the Ladder Creek area, would indicate the source of supply is the Ogallala Formation (Code 211) with a small amount of the Niobrara Chalk Formation (Code 321) identified.

There does not appear to be any domestic wells located within one-half($\frac{1}{2}$) mile of either well requested by the change. The South proposed well has just one nearby irrigation well under File No. 23,897, which is indicated by WRIS to be 2,700 feet away. There is a large stockwatering facility to the Southwest. It's wells are further to the Southwest. No nearby well owners were notified, as all were greater than 2,640 feet away.

The two (2) wells authorized and proposed meet the minimum well spacing as the change will increase the distance between the wells by more than 300 feet, and each well will be located greater than 2,640' from any other well.


In a letter dated March 22, 2022, Toni Palen, Administrative Assistant GMD 1, indicated the Board recommended the application be approved with a **waiver of K.A.R. 5-21-3**. GMD 1 is currently without a Manager. The board justified their recommendation based on water quality issues.

Michael Meyer, Water Commissioner of the Garden City Field Office, recommended approval of the proposed change per his March 23, 2022, E-mail.

Water flowmeters will be required on each well and a check valve is required if any chemical or foreign substance is injected through the diversion works. A WWC-5 will be requirement of the approval. A water level measurement tube will be required by the approval.

Based on the above discussion, that the change appears to be reasonable, that no change in the local source of supply will occur, that impairment to existing water rights is unlikely, that there are no pending applications within the vicinity of this proposed change request that may be affected by this approval, it is recommended that the referenced application be approved.







The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Gary and Beth Wilbur, 426 West County Road L, Leoti, Kansas 67861-6270, received in this office on December 17, 2021, for approval of a change in the location of the point of diversion under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, as modified and amended by the Order of the Chief Engineer dated October 13, 2014, approving the application to change the authorized point of diversion and by the Order of the Chief Engineer dated May 18, 2017, approving the application to change the authorized point of diversion, finds that the change is reasonable and will not impair existing rights, that the change relates to the same local source of supply and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the points of diversion shall be:

one (1) well located in in Lot 1 of the Northwest Quarter of the Northwest Quarter (NW¼ NW¼) of Section 7, more particularly described as being near a point 4,887 feet North and 5,216 feet West of the Southeast corner of said section, and

one (1) well located in in Lot 4 of the Southwest Quarter of the Southwest Quarter (SW¹/₄ SW¹/₄) of Section 7, more particularly described as being near a point 1,053 feet North and 4,013 feet West of the Southeast corner of said section,

both in Township 17 South, Range 36 West, Wichita County, Kansas,

located substantially as shown on the topographic map accompanying the application to change the point of diversion.

Installation of the works for diversion of water shall be completed on or before December 31, 2022, or within any authorized extension of time. The applicant shall notify the Chief Engineer of the Division of Water Resources, Kansas Department of Agriculture, when construction of the works for diversion has been completed.

All wells with a diversion rate of 100 gallons per minute or more drilled under the authority of this order shall have a tube or other device installed in a manner acceptable to, and in accordance with specifications adopted by, the Chief Engineer. This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.

RE: Water Right, File No. 11,742

The water right owner shall submit to the Chief Engineer a copy of the well log for the new point of diversion as required by the Kansas Department of Health and Environment under the authority of K.S.A. 82a-1212, currently form WWC-5, following the drilling of the well at the authorized location.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 11,742, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated April 15, 1977, as modified and amended by the aforementioned orders.
