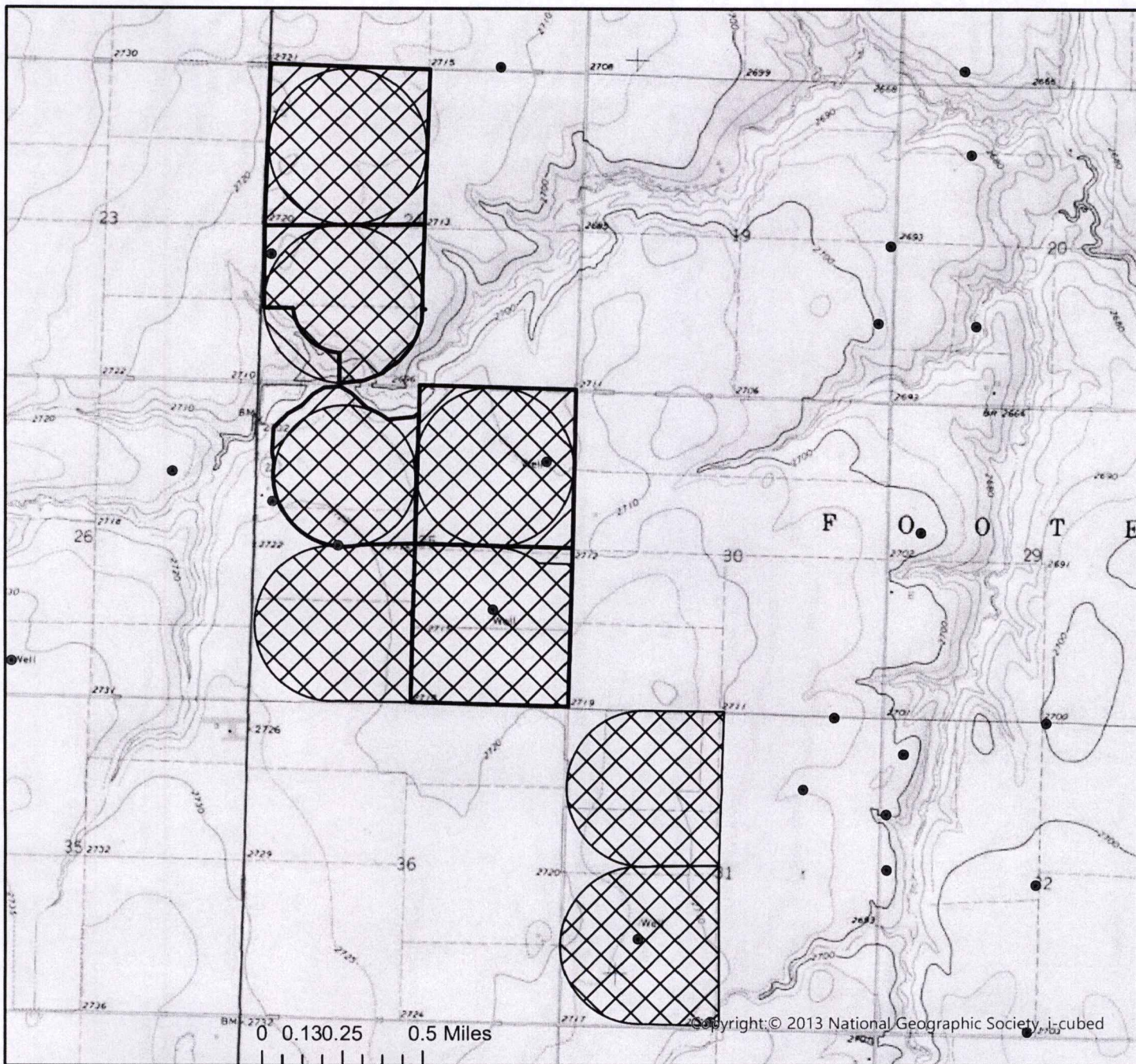






# CHANGE IN PLACE OF DIVERSION WATER RIGHT, FILE NO. 12456

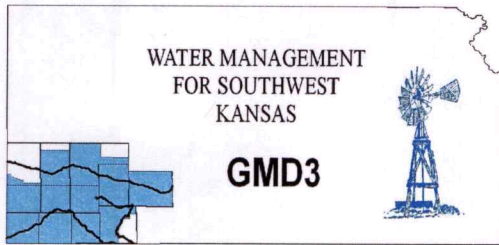
