One-Each Farms – Marlin Heger filed the referenced application for Term Permit on April 16, 2021, to appropriate groundwater for irrigation use in Stevens County. The applicant proposed a quantity of 200 acrefeet of groundwater per year, at a maximum diversion rate of 700 gallons per minute. The proposed term period was from March 31, 2021 to December 31, 2022.

K.A.R.5-9- 1 b of the Kansas Water Appropriation Rule and Regulations states in part: "Approvals and extensions of term permits. (a) Except as specified in subsection (b), each approved term permit shall be valid for five years or less. A term permit shall not be extended for a total of more than five years, including the original approval..."

There have been five previous term permits for the project requesting a year term each thus the current applied term permit will be the sixth consecutive request. The five previous term are as follows: 20169055; 20179043; 20189006; 20199022 and 20209035.

On October 18, 2021, the application for approval of the Chief Engineer for Term Permit was returned to you and, at that time, you were advised that the application was to be returned to this office, with the requested additional information, no later than November 2, 2021.

The application with the requested additional information was not returned to this office by November 2, 2021, or a request for additional time beyond the 15 days to submit additional information has been received.

The included Findings and Order will be issued for this voluntary dismissal. due to failure to return.*

- 1. - 2.
