

Field office change applications of the above referenced files were received requesting two different proposals. The first proposals are requesting that File Nos. 15466 and 28584 switch priorities of their authorized point of diversion locations. This proposal meets all rules. The applications were sent the GMD3 for a recommendation, no recommendation was received within 15 days, with a reminder on the 18th day. Their website has no review documented either

The second request of these same applications, is once approved (and officially notified of the completion on paper), the new location for File No. 28484 will have the priority switched again with File No. 9177. This proposal meets all the rules except with a question on actual distance between the two wells on section 28. With this proposed priority switch, there would now be 632 AF on the NW quarter of section 27 which would require a 2300' spacing (KAR 5-23-3) to the nearby well in the SW Quarter of section 27, of the same owner and application process as described on the first step referenced above. GPS locations show that these two wells are approximately 2269' between them with GPS accuracy with possible greater than 15 feet error at each location which could meant the two wells are over 2300' apart. Since the are owned by the same landowner, the wells exist today, and apparently meet spacing due to accuracy in the field issues, we are recommending that all applications meet all rules. GMD3 never did provide a recommendation for step two process of these applications, nor find any review on their website with the 15 days past due.

This office recommends approvals of all applications.
