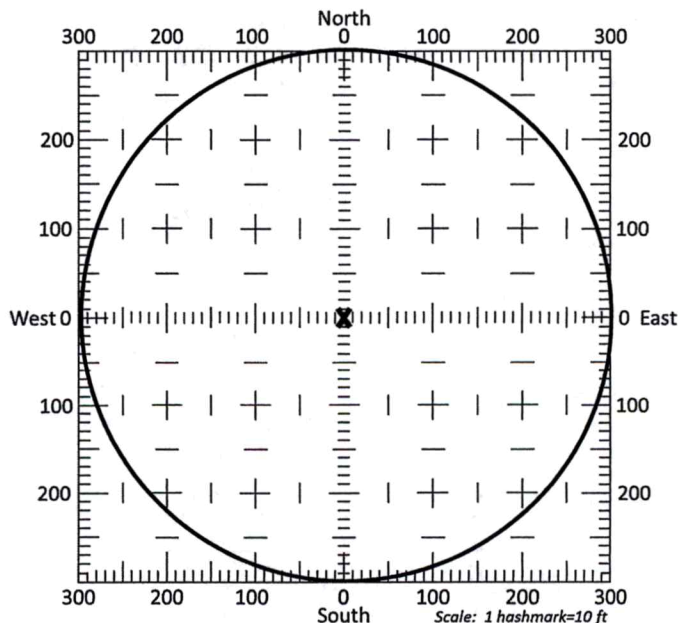

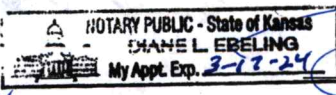

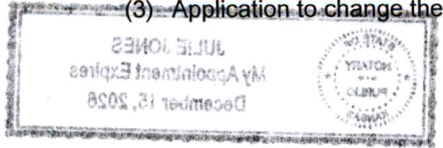

**SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS**

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et. seq.*, and rules and regulations promulgated thereunder, With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 6030-A

1. A change application was received on May 12, 2023 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.

Dear Mike:

We have reviewed the application for the above referenced water right. The proposal is not in conflict with the Management Program of the Southwest Kansas Groundwater Management District No. 3 (GMD3). The proposed change in place of use will rearrange the acres to better suit the current operation and keep the acres within the allowable range, in accordance with K.A.R. 5-5-11(b). It is therefore recommended that the application be approved at this time.
