### SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et. seq.*, and rules and regulations promulgated thereunder, With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. <u>4008</u>

- 1. A change application was received on <u>APRI 7, 2,825</u> requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.



WR 4008 Change in Point of Diversion


