

The Equus Beds Groundwater Management District No. 2 reviewed the referenced change in place of use applications (No. 24902 – groundwater; No. 27996 – surface water) applications on July 22, 2016 using the District's Revised Management Program (effective May 1, 1995) and Rules and Regulations K.A.R. 5-22-1 through 5-22-17.

Under the change applications, the places of use were modified and formed an identical place of use overlap totaling 65 acres between the referenced water rights. The total combined water to land ratio is approximately 1.35 acre-feet per acre under the place of use applications.

The change applications comply with the Revised Aquifer Management program approved by the Chief Engineer and with the District's Rules and Regulations K.A.R. 5-22-1 through 5-22-17. Therefore, the change applications are recommended for approval by the Equus Beds Groundwater Management District No. 2.

A District decision may be appealed to the District Board of Directors by submitting a written petition to the District office within 30 days from date of this notification, pursuant to K.A.R. 5-22-12.
