Robert A. Bacon filed the referenced application to appropriate groundwater for irrigation use, requesting a quantity of 112 acre-feet and a diversion rate of 800 gallons per minute. The proposed point of diversion will be one (1) well located 3,960 feet North and 3,960 feet West of the Southeast corner of Section 36, Township 23 South, Range 5 West, Reno County within the drainage basin of the Arkansas River Basin. No overlaps in the proposed point of diversion or place of use are proposed. The proposed acreage is owned by Robert C. Bacon Revocable Trust.

WRIS and the submitted application indicate there are two irrigation applications filed by Mr. Bacon (Application, File Nos. 49,589 and 49,592) and five domestic wells (one under common ownership) within one-half mile of the proposed well. The nearby domestic well owners were notified of the referenced application by letters dated October 25, 2016 sent by Erin McGrogan, former Environmental Scientist with the Permits Unit: no written responses have been received as of today's date.

In letter dated January 30, 2017 with attachments, Equus Beds Groundwater Management District No. 2 recommended the referenced application be approved and indicated that the application complies with K.A.R. 5-22-1 through K.A.R. 5-22-17.

The total quantity available for irrigation use by File No. 49,590, 112 acre-feet, will irrigate the proposed 80 acres with 1.4 acre-feet per acre and is the maximum reasonable quantity allowed pursuant to K.A.R 5-3-24 in Reno County.

A test hole log was submitted with the pending new application. The source of supply appears to be Equus Beds (190).

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R. 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed. A water level measurement tube is required. The applicant signed, notarized, and returned a minimum desirable streamflow form to our office.

In an April 6, 2017 e-mail Jeff Lanterman, Water Commissioner, Stafford Field Office, recommended approval of the referenced application.

Based on the above discussion, safe yield criteria are met, approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest, it has been recommended that the referenced application be approved.

Enclosed is the Findings and Order by the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, dismissing Application, File No. 49,591, for failure to meet safe yield criteria per K.A.R. 5-22-7(a).

In addition, enclosed are permits (File Nos. 49,587; 49,588; 49,589; 49,590; 49,592; 49,593 and 49,594) to appropriate water authorizing you to proceed with construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a), to divert such unappropriated water as may be available from the source and at the locations specified in the permits, and to use it for the purpose and at the locations described in the permits.

Your attention is directed to the enclosures and to the terms, conditions, and limitations specified in these permits. Water meters are required and you must install them prior to water being put to beneficial use in order for you to maintain accurate records of water use. The meters should be used to provide the information required on the annual water use reports.

Failure to notify the Chief Engineer of the Division of Water Resources of the completion of the diversion works within the time allowed, or within any authorized extension of time thereof, will result in the dismissal of these permits. Enclosed are forms which may be used to notify the Chief Engineer that the proposed diversion works have been completed.

All requests for extensions of time to complete diversion works, or to perfect appropriations, must be submitted to the Chief Engineer before the expiration of time originally set forth in the permit to complete diversion works or to perfect an appropriation. If for any reason, you require an extension of time, you must request it before the expiration of time set forth in this permit. Failure to comply with this regulation will result in the dismissal of your permit or your water right. Any request for an extension of time shall be accompanied by the required statutory fee, which is currently \$100.00.

There is also enclosed an information sheet setting forth the procedure to obtain a Certificate of Appropriation which will establish the extent of your water rights.

- 3. That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of one (1) well located near the center of the Northwest Quarter (NW¼) of Section 36, more particularly described as being near a point 3,960 feet North and 3,960 feet West of the Southeast corner of said section, in Township 23 South, Range 5 West, Reno County, Kansas, located substantially as shown on the map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of 800 gallons per minute (1.78 c.f.s.) and to a quantity not to exceed 112 acre-feet of water for any calendar year.
- 5. That installation of works for diversion of water shall be completed on or before <u>December 31, 2018</u> or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

- 6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2022</u> or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.
- 7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.
- 8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 12. That all wells with a diversion rate of 100 gallons per minute or more drilled under the authority of this permit shall have a tube or other device installed in a manner acceptable to, and in accordance with specifications adopted by, the Chief Engineer. This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.
- 13. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
- 14. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.
- 15. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.
- 16. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

17. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

This Order shall become a final agency action, as defined by K.S.A. 77-607(b), without further notice to the parties, if a request for hearing or a petition for administrative review is not filed as set forth below.

Request for Hearing. According to K.A.R. 5-14-3(c), any party who desires a hearing must submit a request within 15 days after the date shown on the Certificate of Service attached to this Order. Filing a request for a hearing will give you the opportunity to submit additional facts for consideration, contest any findings made by the Chief Engineer, or present any other information you believe should be considered in this matter. A timely-filed request for hearing will stay the deadline for requesting administrative review of this Order pending the outcome of the hearing.

Petition for Review. The applicant, if aggrieved by this Order, may petition for administrative review, pursuant to K.S.A. 82a-711(c) and K.S.A. 82a-1901(a). The petition must be filed within 30 days after the date shown on the Certificate of Service attached to this Order and must set forth the basis for the review, unless stayed by the timely filing of a request for hearing.







Well batteries confuse this old farmer so I also ran afoul of regulations on the Appropriation Application No. 49588. I received a letter saying my application placed my proposed well less than 1,320 from my neighbors well.

It is true I am trying to place a well just over 1,300 feet from a well battery site found on Water Permit No. 45358. That well was never developed. Only the center site of the three was developed. I am 1,650 to 1,700 feet from an actual well. That site was developed in 2003.

Does this matter?

If the Water Permit holder notified you that no development of the proposed east well was planned and would forfeit that location, would that matter?

Can there be a variance from regulations in special circumstances?

Thanks for any and all clarifications about my two above situations.

Oh yes, apparently I used incorrect data about existing and proposed consumptive appropriations when applying for water on Appropriation Application No. 49591. I will not appeal that denial.

During our review of the application, we noted that it appears that there were nearby well owners who were not notified of the application, as the irrigation well authorized by Water Permit No. 48881, and the groundwater pit authorized by Water Permit No. 46863, were not identified on the application map you submitted with the application. As this is a Division of Water Resources' requirement and they send out the surrounding well owner notifications, I suggest you contact Brent Turney, DWR, to discuss on how to handle this.
