



Attached, please find our completed Application For Approval-Point of Diversion Changes- Well #1-Well #4, which I received via email on July 27, 2018. As requested in your letter, please be advised that the Wichita Airport Authority is the rightful owner and of the Terminal Well (industrial application, No. 37008) which has been under term permit (KDHE) for remedial application by Learjet (Bombardier). This well is to be properly abandoned, however, given the upcoming demolition of the abandoned terminal structure. Additionally, it would be noted that this suspension of remedial activity was requested by Learjet and approved by the KDHE-BER group earlier this year. (It is our understanding that the analytical quality of the groundwater will continue to be assessed quarterly through existing monitoring wells located on WAA property).

I have included a map of irrigation wells located on WAA owned property in the vicinity of the requested points of diversion; this map should meet those guidelines regarding groundwater utilization within the 1/2 mile radius of WRB-Appropriation Well-#1 through Well #4:

- The WRB-Appropriation wells are labelled
- WAA has jurisdiction of (2) 5-inch irrigation wells; WWC-5 on record
- Tenant jurisdiction of (8) 5-inch irrigation wells; WWC-5 on record


