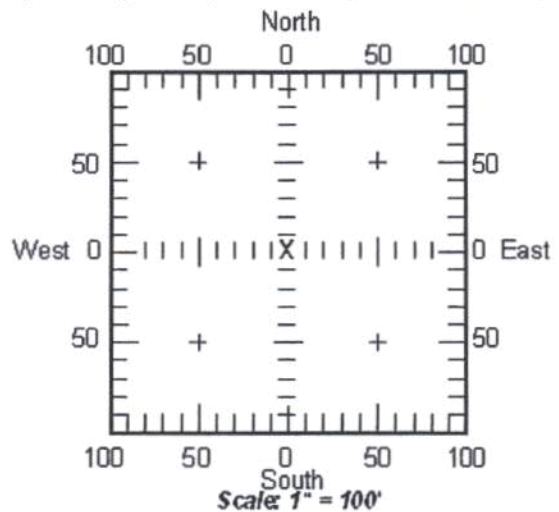

The Equus Beds Groundwater Management District No. 2 reviewed the referenced change in place of use application on May 14, 2018, using the District's Revised Management Program (effective May 1, 1995) and Rules and Regulations K.A.R. 5-22-1 through 5-22-17.

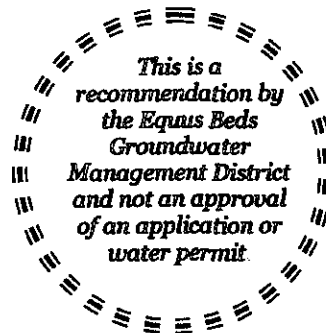
The change application proposes to reconfigure the place of use and change the total authorized acres from 237 to 236 acres, which is a 10 acre increase of the 226 authorized base acres. The proposed place of use results in a water to land ratio of 1.3 acre-feet per acre.

The District's review found that the change application complies with the Revised Aquifer Management program approved by the Chief Engineer and with the District's Rules and Regulations K.A.R. 5-22-1 through 5-22-17. Based upon the review, the application is recommended for approval by the Equus Beds Groundwater Management District No. 2.
