Phillip Hathcock on behalf of Barton County, owner of the above referenced water right, has filed an application for approval to change the use made of water under Water Right, File No. 41,493.

The referenced file number does not appear to be abandoned as per K.S.A. 82a-718.

The change in use made of water proposes to change the use from industrial use to recreational use. The certificate was recently issued on July 23, 2018, and the applicant has submitted a signed Joint Stipulation for Discontinued Pit or Quarry. Since the owner consents that the pit should not be expanded any further, the authorized quantity of water should not be increased by additional evaporation.

There are five permitted water rights within one half mile of the geographic center of the groundwater pit. The owners of these wells were notified by mail of the proposed change. No responses were received.

In a letter dated August 28, 2018, a letter was sent to Big Bend Groundwater Management District No. 5 along with a request to provide a recommendation. In a letter dated September 11, 2018, Orrin Ferril, Manager GMD No. 5 recommended approval of the application.

In an e-mail dated September 11, 2018, Jeff Lanterman, Water Commissioner of the Stafford Field Office, indicated that he is not opposed to approval of the application.

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, that no change in the local source of supply will occur and the new application, File No. 48,069 should prevent any increase in the consumptive use, it is recommended that the referenced application be approved.

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Phillip Hathcock on behalf of Barton County, 1400 Main St, Suite 108, Great Bend, Kansas 67530, received in this office on July 25, 2018, for approval of a change in the use made of water, for approval of a change in the location of the place of use under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, finds that the change is reasonable and will not impair existing rights and that the application should be and is hereby approved.

The effective date of the changes shall be the date this order is executed by the Chief Engineer, after which the authorized use made of water shall be:

Recreational use, in two (2) groundwater pits with a total surface area of 19.6 acres located in the Southeast Quarter (SE $\frac{1}{4}$) of Section 32, Township 19 South, Range 13 West, Barton County, Kansas,

located substantially as shown on the map accompanying the application to change the place of use.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 38,315, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated July 23, 2018.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 18 days after this Order was mailed to you**), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 33 days after this Order was mailed to you**), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

JOINT STIPULATION FOR DISCONTINUED PIT OR QUARRY

This stipulation is filed to provide information regarding annual evaporative loss from the aquifer and to free the owner from having to file annual water use reports otherwise required as a condition of the approval of the permit. This stipulation is only available when the authorized pit or quarry is no longer used for industrial purposes.

As a matter of record, the Division of Water Resources has on hand a large number of applications awaiting processing. Therefore, to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. You will be contacted regarding this application as soon as it has been examined.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water prior to approval of the application is unlawful. You should not proceed and divert water as indicated by your plans in your application for a change for this file until you receive approval for this change from the Chief Engineer. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor...

A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.

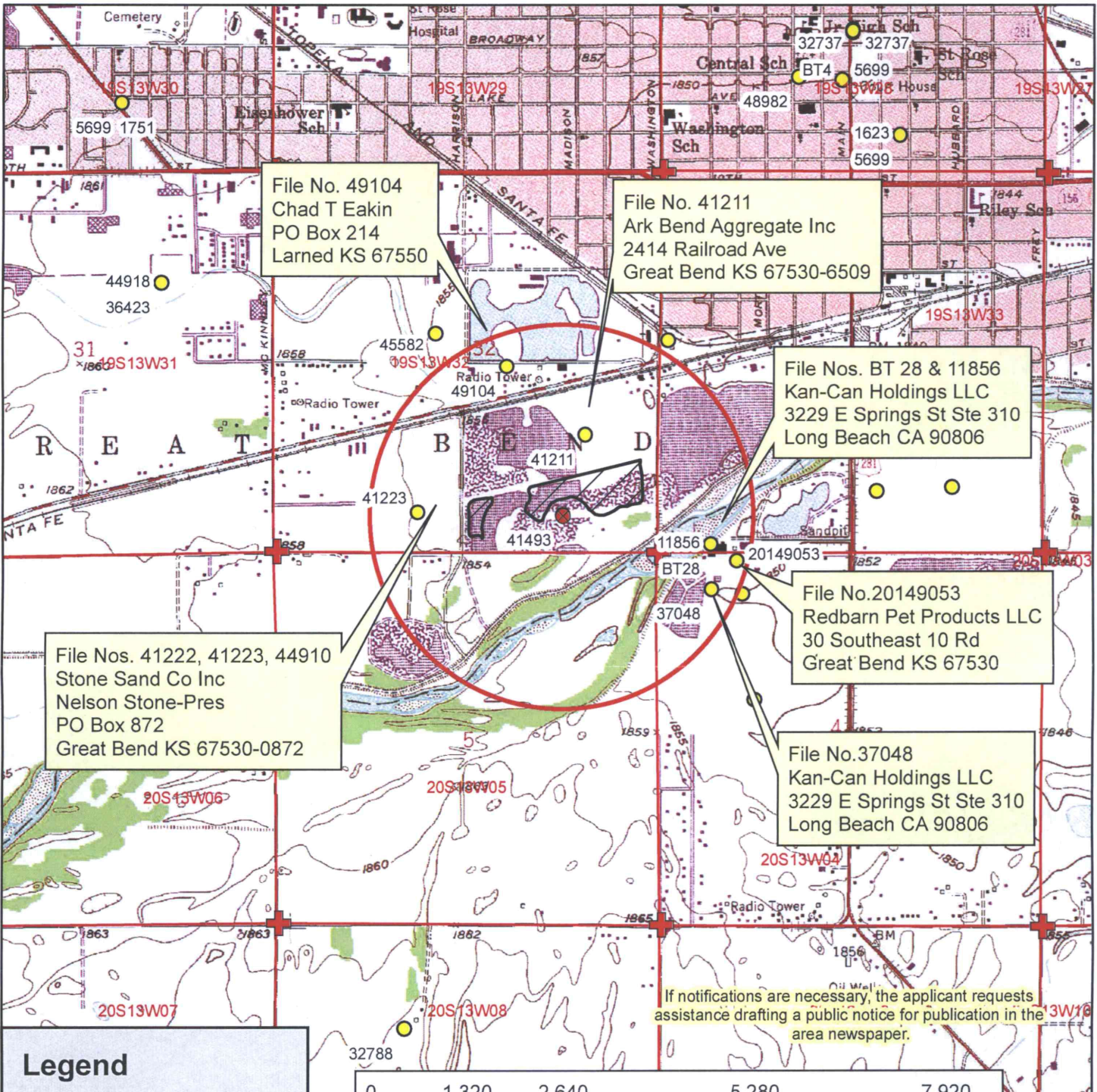

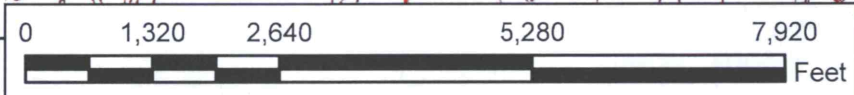
