Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse. If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.

October 5, 2020

Water Right 45830 currently serves as the permit authorizing the use of surface water for recreational purposes for approximately 3.3 acres of pond in the common areas of the Falcon Falls housing development. Upon expansion of housing development, the common area pond was expanded and water right application 49781 (REC) was filed to increase the pond area to a total of approximately 7.8 acres.

At the request of DWR Stafford Field Office staff, the Falcon Falls HOA has filed a change application for water right 45830 to form a complete overlap in point of diversion and place of use with application 49781 (REC). This administrative cleanup for the current partial overlap in place of use for the two files should allow for final DWR processing and consideration of application 49781.
