battery Quivira Waterfowl LLC has filed the referenced new application to appropriate 15 acre-feet of groundwater of 2 from two existing wells at a rate of 275 gallons per minute for recreational use at three recreational ponds. The recreational ponds are located in Section 6, Township 22 South, Range 10 West, Reno County, within the Rattlesnake Creek Drainage Basin. The entire place of use is owned by the applicant and he has signed the application form stating he has access to the point of diversion. The quantity of water is deemed reasonable as the applicant is seeking only fill the ponds seasonally for the hunting season.
But 3.775AF evap (equivalent to 0.03in/day) = 15AF total

Groundwater Management District No. 5 is closed for new appropriations except those seen in K.A.R. 5-25-15. As such, for an exception to happen the following criteria must be met; the sum of the annual quantity of water requested by the new application and the total annual quantities authorized by prior approvals of applications because of an exemption pursuant to this regulation does not exceed 15 acre-feet in a one-mile-radius circle surrounding the proposed point of diversion, the well meets spacing as requirements as in K.A.R. 5-25-2, the application will not allow more quantity from an existing Water Right, this application will not impair any senior water rights in the area, shall comply with all requirements of K.S.A. 82a-709 and K.S.A. 82a-711, and amendments thereto, K.A.R. 5-3-1 and K.A.R. 5-3-1b for processing a new application to appropriate water have been met and shall not be located in an IGUCA. As this application is part of the Rattlesnake Creek Drainage Basin, it will also have be 15 Acre-Feet or Less, meet spacing from K.A.R. 5-25-2 and offset source of water must be present but the proposed point of diversion cannot be closer than the offset point of division to a stream if within three miles of a stream. The well log shows sand and gravel from 15 to 34 feet. The supply of water for this application is undifferentiated Kansas/Nebraskan deposits from the shallowness of the well (42').

The application was sent to Groundwater Management District No. 5 on April 28, 2020. After a GMD #5 Board meeting on May 14, 2020, the board recommended that that the application be approved as long as the proposed well location was moved north to meet spacing for K.A.R. 5-25-15 (a) (1), K.A.R. 5-25-15 (d)(4) be waived and that an offset source was presented as per K.A.R. 5-25-15 (d)(3). However, after further review by DWR, it was determined that the proposed point of diversion could not be moved north enough to meet K.A.R. 5-25-15 and remain on the applicant's property. In a revised recommendation from GMD #5 on June 12th, 2020 it was recommended that the application be approved for a 15 AF exception with a waiver of K.A.R. 5-25-15 (a) (1) and K.A.R. 5-25-15 (d)(4). GMD #5 also requested that the pumping rate be lowered from 580 gallons per minute to 275 gallons per minute. Additionally, the applicant agreed to reduce 30 Acre-Feet for from Water Right No. 30,431 D4 for application No. 50,193 to be approved for 15 Acre-Feet.

After the revised GMD # 5 recommendation, DWR has worked with the applicant to accomplish the following resolutions: the applicant has bought additional quantity of 59 Acre-Feet from Water Right No. 30431 D2. Water Right No. 30431 D2 will then be divided into Water Right Nos. 30,431 D3 and 30,431 D4. Water Right No. 30,431 D4 would then use 15 AF of this quantity for this application, 15 AF would be permanently retired and that would leave 29 AF for the applicant to use as they wish. Water Right No. 30,431 D4 would provide adequate offset to comply with K.A.R. 5-25-15 (d)(3).

The applicant identified one non-domestic well within one-half mile. A nearby letter was sent on May 6th, 2019 with no response to date. Therefore, this application meets K.A.R. 5-25-2 as the nearest non-domestic well is 2,600 feet away and the nearest domestic well is located 2,900 feet away.

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed.

In an August 4th, 2020 e-mail, Jeff Lanterman, Water Commissioner, Stafford Field Office, recommended approval of the referenced new application.

Based on the above discussion, well spacing and safe yield criteria are met, and approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest, it is recommended that the referenced ne application be approved, and the senior files be dismissed as voluntarily requested by the owner.

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

1. That the priority date assigned to such application is January 8, 2019.

2. That the water sought to be appropriated shall be used for recreational use in a waterfowl complex consisting of three ponds located in the Northeast Quarter (NE¼) of Section 6, in Township 22 South, Range 10 West, Reno County, Kansas.

3. That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of a battery of two (2) wells with a geographical center located in the Northwest Quarter of the Southeast Quarter of the Northeast Quarter (NW¼ SE¼ NE¼) of Section 6, more particularly described as being near a point 3,638 feet North and 1,247 feet West of the Southeast corner of said section, in Township 22 South, Range 10 West, Reno County, Kansas.

 That the appropriation sought shall be limited to a maximum diversion rate not in excess of 275 gallons per minute (0.613 c.f.s) and to a quantity not to exceed 15 acre-feet of water for any calendar year.

5. That installation of works for diversion of water shall be completed on or before <u>December 31, 2021</u> or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2025</u> or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.

8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.

9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.

10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.

11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

12. That all wells with a diversion rate of 100 gallons per minute or more drilled under the authority of this permit shall have a tube or other device installed in a manner acceptable to, and in accordance with specifications adopted by, the Chief Engineer. This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.

13. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).

14. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.

15. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.

16. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

17. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

Your attention is directed to the enclosures and to the terms, conditions, limitations, and requirements specified in this permit.

Notice must be filed on the enclosed form once the diversion works have been completed. Failure to complete the diversion works within the time allowed, or within any authorized extension of time thereof, will result in dismissal of this permit. If you need an extension of time, you must request it before the deadline for completion set forth in the permit. Any request for an extension of time must be accompanied by the statutorily required fee, which is currently \$100.00.

An acceptable water flowmeter must be installed on the diversion works authorized by this permit prior to using water. An annual water use report must be filed with the Chief Engineer by March 1, following the end of each calendar year. If a complete annual water use report is not received by the deadline, then a fine may be assessed and all water use under such permit or right may be suspended. Reports submitted in paper form will be assessed a \$20 per file number paper filing fee. In order to avoid this filing fee, you may submit your report online at <u>www.kswaterusereport.org</u>.

The approval of your application constitutes a permit to appropriate water. It does not give authority to construct any dam or other stream obstruction regulated by K.S.A. 82a-301 through 305a. It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

Enclosed is an informational sheet that sets forth the procedure to obtain a Certificate of Appropriation which will establish the extent of your perfected water right. Additional information and applicable forms may be found on our website at <u>agriculture.ks.gov/divisions-programs/dwr</u>. RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
