Always Sunny Hemp & Bee Farm LLC has filed the above referenced new application proposing to appropriate 15 acre-feet of groundwater per calendar year at a diversion rate not to exceed 99 gallons per minute for irrigation use from one well. The proposed point of diversion is located in the Southwest Quarter (SW¼) of Section 33, Township 23 South, Range 9 West, Reno County, Kansas; which is within the drainage basin of the North Fork Ninnescah River.

The proposed place of use is a total of 10.7 acres (industrial hemp) in the Southwest Quarter of the Southwest Quarter of Section 33, Township 23 South, Range 9 West, Reno County Kansas. The entire place of use is owned by the applicant (Phillip J. & Dana A. Sneed).

Originally the applicant requested a 15-acre place of use, that was recommended for denial by the Big Bend Groundwater Management District No. 5. on October 3, 2019. After discussion with Jeff Lanterman and Cameron Conant at the Stafford Field Office, it was suggested the applicant reduce his place of use to 10.7 acres to match the maximum quantity allowed for irrigation use in Reno County (1.4 AF/acre x 10.7 acres = 15 acre-feet).

The applicant, PJ Sneed, agreed to the place of use reduction in a phone message on October 16, 2019. A new place of use map was created to show the 10.7 acres, which Mr. Sneed confirmed the accuracy of in an email on November 2, 2019.

Two nearby well owners were notified in letters dated October 21, 2019; but no responses of any kind were received.

Per the requirements in K.A.R. 5-4-4, minimum well spacing should be 1,320 feet to non-domestic wells and 660 feet to domestic wells with the same source of supply. The closest Water Right is nearly 2.5 miles away, while the closest domestic well is roughly 900 feet away. Therefore, the proposed point of diversion meets minimum well spacing requirements.

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed.

In a letter dated October 31, 2019 Orrin Feril, Manager of the Big Bend Groundwater Management District No. 5 recommended approval of the application.


Jeff Lanterman, Water Commissioner of the Stafford Field Office, gave a recommendation that the new application should be approved, in an e-mail conversation on December 2, 2019.

Based on the above discussion, the area is open to new appropriations, the application meets well spacing criteria, and the approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest. Therefore, it is recommended that the referenced application be approved.

I would prefer he specify the acreage to be irrigated and the map should reflect his 10.7 acres.

After more thought and discussion, the idea about a p/u change monitoring agreement might work but it's also something that we don't know how it would actually work. They would lose a little water based on the calculation to enter the monitoring agreement (lose about 3 AF per year). This is still an option for them but I think we need to push it as 2 options to get the application approved: 1) you need to reduce acres down to reasonable OR 2) appeal the GMD decision and provide information showing the quantity is reasonable for the acreage.

I don't love the second option but they need to know that is totally fine to appeal and provide info. First hurdle is having an approved application, until then it's probably best to not speculate on changes that the GMD would have to agree to monitor, you never know with them.

I have a thought.

Jeff is right, hemp this year and 2 years down the road corn or beans...that is problematic. This is going to come up again when Ted Carder by Sterling submits a 15AF app to cover like 60 acres (I assume we already have his application).

We have a chance to start consistent and remain consistent on how these hemp apps are approved, especially in GMD's. We could only approve these if the agree to the reasonable acreage for 15AF.

Then, once approved, we encourage the hemp grower to file a P/U change to increase acres over base and get monitored by the GMD. The GMD could even write up the contract to specifically say, as long as hemp is being grown GMD will monitor and allow the higher acres but the contract will be dropped and producer has to go back to reversion acres if a different crop is grown.

<u>A bit problematic b/c we'd be doing this on a water right that isn't certified yet, but might be a workable</u> <u>solution...better than approving for unreasonable quantities!</u> Have any of them provided any type of justification for less water per acre??? Surprised the KDA hemp research team doesn't get involved with that... Cameron

That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of one (1) well located in the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4 SW1/4) of Section 33, more particularly described as being near a point 389 feet North and 4,843 feet West of the Southeast corner of said section, in Township 23 South, Range 9 West, Reno County, Kansas, located substantially as shown on the aerial map accompanying the application.

4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of **99** gallons per minute (0.22 c.f.s.) and to a quantity not to exceed **15 acre-feet** of water for any calendar year.

5. That installation of works for diversion of water shall be completed on or before <u>December 31</u>, <u>2021</u>, or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee, which is currently \$400.00, when construction of the diversion works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be accompanied by the required statutory fee, which is currently \$100.00.

6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2025</u>, or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee, which is currently \$100.00.

7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.

8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.

9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.

10. That this permit does not constitute authority under K.S.A. 82a-301 to 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.

11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

12. That all wells with a diversion rate of 100 gallons per minute or more drilled under the authority of this permit shall have a tube or other device installed in a manner acceptable to, and in accordance with specifications adopted by, the Chief Engineer. This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.

13. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).

14. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.

15. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.

16. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

17. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

If you need an extension of time, you must request it before the deadline for completion set forth in the permit. Any request for an extension of time must be accompanied by the statutorily required fee, which is currently \$100.00.

An acceptable water flowmeter must be installed on the diversion works authorized by this permit prior to using water. An annual water use report must be filed with the Chief Engineer by March 1, following the end of each calendar year. If a complete annual water use report is not received by the deadline, then a fine may be assessed and all water use under such permit or right may be suspended. Reports submitted in paper form will be assessed a \$20 per file number paper filing fee. In order to avoid this filing fee, you may submit your report online at <u>www.kswaterusereport.org</u>.

The approval of your application constitutes a permit to appropriate water. It does not give authority to construct any dam or other stream obstruction regulated by K.S.A. 82a-301 through 305a. It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

Enclosed is an informational sheet that sets forth the procedure to obtain a Certificate of Appropriation which will establish the extent of your perfected water right. RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary. To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
