The Robert D Hay Revocable Trust, on behalf of Isidores Agronomics of Kansas LLC, the owner of the referenced files authorized for irrigation use, has submitted three (3) applications for approval to change the authorized place of use. Robert and Janice Hay signed the applications and provided information showing they are authorized to sign on behalf of the LLC.

File Nos. 1660, 31754 and 42234 appear to be in compliance with 82a-732 (Annual water use report required). A review of the applications found that they comply with K.A.R. 5-5-1, *Filing an application for change*. The referenced files do not appear abandoned as per K.S.A. 82a-718 *Abandonment of water rights*.

The referenced files currently have an overlapped place of use on 128 acres in the Northwest Quarter (NW $\frac{1}{4}$) of Section 36, Township 28 South, Range 1 West, Sedgwick County. There are no point of diversion overlaps and all files are certified. All subsequent legal descriptions in this memo are in Township 28 South, Range 1 West.

File No. 1660 authorizes a battery of two (2) groundwater wells with a geographic center in the Northwest Quarter of the Northeast Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 36, more specially described as 5,107 feet North and 3,800 feet West of the Southeast corner of said section. The permit is authorized 115 acre-feet (AF) at 380 gallons per minute (gpm). A compliance inspection on June 11, 2015 found the water right to be in compliance and the authorized point of diversion will be modified based on GPS coordinates on file.

File No. 31754 authorizes a groundwater well near the center of the Northwest Quarter (NC NW $\frac{1}{4}$) of Section 36, more specially described as 4,006 feet North and 3,960 feet West of the Southeast corner of said section. The permit is authorized 115 acre-feet at 400 gpm and is limited to 153 AF at 535 gpm when combined with File No. 1660. A compliance inspection on June 11, 2015 found the water right to be in compliance and the authorized point of diversion will be modified based on GPS coordinates on file. It should be noted that the water from File No. 1660 dumps into the casing of this well. Therefore, the meter installed for File No. 31754 double meters the quantity from File No. 1660.

File No. 42234 authorizes a groundwater well in the Northwest Quarter of the Southwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 36, more specially described as 3,530 feet North and 5,235 feet West of the Southeast corner of said section. The permit is authorized 57 acre-feet at 180 gpm and is limited to 153 AF when combined with File Nos. 1660 and 31754. A compliance inspection on June 11, 2015 found the water right to be in compliance and the authorized point of diversion will be modified based on GPS coordinates on file.

The referenced change applications, received on August 9, 2021, propose to maintain the existing overlap under the associated water rights while modifying the acreage to authorize additional acres to accommodate a swing arm center pivot system.

File No. 5228 has 128 "Base Acres" as defined by K.A.R. 5-5-11 *Applications for change in place of use for irrigation purposes*. File No. 31754 and 42234 do not have any additional base acres. The proposed 138 acre place of use complies with part (b) of K.A.R. 5-5-11 and the 10 acre / 10 percent increase above the *Base Acres* is allowed by the regulation.

The proposed changes will result in a maximum quantity of 153 AF irrigating 138 acres, resulting in an irrigation ratio of 1.11 AF per acre. It would appear this irrigation ratio is reasonable as the ratio is less than the 1.5 AF per acre maximum for Sedgwick County found in K.A.R. 5-3-19, *Maximum reasonable annual quantity of water for irrigation use*, thus complying with K.A.R. 5-3-23, *Maximum reasonable annual quantity approvable for irrigation use for an application for change in place of use and a request to reduce a water right*. The generally accepted minimum quantity per acre for Sedgwick County is 1.05 AF per acre, so the proposed quantity meets this threshold as well.

Since the referenced applications to change the place of use do not propose to add more than 10 acres or 10% of the *Base Acres* to the authorized place of use, water well owners within one-half mile of the authorized point of diversion were not notified of the proposed change in place of use (EKF Memo dated 09/3/2021).

The referenced water rights are not in a special use area.

The referenced water rights are not in a groundwater management district.

No structures permit appears to be needed.

A water flow meter is required for each point of diversion. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it has been recommended that applications are approved.

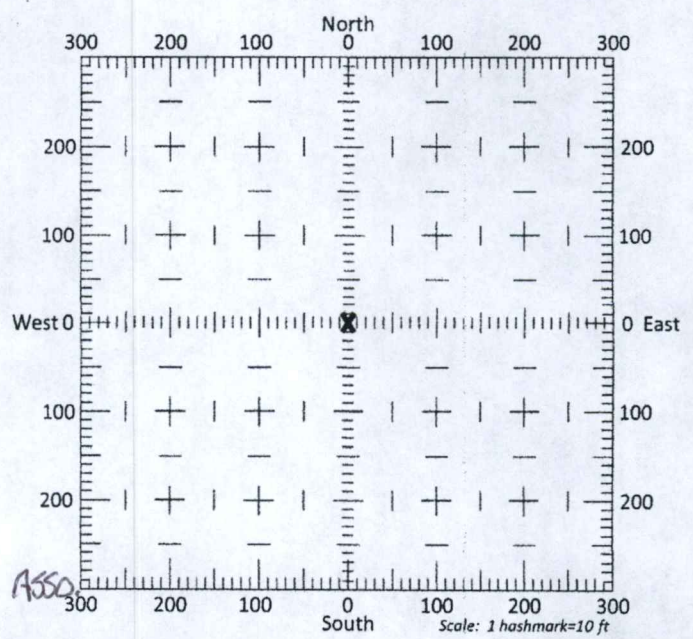

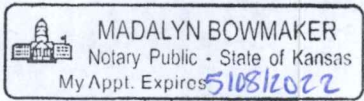

SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et seq.*, and rules and regulations promulgated thereunder, With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 11660.

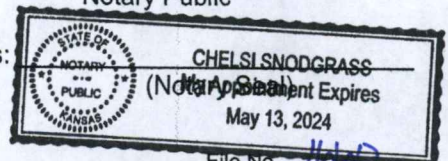

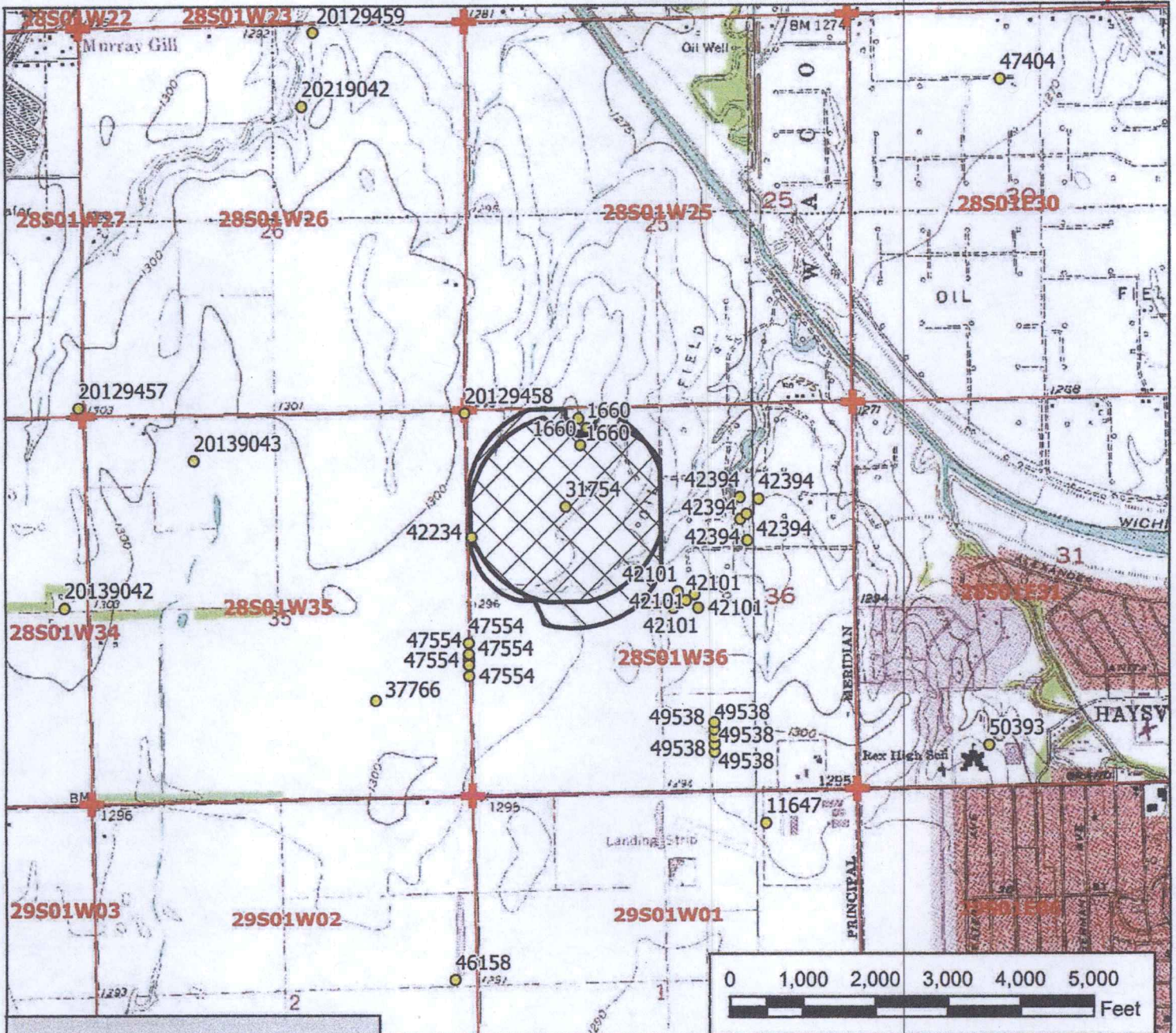
