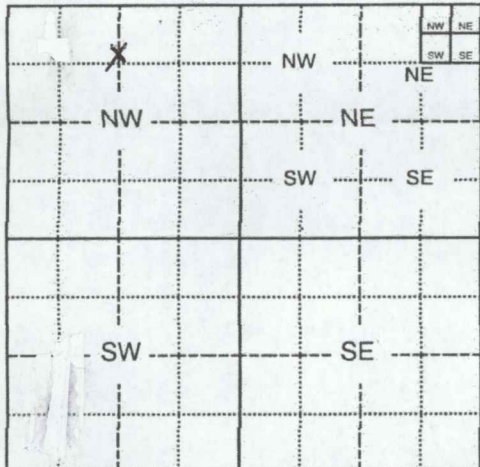

- 2. The fee for an application in which storage is requested, is:

0-250 \$200.00  
More than 250 \$200.00  
plus \$20.00 for each additional 250 acre-feet of storage or any part thereof.

- NOTE: If an application requests both direct use and storage, the fee charged shall be as determined under No. 1 or No. 2 above, whichever is greater, but not both fees.

I understand that the diversion of groundwater from the source of supply to which the above referenced application applies is subject to the following conditions of approval.

(1) That if I am diverting groundwater, static water level must remain at a sufficient level to satisfy demands of all senior water rights, including domestic water rights in the nearby area. At minimum, the static water level should remain at least 10 feet above bedrock, but I understand that the static water level that must be maintained could be subject to change should it become necessary to protect senior water rights.

(2) That if any impairment of a nearby water right holder is substantiated, I understand I must cease diversion or remedy the impairment immediately.

(3) That the use made of water is for dewatering purposes. Any irrigation use would be considered secondary use in nature and would in no way be guaranteed by the approval of the above referenced application. This may affect the economics of my cropping decisions, should the diversion of water be required to cease.

(4) That the discharged water is controlled and managed by the applicant to minimize flooding, waste, damage, hazards or a public nuisance.

(5) That if the high water table conditions still exist at the end of this five year term permit, and dewatering is still necessary to mitigate flooding basements in Salem Township, the chief engineer will consider issuing an additional term permit for dewatering purposes, provided an appropriate application is filed.

I understand that if this application is approved, there could be times, as determined by the Division of Water Resources, when I would not be allowed to divert water. I realize that this could affect the economics of my decision to appropriate water. I am aware of the above factors, and with the knowledge thereof, request that the Division of Water Resources proceed with processing and approval, if possible, of the above referenced application.
