The referenced application has been filed by ICM, Inc. to appropriate 1.630 mgy (5.0 acre-feet) of groundwater per calendar year for industrial use at a diversion rate not to exceed 50 gallons per minute. The proposed quantity is in addition to the authorized quantity under Water Right, File No. 31,650 which is an overlap in place of use. The requested point of diversion is a well that was formerly authorized under Water Right, File No. 31,650 until a change in point of diversion in 2019. The well is located in the Northeast Quarter of the Northwest Quarter of the Southwest Quarter (NE¼ NW¼ SW¼) of section 15, more particularly located near a point 2,147 feet North and 4,640 feet West of said section, in Township 26 South, Range 2 West, Sedgwick County, Kansas.

The proposed quantity will be used in pressure testing of water tanks at a facility located in the Southeast Quarter of Section 15, Township 26 South, Range 2 West, Sedgwick County, Kansas. The source of the water for the groundwater well is likely the Equus Beds aquifer.

The applicant has a prior water right under Water Right, File No. 31,650 for industrial use. The authorized quantity for this groundwater is 1.630 mgy per year (5.0 acre-feet) at a rate of 50 gallons per minute. The new application will be in addition to the current authorized quantity of the place of use overlap, Water Right, File No. 31,650.

A test log was not submitted with the application, but information provided on the application estimates the date the well was drilled as approximately 1980, the total depth of the well at 100 to 150 feet and depth to static water level at 20 to 25 feet.

Due to the densely populated area, a public notice was published in the local paper for three consecutive weeks, the issue dated May 10, 2021, and the last issue dated May 24, 2021. No contact of any kind was received.

Application, File No. 50,484 lays within the boundaries of Equus Beds Groundwater Management District No. 2 (GMD 2). A copy of the application was sent to GMD 2 with a request for recommendation in a correspondence dated June 21, 2021. The application was recommended for denial in a correspondence dated December 27, 2021. The applicant appealed the GMD 2 recommendation for denial in an email dated January 25, 2022. GMD 2 held an appeal hearing on February 17, 2022. A recommendation was received on February 25, 2022, with GMD 2 recommending approval with exceptions to the Well Spacing Rule and Regulation K.A.R. 5-22-2(a)(1), and the Safe Yield Regulation K.A.R. 5-22-7, and that the application be approved under the Safe Yield Rule and Regulation "small use" exemption provision K.A.R. 5-22-7(b)(1).

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R. 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed. A water level measurement tube is required because this is a proposed new well exceeding 100 gpm.

Jeff Lanterman, Water Commissioner, Stafford Field Office, recommended approval of the referenced application on May 18, 2022. Based on the above discussion, waivers of well spacing and safe yield criteria, and approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest, it is recommended that the referenced application be approved.



- 1. That K.A.R. 5-22-2(a)(1) states that "the minimum spacing of all nondomestic and nontemporary wells described in an application for permit to appropriate water for beneficial use, an application for a term permit, or application to change the point of diversion shall be the following: 1,320 feet from all nondomestic wells, groundwater pits, and baseflow nodes."
- 2. That the proposed point of diversion is an existing well that was originally drilled under the authority of Water Right, File No. 31,650 until a change in point of diversion was approved and a new well was drilled approximately 250 feet to the southeast, thus, the proposed point of diversion does not meet spacing to the well currently authorized by File No. 31,650.
- 3. That the industrial well (File No. 31,650) remains under common ownership with the proposed point of diversion.
- 4. That the low rate (50 gallons per minute) and quantity (5 acre-feet) proposed by this application is unlikely to impair any existing wells.
- 5. That Equus Beds Groundwater Management District No. 2 calculations estimate drawdown at the nearby well authorized by File No. 31,650 would be minimal at approximately 0.11 feet.

- 6. That the proposed application meets all other criteria for a small use exemption.

That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of one (1) well, located in the Northwest Quarter of the Northwest Quarter of the Southwest Quarter (NW¼ NW¼ SW¼) of Section 15, more particularly described as being near a point 2,147 feet North and 4,640 feet West of the Southeast corner of said section, in Township 26 South, Range 2 West, Sedgwick County, Kansas, located substantially as shown on the topographic map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of **50 gallons per minute (0.11 c.f.s)** and to a quantity not to exceed **1.629 million gallons (5 acre-feet)** of water for any calendar year.
- 5. That installation of works for diversion of water shall be completed on or before <u>December 31, 2023</u> or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.
- 6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2027</u> or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.

- 8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 12. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
- 13. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.
- 14. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.
- 15. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.
- 16. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may request an evidentiary hearing before the Chief Engineer, or request administrative review by the Secretary of Agriculture. Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
