Chris Boyd has filed the referenced application File No. 50,516 to appropriate groundwater for irrigation use, requesting one (1) well a quantity of 91 acre-feet, and a diversion rate of 800 gallons per minute. The proposed well is to be located in the Northwest Quarter of the Northwest Quarter of the Northeast Quarter (NW¼ NW¼ NE¼) of Section 13, more particularly described as a point near 5,077 feet North and 2,601 feet West of the Southeast Quarter of said section, in township 30 South, Range 12 West, Barber County, within the Medicine Lodge River drainage basin. Application File No. 50,516 will be a PD overlap with Water Right, File No. 46,316. The applicant submitted an application to change the Place of Use for Water Right, File No. 46,316. This will create an exact PU overlap of Application File No. 50,516 and Water Right, File No. 46,316.

File No. 46,316 appears to not be abandoned as per K.S.A. 82a-718 and in compliance with K.S.A. 82a-732. As required by K.S.A. 82a-1906, a public notice was published, and letters were sent to nearby well owners. No written comments were received.

Water Right, File No. 46,316, is authorized 805 gallons per minute to divert 182 acre-feet for the irrigation of 130 acres one (1) well in the Medicine Lodge River Basin. The well is described as being located in the Northwest Quarter of the Northwest Quarter of the Northeast Quarter (NW¼ NW¼ NE¼) of Section 13, approximately 5,077 feet North and 2,601 feet West of the Southeast corner of Section 13, Township 30, Range 12 West, Barber County, Kansas.

The new application, File No. 50,516 requested quantity of 91 acre-feet to be diverted at a rate of 800, identified in the application and overlapping with that proposed under File No. 46,316. This is more than the maximum allowable of 1.4 acre-feet per acre for Barber County, Kansas. The safe yield showed only 55.39 acre-feet left for appropriation. The applicant gave permission to change the amount requested on the application from 91 acre-feet to 55.39 acre-feet. The new application's request for 55.39 acre-feet and File No. 46,316 authorized quantity of 182 acre-feet, for a total of 237.5 acre-feet or 1.25 acre-feet/acre which is more than the minimum reasonable quantity in Barber County. The application will be limited to 805 gpm when combined with Water Right, File No. 46,316. The new permit complies with K.A.R. 5-3-24, Reasonable quantity for irrigation use in Barber County.

The proposed point of point of diversion for File No. 50,516 was drilled under File No. 46,316 on June 2, 2006. The total well depth is 168 feet. The well's static water level was 70 feet below land surface. Saturated thickness according to the well log is 103 feet. The source of supply is Quaternary sand and gravel beds. The well is located in DUA Unit 21. Regulations for this unit designate 3,135 acre-feet of water per year is available in this area. Upon approval of application File No. 50,516, there will be 1,095 acre-feet available for appropriation. in DUA 21.

The request to add additional acres of new irrigated land appears to comply with Part (b)(6) of K.A.R. 5-5-11, Applications for change in place of use for irrigation purposes, with the determination that new quantity will be available and permitted. The change in the irrigated place of use will also update the irrigated acres to overlap with the permit.

Nearby notification letters were mailed on June 23, 2021. No contact of any kind was received. According to the WRIS database, the nearest non-domestic point of diversion (Water Right, File No. 50,145) is located 3745 feet away with common ownership to File Nos. 46,316 and 50,516. The nearest possible domestic well is approximately 5,175 feet away. The proposed point of diversion for the new application meets minimum well spacing to all existing wells. The new application will comply well spacing as per K.A.R. 5-4-4.

Jeff Lanterman, Water Commissioner, Stafford Field Office, recommended approval of the referenced applications on January 6, 2022.

Based on the above discussion, that the permit will be issued, the change should not significantly increase consumptive use, and impairment to existing water rights is unlikely, it is recommended that the new permit be issued and the application for change be approved.



*With only 55.39 AF left for appropriation, the applicant has agreed to reduce the amount requested from 91.0 AF to 55.39 AF.

Safe Yield Variables

The area used for the analysis is set at 8,042 acres. The potential annual recharge at the circle center is estimated to be 1.8 inches. The percent of recharge available for appropriation is 50%.

That the authorized source from which the appropriation shall be made is groundwater to be withdrawn by means of one (1) well located in the Northwest Quarter of the Northwest Quarter of the Northwest Quarter (NW¼ NW¼ NE¼) of Section 13, more particularly described as being near a point 5,077 feet North and 2,601 feet West of the Southeast corner of said section, in Township 30 South, Range 12 West, Barber County, Kansas.

4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of **800** gallons per minute (1.78 c.f.s.) and to a quantity not to exceed **55.39 acre-feet** of water for any calendar year for irrigation use on the land described herein.

8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.

This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.

13. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
