

Note: The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works for diversion has been completed, except that for applications filed on or after July 1, 2009, for works constructed for sediment control use and for evaporation from a groundwater pit for industrial use shall be accompanied by a field inspection fee of \$200.00.

A Water Conservation Plan may be required per K.S.A. 82a-733. After the Division of Water Resources has had the opportunity to review your application, you will be notified whether or not you will need to submit a Water Conservation Plan. You also may be required to install a water flow meter or water stage measuring device on your diversion works prior to diverting water. 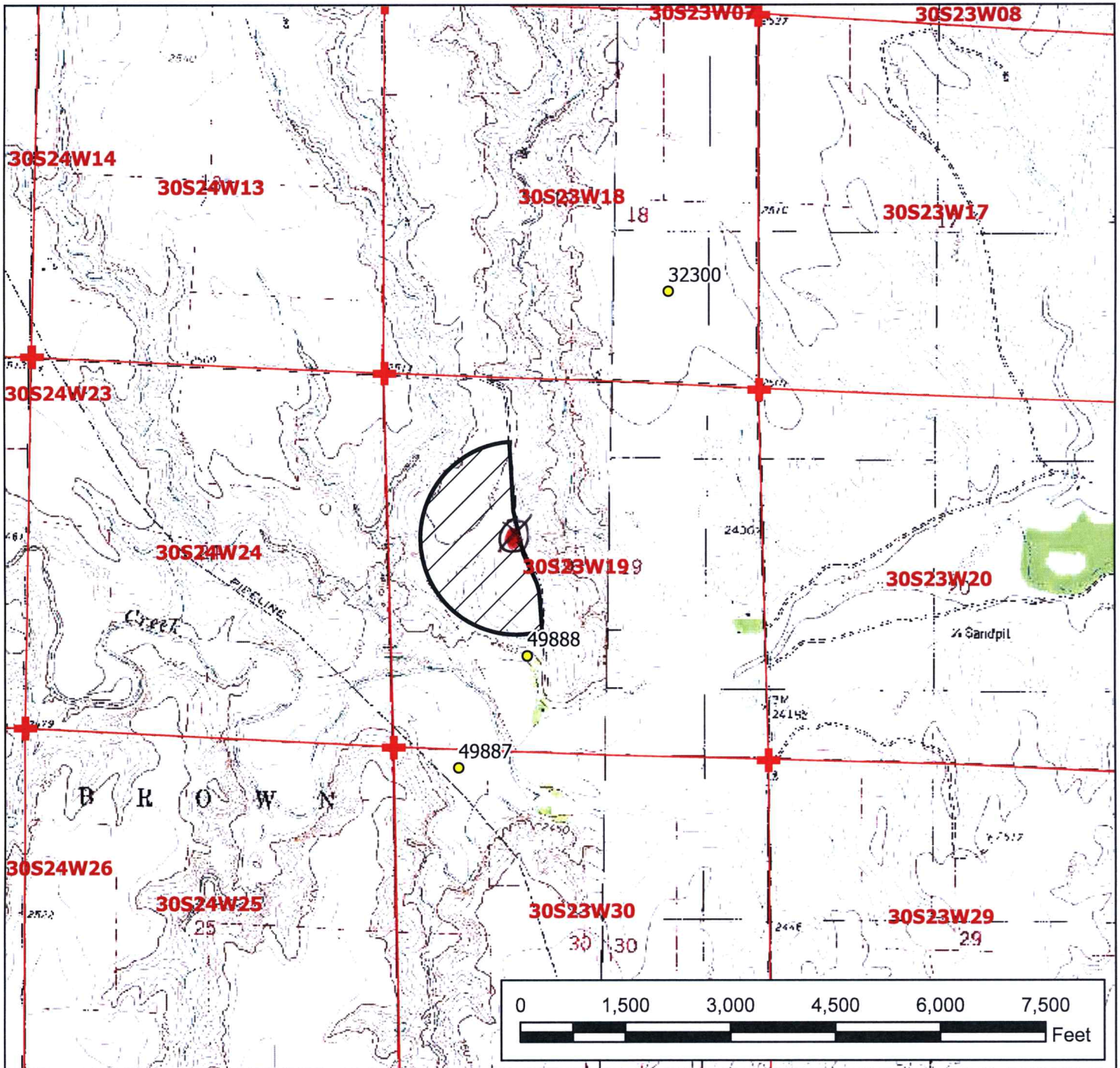

I am aware of the above factors, and with the knowledge thereof, request that the Division of Water Resources proceed with processing and approval, if possible, of the above referenced application.

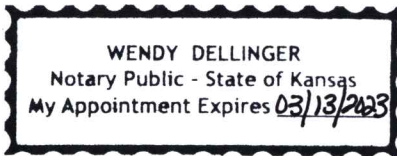

You will find enclosed with this letter an application for a permit to proceed at the referenced location. The enclosed application was completed as a 60 day to locate application for a battery of four (4) wells, because the proposed well(s) location is not yet known. If only one (1) well is needed/desired, the application can be modified at a later date. In addition, the proposed acres were described for a slightly larger area than we had discussed.

The application is mostly complete and should be carefully reviewed for accuracy. Question number 9 of the main application still needs completed along with question 2 on the back page of the irrigation supplemental form. The other blanks will be completed after the well location(s) are determined. A signature is needed on item number 6 AND number 16 of the main application. A notary is not required but be certain to sign both places. This application also requires an MDS acknowledgement form that has been included, which does require a notarized signature.

There is a \$300 fee for the enclosed application. Please include a check for the appropriate amount made payable to the Kansas Department of Agriculture with the signed application and associated documents when they are submitted to Manhattan for processing.
