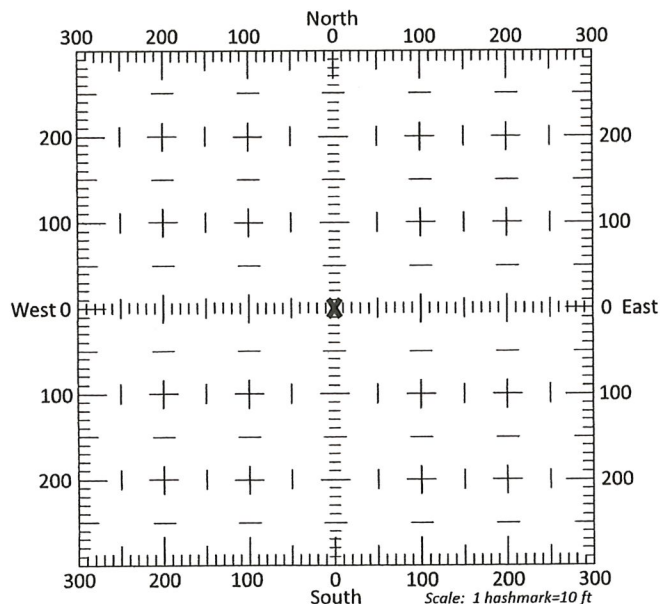

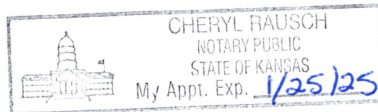

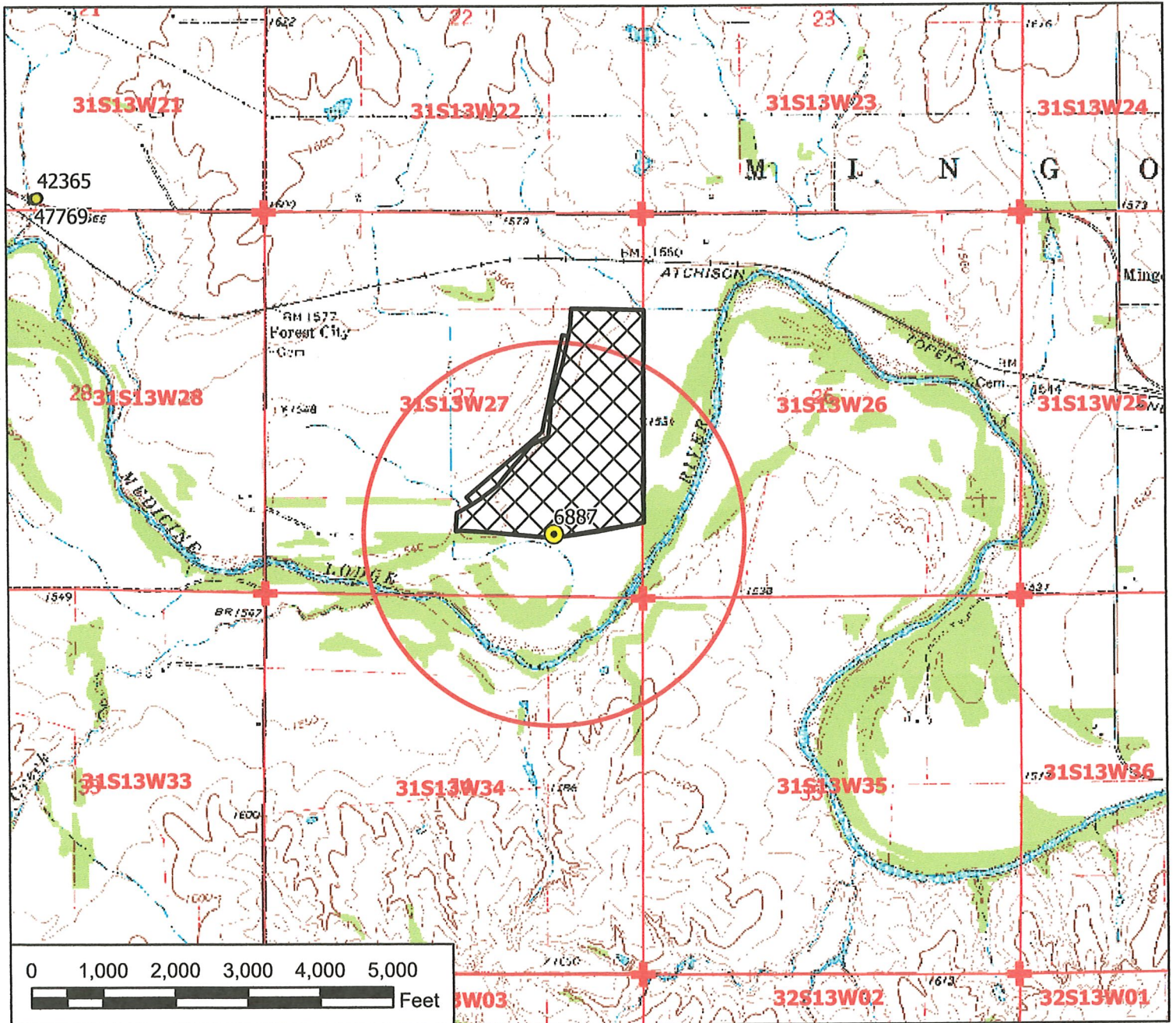

## Change in Place of Use Map 27-31-13W // Barber County



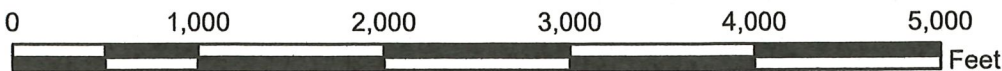
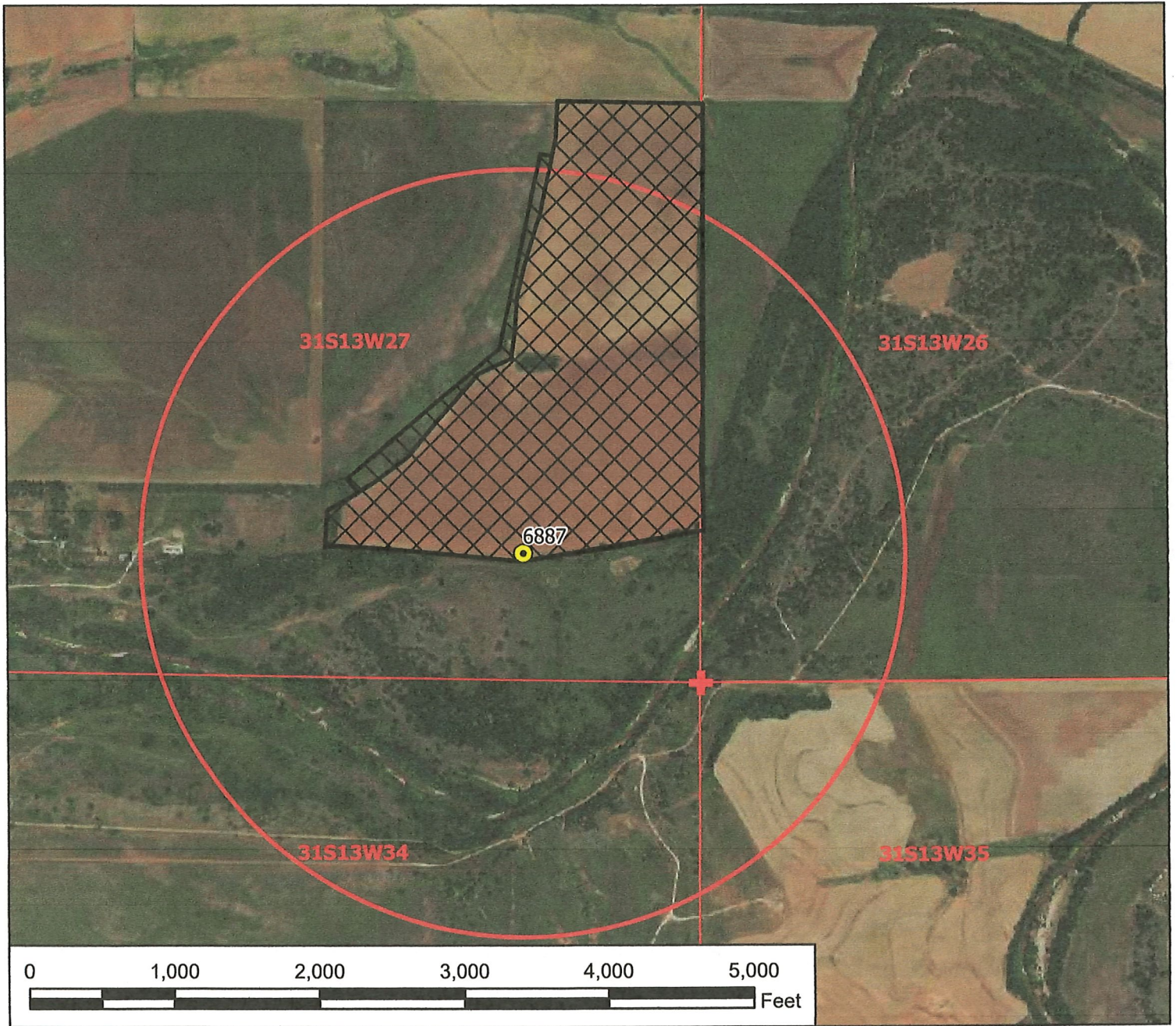
