APPROVAL OF APPLICATION FOR CHANGE IN POINT OF DIVERSION WATER RIGHT FILE NO. 46,373

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Douglas Thiessen on behalf of Triple T Livestock, LLC, 14429 NW 100th Street, Whitewater, Kansas 67154, received in this office on August 22, 2022, for approval of a change in the location of the point of diversion under the certificate of appropriation issued pursuant to the permit to appropriate water for beneficial use, as modified and amended by the Order of the Chief Engineer dated April 9, 2007, approving the application to change the point of diversion, and by the Order of the Chief Engineer dated May 4, 2017, approving the application to the change the place of use, and Order in the matter of the authorized point of diversion, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the point of diversion shall be:

a battery of three(3) wells with a geographic center located in the Northwest Quarter of the Northwest Quarter of the Northeast Quarter (NW1/4 NW1/4 NE1/4) of Section 16, more particularly described as being near a point 4,724 feet North and 2,008 feet West of the Southeast corner of said section, in Township 24 South, Range 3 East, Butler County, Kansas.

located substantially as shown on the topographic map accompanying the application to change the point of diversion.

That all wells shall be located within the same local source of supply and shall supply water to a common distribution system.

Installation of the works for diversion of water shall be completed on or before December 31, 2023, or within any authorized extension of time. The applicant shall notify the Chief Engineer of the Division of Water Resources, Kansas Department of Agriculture, when construction of the works for diversion has been completed.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year. RE: File No. 46,373

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 46,373, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated September 15, 2020.

- 1) K.A.R. 5-1-1(n) currently defines and restricts batteries of wells to a maximum radius of 300 feet from a geographical center.
- 2) That the overlapping files originally authorized a domestic stockwater operation that was changed to a battery of three(3) wells.
- 3) That the most northern well was drilled further north due to the facility layout and is 47 feet beyond the allowable 300 feet.
- 4) The battery authorizes 48 acre-feet at 80 gallons per minute meets all other rules and definitions of a battery.
- 5) No nearby well owners within one-half $(\frac{1}{2})$ mile of the proposed geographic center of the battery.
- 6) The approval of the change should not result in the impairment of any existing domestic or water rights nor shall the change adversely affect the public interest.

Douglas Thiessen, signing as owner of Triple T Livestock LLC, the listed owner of the referenced files authorized for stockwatering use, filed applications for change in point of diversion under File No. 28,286.05 & 46,373. The applications were received on August 22, 2022, with a proposed new appropriation assigned File No. 50,847. The new appropriation is summarized in a separate memo. The referenced files are located in the Walnut River Basin, Butler County.

The subject rights appear to be in compliance with K.S.A. 82a-732 and not abandoned per K.S.A. 82a-718. The applications for change appear to comply with K.A.R. 5-5-2a, *Complete change application*.

The source of supply has been determined to be the Wellington Formation, (Code 533)

File Nos. 28,286.05 & 46,373 are certified to provide a limited quantity of 15.641 million gallons (mgy) (48.0 acre-feet) per year from a battery of three(3) wells with a complete overlap in point of diversion and place of use located in the Northeast Quarter (NE¹/₄) and a portion in the Northwest Quarter (NW¹/₄) of Section 16, Township 24, Range 3 East. File No. 46,373 certified only 80 gallons per minute while the senior file certified 120 gallons per minute.

The change is to authorize one(1) of the three(3) wells being redrilled with all of the three wells remaining authorized by File Nos. 28,286.05 & 46,373. It appears the wells were drilled to fit the layout of the facility and not the definitions of a battery of wells as detailed in K.A.R. 5-2-3, *Battery of wells*. A well drilled to the Southwest is far enough away (1,272 feet) from the authorized geographical center it was required to be permitted by File No. 50,847. The North well was redrilled has been determined to be located approximately 5,047 feet North and 1,881 feet West of the Southeast corner of Section 16. When evaluated with the two(2) remaining authorized wells, it was determined to be 47 feet outside of the 300 foot required radius for battery wells. A **waiver of K.A.R. 5-1-1, Definitions(n)** "Battery of wells" has been requested. Looking at the site it could be due to the nature of the facility authorizing cattle and swine with the existing infrastructure. The change will shift the geographical center 62 feet North from the authorized location of the Northwest Quarter of the Northwest Quarter of the Southeast corner to a point approximately 4,724 feet North and 2,008 feet West of the Southeast corner, remaining with the same qualifiers.

The well log is on the KGS web site. This newly drilled North well is indicated as 107 feet deep and similar lithology of the other wells. It appears the source of supply will remain unchanged.

The proposed (updated) geographical center meets K.A.R. 5-4-4, *Well spacing,* actually 1,342 feet from the new well. A review of the area indicates there are no other wells other than the applicant/owners proposed new well under File No. 50,847 within one-half ($\frac{1}{2}$) mile.

Jeff Lanterman, Water Commissioner was sent a copy of this memorandum for comments and a recommendation. He indicated in an e-mail dated April 5, 2023, he recommends approval the changes and the new permit.

Water flowmeters are required according to KSA 82a-706c, for all the referenced files. The proposed change in point of diversion under File No. 28,286.05 & 46,373, will not require a water level measurement tube as all the wells under File No. 28,286.05 & 46,373, have not been constructed with a tube as the wells appear to be operated at less than 100 gallons per minute. As a WWC-5 log was obtained from the KGS web site, a WWC-5 will not be a condition of the approval.

Based on the above discussion, the waiver is granted for the changes, they appear to be reasonable, that impairment to existing water rights is unlikely, that there are no pending applications within the vicinity of the proposed changes and filed prior that may be affected by the approvals and that no change in the local source of supply will occur, it is recommended that the applications be approved.

I don't think his intention is to expand this facility at all and the point of the new application was to cover an illegal/unauthorized well that was re-drilled incorrectly and outside the distances allowed by the senior files...so it violated the battery of wells so needed a new app to cover the new well. I think he has justified the quantity that he currently has and not more than that, so I think the limitation on the new app back to the senior files is appropriate and is ok.

This was a mess b/c he had an illegal well too far away that we needed to cover. He wasn't going for more quantity or a large expansion with these applications but I'm open to more discussion if we need?

Have you spoken with Doug and if so, can he justify the additional quantity with some proposed expansion or flaker mill use? If so, I'm not against doing it as additional since there is 2500 AF open in the area, but that wasn't the starting point for these changes.

This project is for Doug Thiessen in Butler Co. The stockwatering facility serves swine, cattle and has a feed mill. The battery of three wells was redrilled off. so much so a new app was considered for one of the wells, and a waiver of 300 foot radius for the other 3 wells remaining in the battery.

The new app is says it is limited with the senior files but feel that would be wrong as the rate should be able to be developed as it is a separate well. It is located close to the cattle pens... also the quantity should be allowed to be developed separately as we have gotten better at doing certificates and there is a feed mill on the site. I would think we would want to allow this new permit to accommodate an expansion of the operation. The new app also lists the quantity for the senior file only and not the total Q under both files makes for a wanky limitation.. so better to just allow it to develop another quantity from this well for use at the livestock complex. Also there is over 2500 AF available for appropriations. Gosh I feel like we want these guys to grow their business... maybe this appropriation with just the quantity and rate without additional Q& R back to a senor file.. would be just the ticket. Don't see it as to different from doing some of the files out west where there are two files limited and a third or fourth that are not.

Please let me know your comments and concerns. The new app well has been operating under a temporary that expired 2/19.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Division, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX 785-564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX 785-564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b).
