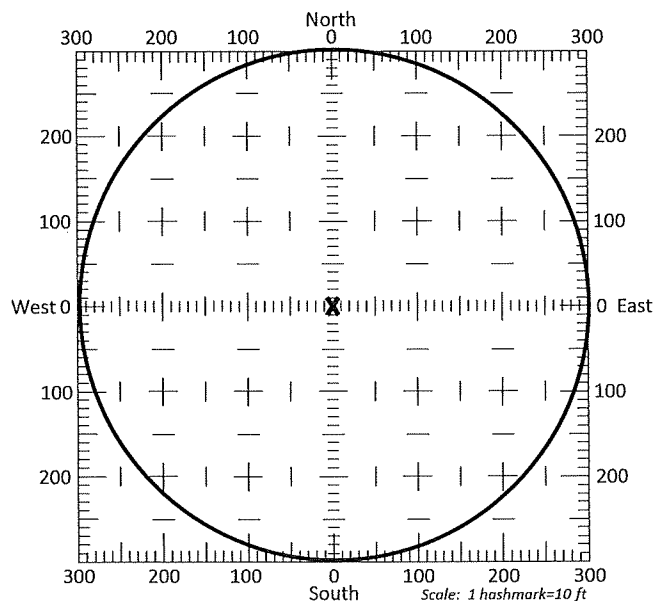






**Change in Place of Use Map, File No. 17128**

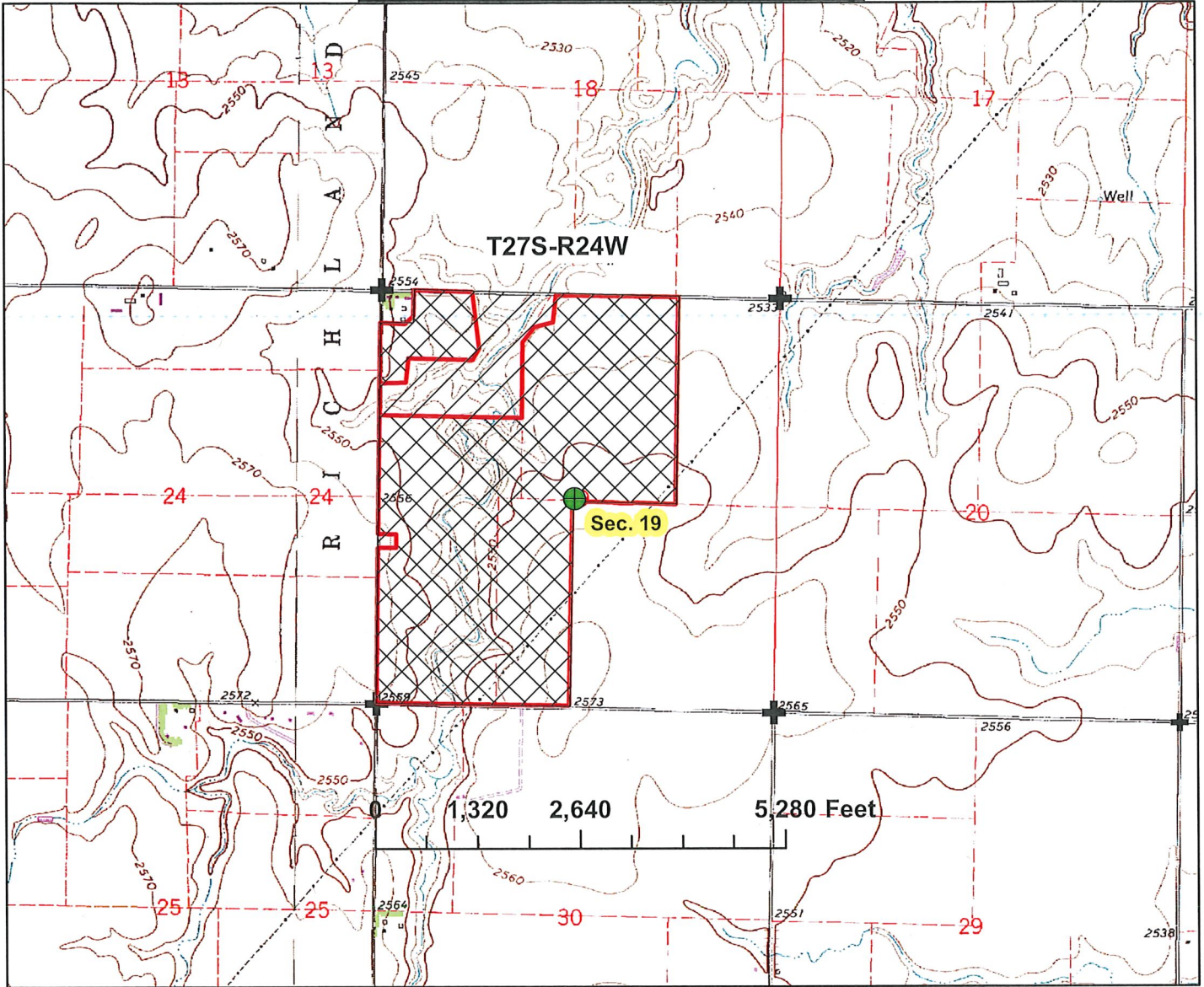


