# MEMORANDUM TO FILE

Division of Water Resources, Water Appropriation Program

## Summary

The City of Galva has filed the above referenced application to appropriate 32,585,100 acre-feet of groundwater at a rate of 100 gallons per minute for municipal use within the City of Galva in McPherson County, Kansas. An existing battery of two wells authorized under Vested Right MP-002 will be used with a complete point of diversion and place of use overlap. The above referenced application is attempting to move the entirety of the city's municipal water supplies to the battery of wells authorized under the Vested Water Right. This is due to a contamination plume from nearby historical industrial sites that is threatening the city wells authorized under File Nos. 21,401, 46,459, and 46,460. No additional water is being requested. A change application will not be needed for the vested water right as the point of diversion and place of use are not changing. In addition, the above referenced application overlaps in place of use with File Nos. 21,401 46,459, and 46,460. The point of diversion is located within the 2016 expansion area of the Equus Beds Groundwater Management District No. 2 and within the Little Arkansas River Basin. In addition, two points of diversion are currently authorized under Vested Water Right MP 002. A waiver of K.A.R. 5-3-4(d) is recommended to allow for a complete overlap of the above referenced application.

# Reasonable Rate and Quantity

The proposed place of use (the City of Galva and immediate vicinity) overlaps multiple other files as follows: Vested Water Right, File No. MP-002, Water Right, File No. 21,401, Appropriation of Water, File No. 48,459 and 48,460. The authorized rates and quantities of the current appropriations are summarized in the following table.

Maximum reasonable quantity was found to be 55 million gallons based on prior limitations for the senior water rights. Present water use was reported as 40,255,200 gallons for a population of 834 persons. Future population based on the applicants supplied population projections indicate a future population of 1,220 persons. However, based on historic population growth for the City of Galva, the city saw an average population growth of 14.1% over 50 years with an average of 20% population growth over the last 20 years or approximately 1% per year.

Taking the most recent (2020) census population of 834 people and multiplying that by 1% population growth per year for the last 4 years indicates the current population is approximately 868 people in 2024. Looking at the potential 20-year population growth indicates the city could see a total population of 1,059 by 2044.

Present water use under the senior files for the year of 2020 (which saw the most recent census data) shows that the water used was 40,255,200 gallons.

(40,255,200 gallons / 834 people) / 365 days = 132.24 gallons per person per day.

132.24 gpcd x 1,059 people x 365 days = 51,115,388.4 gallons rounded to 51.116 MGY

As the applicants' previous water rights (48,459 & 48,460) were limited to 55 MGY when combined with all senior and vested water rights. The water requested will be limited to 55 MGY when combined with all senior and vested water rights. Currently the wells authorized under 21,401, 48,459 and 48,460 are in an area that is at risk of contamination by a groundwater plume from nearby industrial areas. This new application will provide no additional water; however, it will give the applicant the flexibility they require to pump water from their various wells as they see fit.

# Source of Supply and Safe Yield

The source of supply appears to be the Equus Beds (Quaternary System) and was previously identified as such on the senior water rights (21,401, 48,459 & 48,460). Evaluation of the area of consideration included the extent of the unconfined aquifer, which provided an area of consideration of 5,976 acres. With a potential annual recharge of 1.0 inches, and 100% of recharge available for appropriation, safe yield was determined to be 498.03 acre-feet. Existing water rights have appropriated 243.79 acre-feet, providing a difference of 254.24 acre-feet available for appropriation, and the application requesting no additional quantity complies with safe yield. To date, recharge values have not yet been established within the 2016 GMD 2 expansion area. Safe yield was performed several different ways and even in the most restrictive scenario, which is outlined in this memorandum, safe yield was still met.

# Nearby Water Rights

One (1) appropriated well (File Nos. 48,460 & 21,401) was found to be within a half mile of the proposed point of diversion, however it is owned by the applicant. As the proposed point of diversion is located within the City of Galva. The applicant was required to submit a public notice within the local newspaper of record. An affidavit of publication was returned by the applicant for the McPherson Sentinel after three consecutive weeks of publication. No comments of any kind were received during the public notice period open to comments and concerns. It should be noted that there are several residential buildings near the city's existing well, many of which may have domestic wells that do not meet standard well spacing. Taking into consideration the fact that these are existing vested right wells that have been in continuous operation since at least 2019, no comments of any kind were received, no additional rate is being requested, and DWR has no records of any complaints, existing well spacing appears to be adequate and a waiver of well spacing regulation K.A.R. 5-22-2 is recommended.

### Recommendations

On December 9, 2024, the application was sent to Groundwater Management District #2 for a recommendation allowing for 30 days to provide a recommendation or to request an extension of time. On January 9, 2025, an extension was requested. The GMD was allowed another 30 days to provide a recommendation or to request an extension of time. As of March 26, 2025, no correspondence of any kind has been received from the district. **Therefore, a waiver of regulation K.A.R. 5-22-12 has been proposed.** This regulation outlines the procedure for getting a recommendation from GMD 2.

The application has been recommended for approval by Jeff Lanterman, Water Commissioner of the Stafford Field Office in an email dated October 21, 2020, and in an email dated April 24, 2024.

The application complies with all regulations concerning reasonable quantity, safe yield, and minimum well spacing requirements. The proposed applications are subject to minimum desirable streamflow requirements. Approval of the applications will not impair senior water rights nor prejudicially or unreasonably affect the public interest. Therefore, it is recommended that the referenced application be approved.

I sent the applicant a public notice and have not received any comments or concerns of any kind.



# **Analysis Results**

The selected PD is in an area OPEN to new appropriations.

The safe yield based on the variables listed below is 498.03 AF.

Total prior appropriations in the circle is 343.79 AF. (-100 50283 = 243.79) Safe Yield is Met.

Total quantity of water available for appropriation is 154.24 AF.

# Safe Yield Variables

The area used for the analysis is set at 5,976 acres. (Area adjusted to only within GMD #2)

The potential annual recharge at the circle center is estimated to be 1.0 inches.

The percent of recharge available for appropriation is 100%.

Authorized Quantity values are as of 21-OCT-2020 and are based on Appropriated and Vested ground water right and possible stream nodes for GMD #2. Domestic, Term and Temporary water rights have been excluded.

There are 6 water rights and 6 points of diversion within the circle.

- 1. That K.A.R. 5-22-2(a)(2) requires a minimum well spacing of 660 feet from a well or wells proposed by an application to all other domestic wells.
- 2. That the wells which are the subject of the above referenced application may not meet minimum well spacing criteria as required by K.A.R. 5-22-2(a)(2), because there are several in-town residences within 660 feet, which may have domestic wells for watering lawns and gardens.
- 3. That the wells which are the subject of the above referenced application are authorized under Vested Right, MP 002, have existed at this location since the 1930s, and have been in continuous operation in the proposed manner since at least 2019, due to oilfield contamination at the City's other authorized wells.

This is to certify that I have examined Application, File No. 50,283 of the applicant

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

- 1. That the priority date assigned to such application is August 12, 2019.
- 2. That the water sought to be appropriated shall be used for municipal use in the City of Galva and immediate vicinity.
- 3. That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn at the following points:
  - one (1) well located in the Northwest Quarter of the Southwest Quarter of the Southwest Quarter (NW¼ SW¼ SW¼) of Section 22, more particularly described as being near a point 1,040 feet North and 4,530 feet West of the Southeast corner of said section, and
  - one (1) well located in the Northwest Quarter of the Southwest Quarter of the Southwest Quarter (NW¼ SW¼) of Section 22, more particularly described as being near a point 1,040 feet North and 4,580 feet West of the Southeast corner of said section.
  - both in Township 19 South, Range 2 West, McPherson County, Kansas, located substantially as shown on the topographic map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of 250 gallons per minute (0.56 c.f.s.) and to a quantity not to exceed 32,585,100 gallons of water (100 acrefeet) for any calendar year.

5. That the quantity of water approved under this permit is further limited to the quantity which combined with Vested Right, File No. MP 002, Water Right, File No. 21,401, and Appropriation of Water, File Nos. 48,459 and 48,460, will provide a total not to exceed **55 million gallons of water (76.72 acrefeet)** per calendar year, for municipal use within the City of Galva and immediate vicinity.

- 6. That the rate of diversion of water approved under this permit is further limited to the rate which combined with Vested Right, File No. MP 002, will provide a maximum diversion rate not in excess of **250 gallons per minute (0.56 c.f.s.)** from the wells at the locations described herein.
- 7. That installation of works for diversion of water shall be completed on or before <u>December 31</u>, <u>2026</u>, or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.
- 8. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2046</u>, or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.
- 9. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.
- 10. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 11. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 12. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 13. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 14. That acceptable water flow meters shall be installed and maintained on the diversion works authorized by this permit in accordance with Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. These water flow meters shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).

15. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1, following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.

- 16. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.
- 17. That the applicant must submit a progress report to the office of the Chief Engineer by March 1 after the tenth year from the date of the approval of this application and permit to proceed. The progress report is to contain sufficient details to explain the extent of development (perfection) of the water right during the previous ten (10) years, the extent of population being served by the water right and how the water right, in association with any other water right(s) meets the demonstrated municipal use need.
- 18. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.
- 19. That failure without cause to comply with the provisions of this permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may request an evidentiary hearing before the Chief Engineer or request administrative review by the Secretary of Agriculture. Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Division, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
