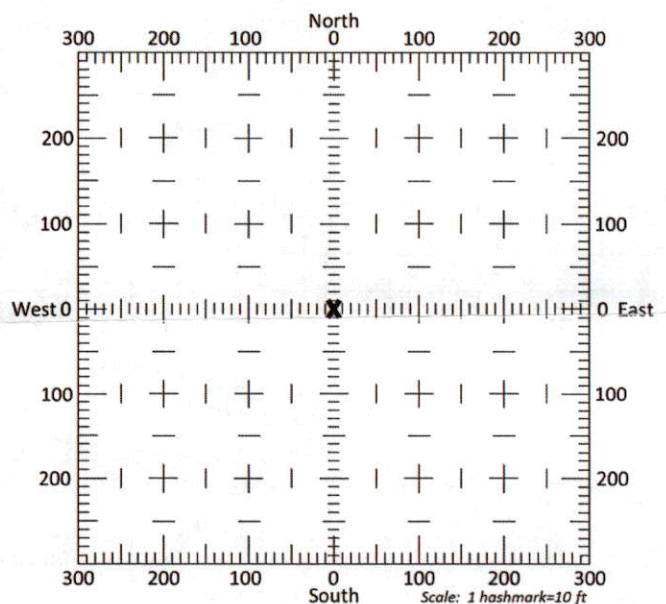

The Equus Beds Groundwater Management District No. 2 reviewed the referenced change in place of use applications on March 19, 2025, using the District's Revised Management Program (effective May 1, 1995) and Rules and Regulations K.A.R. 5-22-1 through 5-22-17.

The change applications propose to modify the place of use and add 1.3 acres for a total of 179 acres and form a complete and identical overlap between Water Permit Nos. 50461 & 50584. The proposed place of use results in a combined water to land ratio of 1.11 acre-feet per acre.

The District's review found that the change applications comply with the Revised Aquifer Management program approved by the Chief Engineer and with the District's Rules and Regulations K.A.R. 5-22-1 through 5-22-17. Based upon the review, the change applications are recommended for approval by the Equus Beds Groundwater Management District No. 2.

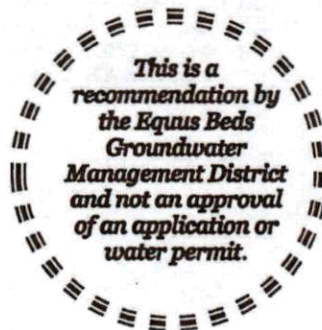

Change in place of use application submitted by Marvin Miller to modify the place of use and add 1.3 acres for a total of 179 acres in Reno County. PU is proposed to add 1.3 acres to the PU and form a complete and identical overlap in PD/PU with change in PU filed on No. 50584. The app. map shows the areas to be modified. Water Permit No. 50461 has not been perfected. PD will apparently be corrected with this change to a battery of three wells, as one well of the battery was not completed.

Water Permit No. 50461 has authorized acres and base acres of 177.7 acres.

Application requests a change in place of use of the currently authorized acres and add 1.3 acres for a total of 179 acres. Base acres for No. 50461 & 50584 is 177.7 total acres. Proposed increase of 1.3 acres (less than 1%) complies with K.A.R. 5-5-11 max increase of 10 acres/10% (whichever is less).

Item 14:  $187 \text{ AF} / 179 \text{ acres} = 1.05 \text{ AF/A}$  - combined with No. 50584 =  $(187 \text{ AF} + 12 \text{ AF} = 199 \text{ AF} / 179 \text{ Acres}) = 1.11 \text{ AF/A}$ . At or below max AF/A for Reno Co. of 1.4 AF/A permit was approved in 2023.

No meter inspection has been performed by GMD2 to date, but previous meter requirement when permits were approved. Nos. 50461 & 50584 received notice of non-compliance for overpumping in 2023 (less than 24 hours).

Reno County records show the currently authorized place of use is owned by Marvin R. & Jackie L. Miller. It appears that only Marvin Miller signed the application. GMD2 will notify DWR for their information and action if needed.

Recommend approval, complies with K.A.R. 5-22-1 through 5-22-17.
