No water has been pumped under 48223, which auth. 335 AF on 277 acres. A reduction in place of use under file no.44316 will be filed concurrently to remove 120 acres from the total 277 base acres. This application will propose to cover 230 acres (1.46 AF/AC). Since no water has been used, there will be no increase in historic net consumptive use, which allows base acres to be exceeded under K.A.R. 5-5-11(6).
