

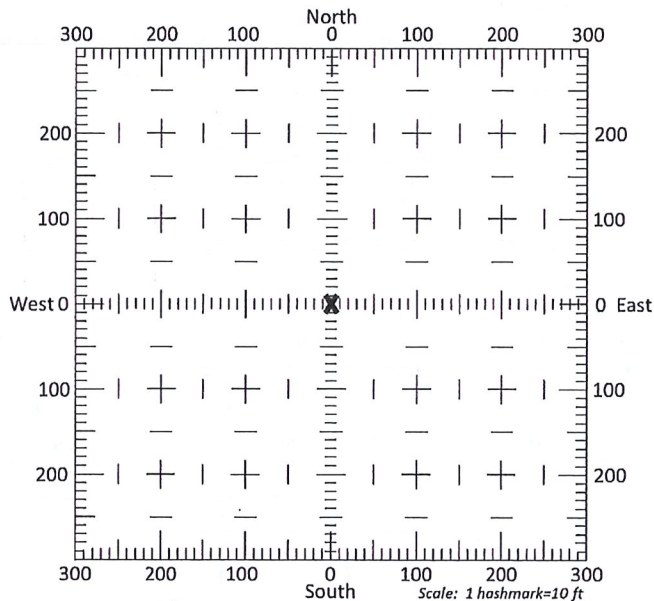

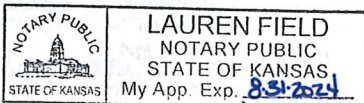

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, et seq. and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et. seq.*, and rules and regulations promulgated thereunder. 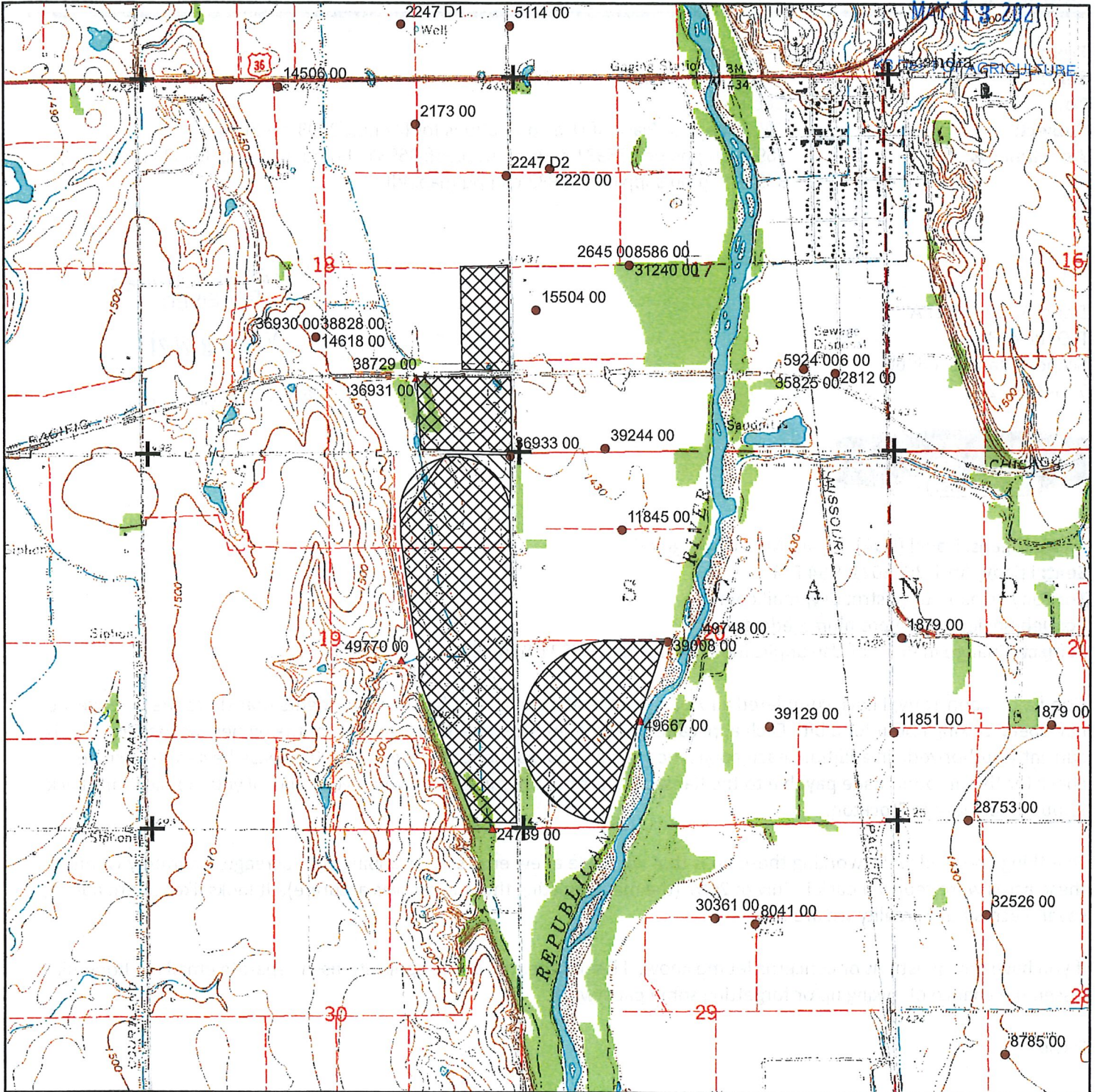

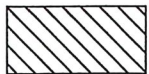

5. The General Partner is empowered to execute any instruments necessary to acquire, convey, encumber, lease and otherwise act on behalf of the Partnership insofar as the same affects title to any interest of the Partnership in real or personal property.
