Matt Toll has filed the above referenced application to appropriate surface water directly from the Smoky Hill River for irrigation use. The applicant is proposing a single pump site, and requesting 85 acrefeet of surface water at a diversion rate of 750 gallons per minute to irrigate 75 acres in McPherson County. The place of use is owned by Craig Meyers, and the landowner has signed the application form stating he has access to the point of diversion. Water Right, File No. 2960-D2 overlaps in both point of diversion and place of use.

Water Right, File No. 2960-D2 is authorized 45 acre-feet of water. The applicant has purchased only 40 acre-feet from the Lower Smoky Hill Access District, therefore the new application will be limited to 85 acre-feet with this senior file, providing only 40 acre-feet additional water. The requested 85 acre-feet, is less than the maximum allowable to irrigate the proposed 75 acres with 1.3 acre-feet per acre in McPherson County, Kansas, however it provides 1.1 acre-feet per acre, which is still reasonable.

The applicant provided a list of nearby landowners, which complies with K.A.R. 5-3-4. These same nearby landowners were recently notified (on 4/27/20) regarding the change in point of diversion for the senior file 2960-D2, which overlaps this new application. No responses of any kind were received and no further notification letters are required for this new application since the upstream and downstream landowners are certainly aware of this irrigation project. There are multiple surface water rights located both upstream and downstream of the pump site within a two-mile radius. The nearest downstream pump site is located over 2,000 feet away. Therefore, with proper conditioning, approval of this application will not impair any senior water rights.

Since the source of supply will be the direct diversion of surface water from the Smoky Hill River, this application is subject to the restrictions of K.A.R. 5-3-15, which, in part, require the applicant to demonstrate that the direct diversion of surface water is not necessary during the period from July 1 through September 30 of each calendar year. In order to comply with K.A.R 5-3-15 (c)(5) the applicant is proposing to use stored water from Kanopolis Reservoir, under the newly formed Lower Smoky Hill River Irrigation District. This stored water is now available to irrigators since the special use district has been implemented. Per K.A.R 5-3-15, the application will be subject to specific conditions, which stipulate strict requirements for direct surface water diversion. These conditions include the stipulation that no diversion shall occur unless there is water available to satisfy all demands by senior water rights and permits, written or verbal permission from the Chief Engineer, or an authorized representative is required prior to diverting water, and streamflow cannot be stopped at the first riffle below the point of diversion while diversion is taking place.

A copy of the application was sent to the Kansas Water Office for their review and comment. In a letter dated July 27, 2020, the KWO stated that the results of the OASIS model run indicate that there is sufficient assurance reservoir storage to support the requested additional water. DWR Technical Services staff also recommended approval of the new application in conjunction with the determination by the KWO.

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed.

The applicant has submitted a signed Minimum Desirable Streamflow form for the pending new application, which has been properly notarized. By completing this statement, the applicant affirms his/her knowledge that there could be times when the diversion of water may not be allowed under this permit.

Kelly Stewart, Water Commissioner, Stockton Field Office, recommended that the referenced new application be approved in an e-mail received on July 16, 2020.

Based on the above discussion, the application is supported by the Lower Smoky Hill River Access District, Smoky Hill River is open to new appropriations meeting specific criteria, the application complies with all regulations, the Kansas Water Office supports approval, and approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest, it is recommended that the referenced application be approved.

Basin scale modeling has been conducted by the Kansas Water Office (KWO) within the Smoky Hill River basin to determine required water supply storage for drought periods given historical drought conditions. To do so, the Smoky Hill River basin was simulated for the period of 1950-2014 using historical conditions, except with reservoir inflows being depleted early in the simulation based on the trends through time.

The Smoky Hill River basin model is made up of Kanopolis Lake and downstream users to the confluence with the Republican River near Junction City, Kansas. Kanopolis Lake holds water for the Smoky Hill Access District, containing accounts for municipal and irrigation water users. For the irrigation portion of the Smoky Hill Access District, 1952-1957 represents the multi-year drought of record whereas 2012 represents the single-year drought of record.

KWO modeling of member demands indicates that the 24.23% of Kanopolis conservation storage (approximately 11,259 acre-feet in 2020) currently owned by the Smoky Hill Access District would be sufficient to supply water use authorized by Application, File No. 50,397 along with current appropriations during the historic droughts, given both current capacity of Kanopolis and the capacity in 20 years.

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

- 1. That the priority date assigned to such application is May 13, 2020.
- 2. That the water sought to be appropriated shall be used for irrigation use on land described in the application, as follows:

That the authorized source from which the appropriation shall be made is surface water from the Smoky Hill River, to be diverted at one (1) pump site located in the Southwest Quarter of the Southwest Quarter of the Southwest Quarter (SW½ SW½ SW½) of Section 5, more particularly described as being near a point 257 feet North and 5,122 feet West of the Southeast corner of said section, in Township 17 South, Range 5 West, McPherson County, Kansas, located substantially as shown on the topographic map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of **750** gallons per minute (1.67 c.f.s.) and to a quantity not to exceed **85 acre-feet** of water for any calendar year.
- 5. That installation of works for diversion of water shall be completed on or before <u>December 31</u>, <u>2022</u> or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2026</u> or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

- 7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.
- 8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 12. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
- 13. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.
- 14. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.
- 15. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.
- 16. That the stream flow shall not be stopped at the first riffle below the point of diversion while diversion is taking place under the authority of this water right or permit.
- 17. That diversion of natural flows shall not take place unless there is water available to satisfy all demands by senior water rights and permits.

- 18. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.
- 19. That during the period October 1 through June 30, the verbal or written permission of the Chief Engineer, or an authorized representative of the Chief Engineer, shall be obtained in order to divert water each time the applicant desires to divert water.
- 20. That during the period July 1 through September 30 each calendar year, no direct diversions of surface water shall be permitted unless written permission is obtained from the Chief Engineer, or the Chief Engineer's authorized representative.
- 21. That the quantity of water approved under this permit is further limited to the quantity which combined with Water Right, File No. 2,960-D2, will provide a **total not to exceed 85 acre-feet** of water per calendar year for irrigation use from the point of diversion described herein.

Your attention is directed to the enclosures and to the terms, conditions, limitations, and requirements specified in this permit.

Notice must be filed on the enclosed form once the diversion works have been completed. Failure to complete the diversion works within the time allowed, or within any authorized extension of time thereof, will result in dismissal of this permit. If you need an extension of time, you must request it before the deadline for completion set forth in the permit. Any request for an extension of time must be accompanied by the statutorily required fee, which is currently \$100.00.

An acceptable water flowmeter must be installed on the diversion works authorized by this permit prior to using water. An annual water use report must be filed with the Chief Engineer by March 1, following the end of each calendar year. If a complete annual water use report is not received by the deadline, then a fine may be assessed and all water use under such permit or right may be suspended. Reports submitted in paper form will be assessed a \$20 per file number paper filing fee. In order to avoid this filing fee, you may submit your report online at <a href="https://www.kswaterusereport.org">www.kswaterusereport.org</a>.

The approval of your application constitutes a permit to appropriate water. It does not give authority to construct any dam or other stream obstruction regulated by K.S.A. 82a-301 through 305a. It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

Enclosed is an informational sheet that sets forth the procedure to obtain a Certificate of Appropriation which will establish the extent of your perfected water right. #### RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

1) request an evidentiary hearing before the Chief Engineer, or

2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
