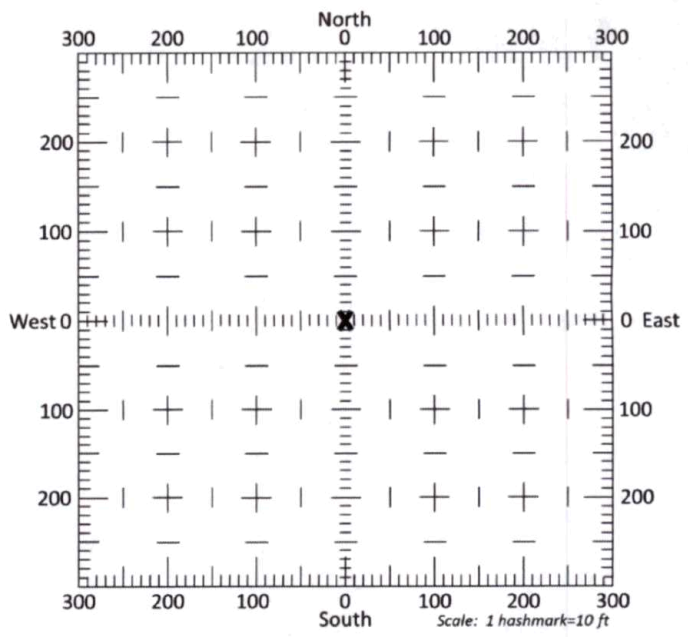

1. A change application was received on 9-18-24 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application. Stockton Field Office

2. On and after the effective date of this summary order, the authorized place(s) of use shall be located substantially as shown on the topographic map accompanying the application to change the place of use. Applicable Not Applicable
3. The change in point of diversion shall not impair existing rights and shall be limited to the same source or sources of water as previously authorized. Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.

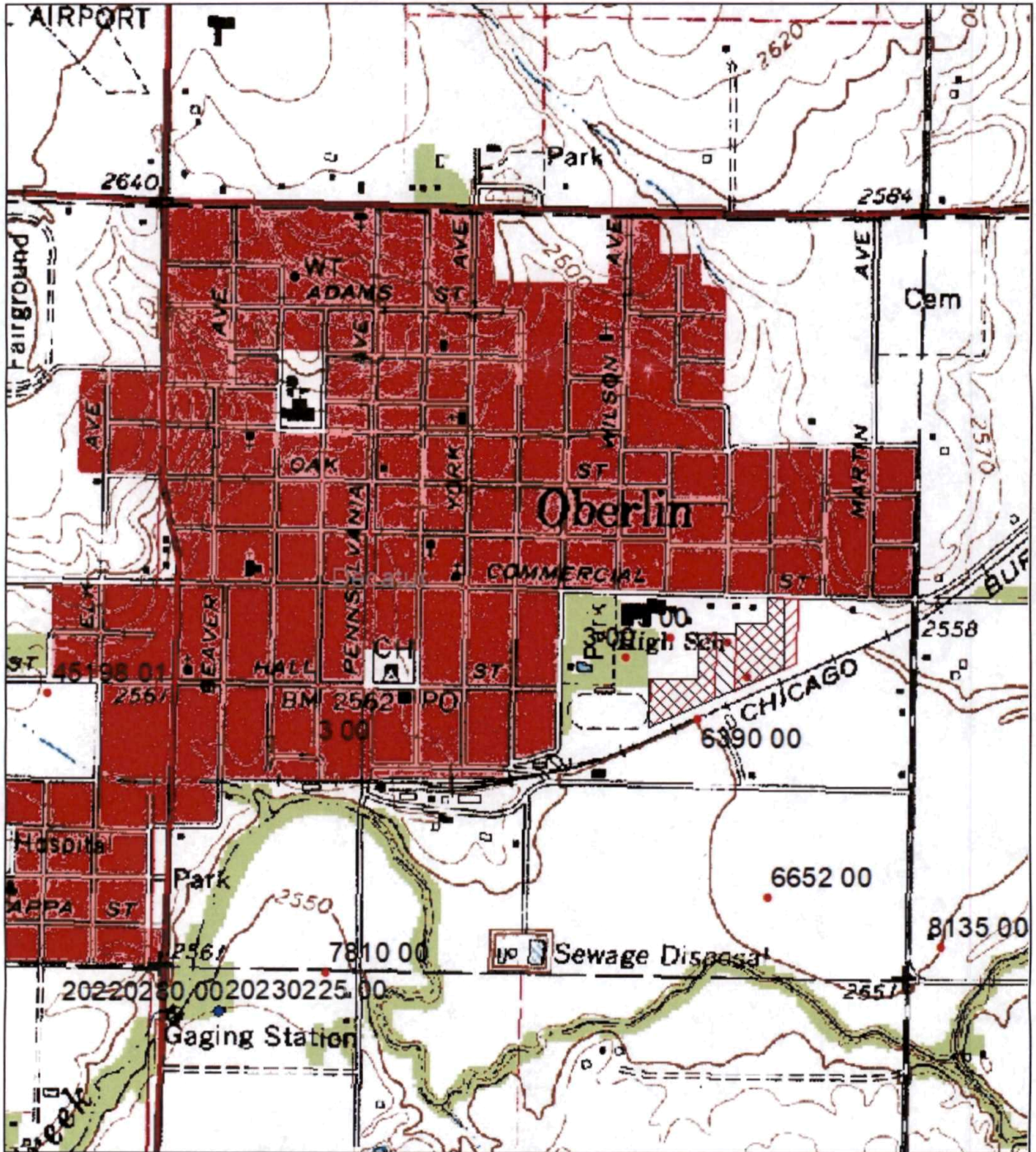
