Haag Farms has filed the above referenced applications proposing to appropriate surface water by both the collection and storage of natural flows in two existing reservoirs (File Nos. 49,661 and 49,662), and the direct diversion of surface water at a pump site (File No. 49,663). The two storage applications are located on tributaries to Six Mile Creek, while the pump site is located directly on Six Mile Creek (Wakarusa). Application, File No. 49,663 will allow water to be pumped directly from the stream (when flows are adequate and permission has been granted) either directly to the place of use or into the reservoirs requested under Application, File Nos. 49,661 and 49,662, to be stored for subsequent re-diversion for irrigation use. The points of diversion are all located in the West Half of Section 16, Township 13 South, Range 15 East, Shawnee County, Kansas. The applications' place of use comprises 134 acres, wholly owned by the applicant, and Ernie Haag representing the applicant has signed the application forms stating that he has legal access to the points of diversion. The files will be used for the same irrigation project (i.e. overlap in place of use).

Please note that the applicant has a senior file, Water Right, File No. 43,388, which also overlaps the proposed place of use. The point of diversion for this senior water right is the watershed district reservoir located in the adjacent section to the west (Section 17). The applicant has informed DWR that he no longer has access to this point of diversion. The applicant has elected not to dismiss this senior file, therefore these new applications will be limited in quantity for direct irrigation use as needed. Water Right, File No. 43,388 is authorized 49 acre-feet for direct irrigation use.

Application, File No. 49,661 is requesting 60.7 acre-feet of surface water storage, and the re-diversion of 60.7 acre-feet of the stored water for irrigation use at 1,200 gallons per minute. Runoff computations have determined that the 52 acre drainage area will result in only 60.7 acre-feet of runoff in 1 out of every five (5) years (a 20% chance). Therefore, per K.A.R. 5-6-5, this quantity **IS** the limiting factor, and the application has requested this allowable maximum quantity. No quantity limitation is required on this file.

Application, File No. 49,662 is requesting 49 acre-feet of surface water storage, and the re-diversion of 49 acre-feet of the stored water for irrigation use at 1,200 gallons per minute. Runoff computations have determined that the 42 acre drainage area will result in only 49 acre-feet of runoff in 1 out of every five (5) years (a 20% chance). Therefore, per K.A.R. 5-6-5, this quantity **IS** the limiting factor, and the application has requested this allowable maximum quantity. A quantity of 134 acre-feet is the maximum allowable to irrigate the proposed 134 acres, since 1.0 acre-feet per acre is allowable in Shawnee County, Kansas. Therefore a quantity limitation is required on File No. 49,662 when combined with the two senior files for direct IRR use on the proposed place of use. File No. 49,662 will provide for 24.3 acre-feet of additional water when combined with the two senior files (134 AF – 49 AF – 60.7 AF).

Application, File No. 49,663 is requesting 134 acre-feet of surface water at a diversion rate of 1,000 gallons per minute. Per K.A.R 5-3-15, Application, File No. 49,663 will be subject to specific conditions, which stipulate strict requirements for direct surface water diversion. These conditions include the stipulation that no diversion shall occur unless there is water available to satisfy all demands by senior water rights and permits, written or verbal permission from the Chief Engineer, or an authorized representative is required prior to diverting water, and streamflow cannot be stopped at the first riffle below the point of diversion while diversion is taking place. The application also complies with K.A.R 5-3-15 (c)(5) because the proposed off-stream reservoirs will provide adequate water storage, and there is no need for direct diversion of water from July 1 through September 30. File No. 49,663 will be limited to 134 acre-feet when combined with the senior files, and will provide no additional quantity of water.

Notification letters for all three applications were sent to upstream and downstream landowners on July 25, 2016. Telephone calls were received from both an upstream and a downstream landowner, who asked general questions about the applications, but provided no specific impairment concerns. They were both informed about the specific conditions relative to the direct diversion of streamflow under Application, File No. 49,663 (i.e. requiring permission, can't stop flow). The WRIS database indicates there are several sediment control reservoirs within a two (2) mile radius of the files, which are owned by Wakarusa Watershed Joint District #35, and they are all on different tributaries. Therefore approval of these applications will not impact any senior water rights. As noted above, the direct diversion of water under File No. 49,663 will generally be limited to off-season, and only when there is sufficient water to satisfy all senior water rights.

The North dam (File No. 49,661) is already permitted under DWR Structures Program staff File No. DSN-0237, which was issued many years ago. The second existing structure (File No. 49,662) was determined to be non-jurisdictional for structures permitting.

There is no established Minimum Desirable Streamflow (MDS) for the Wakarusa River. As allowed by K.S.A. 82a-706(c) approved water flow meters shall be installed on the diversion works and/or secondary diversion works (reservoir pump sites) for these files. If any chemical or foreign substance is injected into the water pumped under these permits, check valves will also need to be installed.

In an August 10, 2016 discussion, Katie Tietsort, Water Commissioner, Topeka Field Office, stated that the referenced new applications should be approved. Based on the above discussion, that this area is open to new appropriations, the proposed appropriations of water are reasonable, the structures are either already permitted or determined to be non-jurisdictional by the DWR Water Structures Program, and senior rights will not be impacted, it is recommended that the referenced new applications be approved. This will successfully allow the applicant to continue his irrigation project from these new sources of water supply.


There are enclosed permits to appropriate water authorizing you to proceed with construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a), to divert such unappropriated water as may be available from the sources and at the locations specified in these permits, and to use it for the purpose and at the location described in these permits.

Your attention is directed to the enclosures and to the terms, conditions, and limitations specified in these permits, with specific reference to Paragraph Nos. 19 and 20 for File No. 49,663 requiring you to obtain permission prior to diverting water at your pump site. Water meters are required and you must install them prior to water being put to beneficial use in order for you to maintain accurate records of water use. The meters should be used to provide the information required on the annual water use reports. Failure to notify the Chief Engineer of the Division of Water Resources of the completion of the diversion works within the time allowed, or within any authorized extension of time thereof, will result in the dismissal of these permits. Enclosed are forms which may be used to notify the Chief Engineer that the proposed diversion works have been completed for each file.

All requests for extensions of time to complete diversion works, or to perfect appropriations, must be submitted to the Chief Engineer before the expiration of time originally set forth in these permits to complete diversion works or to perfect an appropriation. If for any reason, you require an extension of time, you must request it before the expiration of time set forth in these permits. Failure to comply with this regulation will result in the dismissal of your permits or your water rights. Any request for an extension of time shall be accompanied by the required statutory fee, which is currently \$100.00 per file number. There is also enclosed an information sheet setting forth the procedure to obtain Certificates of Appropriation which will establish the extent of your water rights.

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

1. That the priority date assigned to such application is **June 24, 2016**.

2. That the water sought to be appropriated shall be used for irrigation use on land described in the application, as follows:

3. That the appropriation sought shall be limited to all natural flows of an unnamed tributary to Six Mile Creek, designated in the office of the Chief Engineer as Six Mile Creek Trib 5 (Wakarusa), not needed to satisfy all vested rights and prior appropriation rights to be incrementally accumulated as reservoir storage space becomes available to a maximum extent of **60.7 acre-feet** per calendar year in one (1) reservoir created by a dam located in the Southwest Quarter of the Southeast Quarter of the Northwest Quarter (SW¼ SE¼ NW¼) of Section 16, more particularly described as being near a point 3,168 feet North and 4,030 feet West of the Southeast corner of said section, in Township 13 South, Range 15 East, Shawnee County, Kansas, to provide **60.7 acre-feet** of water as needed for direct irrigation use to be withdrawn, released or otherwise diverted from the reservoir at a re-diversion rate of approximately **1,200 gallons per minute (2.67 c.f.s.)**. A reasonable maximum re-diversion rate will be established during the perfection period and assigned at certification.

4. That installation of works for diversion of water shall be completed on or before **December 31, 2017** or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee, which is currently \$400.00, when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee, which is currently \$100.00.

5. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before **December 31, 2021** or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee, which is currently \$100.00.

6. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.

7. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.

8. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.

9. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.

10. That all re-diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the re-diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

11. That an acceptable water flow meter shall be installed and maintained on the re-diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).

12. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.

13. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.

14. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

15. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

This Order shall become a final agency action, as defined by K.S.A. 77-607(b), without further notice to the parties, if a request for hearing or a petition for administrative review is not filed as set forth below.

Request for Hearing. According to K.A.R. 5-14-3(c), any party who desires a hearing must submit a request within 15 days after the date shown on the Certificate of Service attached to this Order. Filing a request for a hearing will give you the opportunity to submit additional facts for consideration, contest any findings made by the Chief Engineer, or present any other information you believe should be considered in this matter. A timely-filed request for hearing will stay the deadline for requesting administrative review of this Order pending the outcome of the hearing.

Petition for Review. The applicant, if aggrieved by this Order, may petition for administrative review, pursuant to K.S.A. 82a-711(c) and K.S.A. 82a-1901(a). The petition must be filed within 30 days after the date shown on the Certificate of Service attached to this Order and must set forth the basis for the review, unless stayed by the timely filing of a request for hearing.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564-6777.

Your application for permit to appropriate water in 16-13S-15E in Shawnee County, was received and has been assigned the file number noted above.

As a matter of record, the Division of Water Resources has on hand a large number of applications awaiting processing. Therefore to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. Once review of your application has begun, we will contact you, if additional information is required.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water as proposed prior to approval of the application is unlawful. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

**Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.**

**(b) (1) The violation of any provision of this section by any person is a class C misdemeanor . . .**

**A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.**

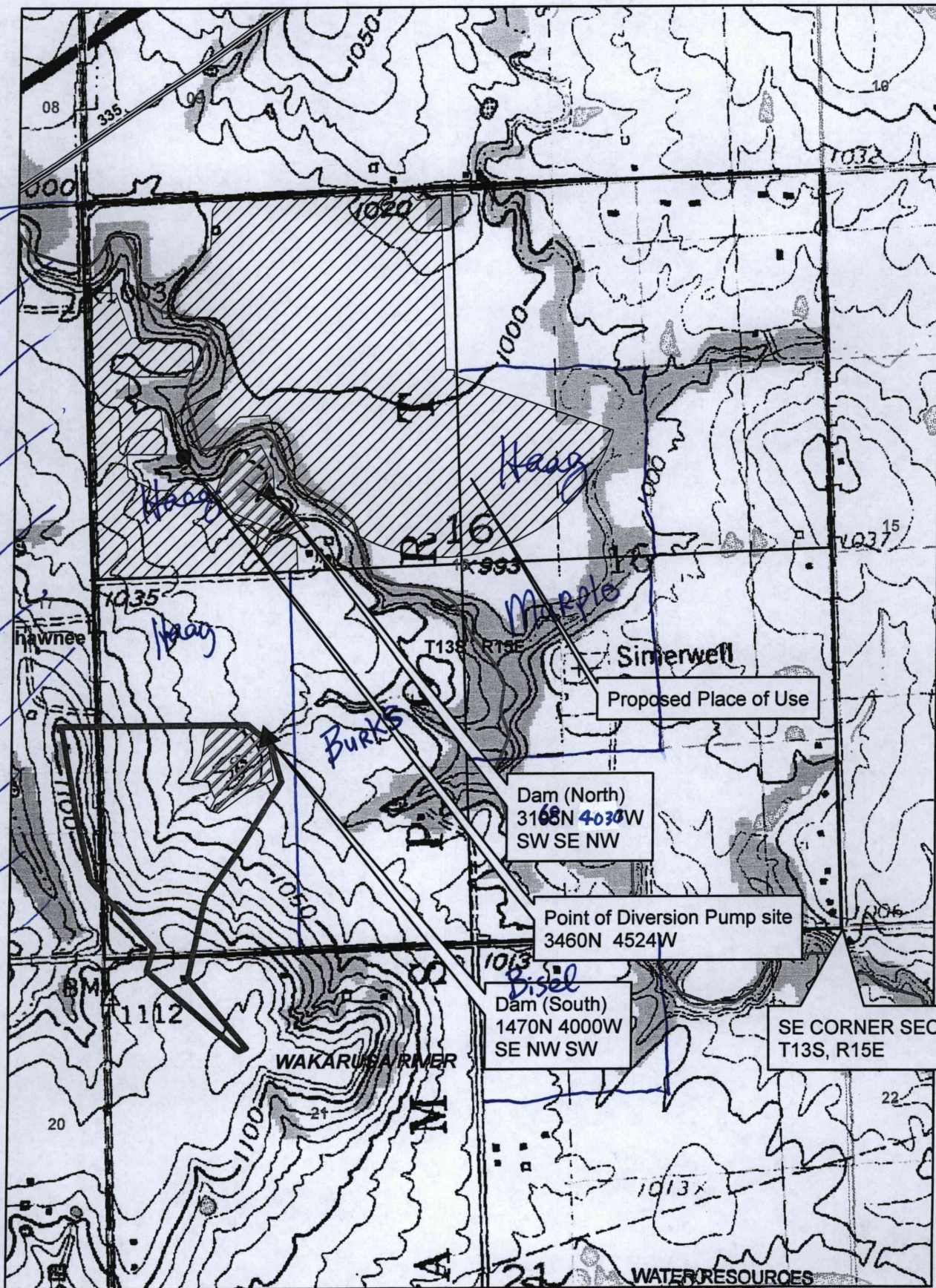

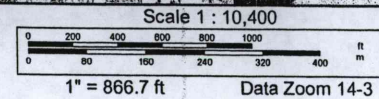

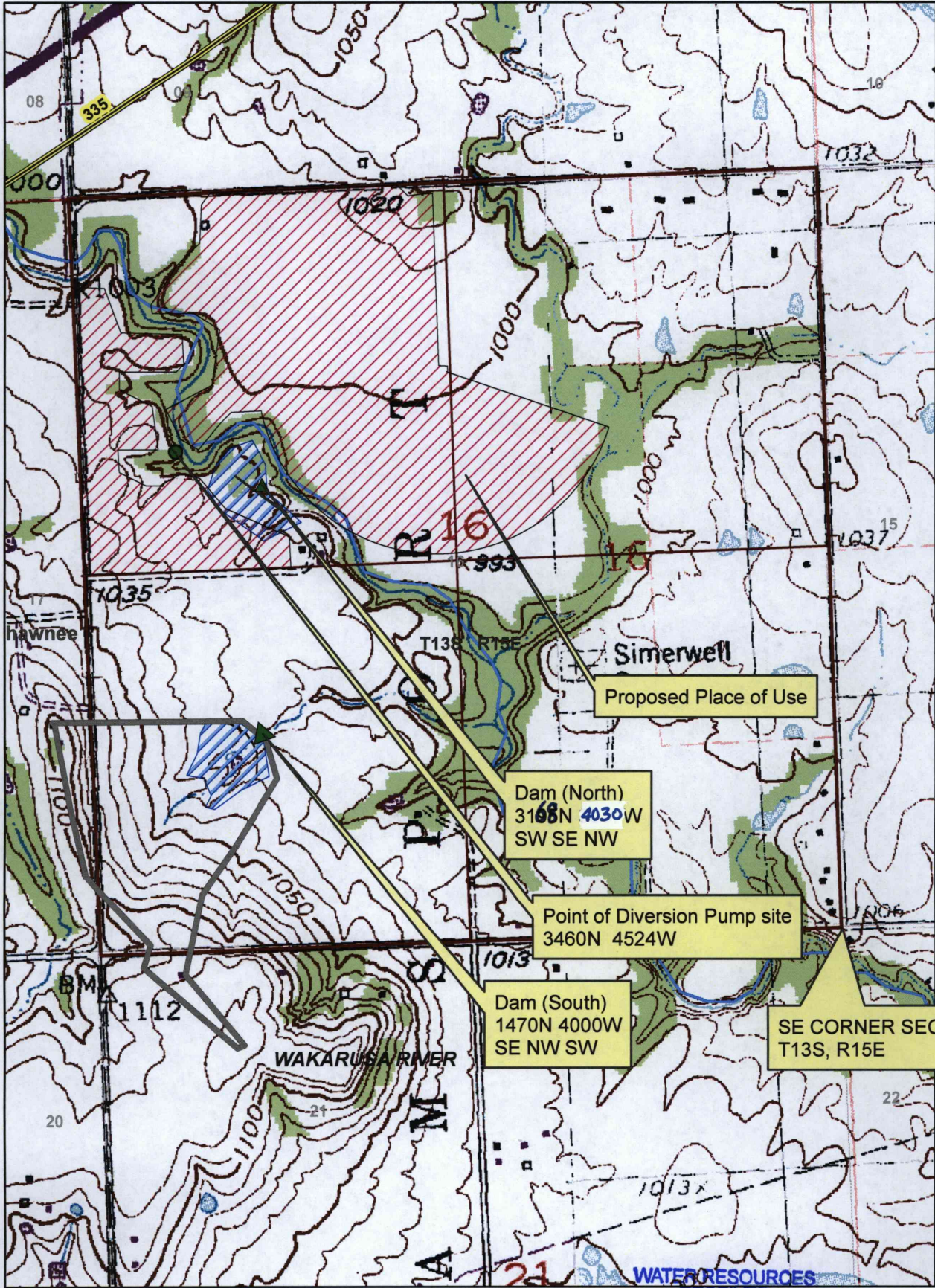
