Henry Land & Cattle has filed new applications proposing to appropriate surface water by both the direct diversion of surface water at three (3) pump sites (File No. 49,851), and the collection and storage of natural flows in two proposed reservoirs (File Nos. 49,852 and 49,853). All of the applications will be used for the same irrigation project (i.e. overlap in place of use), which comprises 1,715 acres. The applicant is using the water in large part to dilute his wastewater lagoons (from cattle feedlot) and then irrigating from the lagoons, as well as the storage ponds. The applicant stated that he needs a large place of use to adequately handle the lagoon wastewater. The place of use is owned by the applicant, Henry Farms, Richard and Jody Cott Trusts, and Cecil and Evelyne M. Keen Trusts. In each case, the applicant has signed the application forms stating that he has legal access to the points of diversion.

Application, File No. 49,851 is proposing to appropriate 320 acre-feet of surface water at a diversion rate of 2,000 gallons per minute. The source of water is a tributary (Trib 2) to Chapman Creek in the Smoky Hill River Basin, located in the Northeast Quarter of Section 5, Township 10 South, Range 2 East, Clay County, Kansas. Application, File No. 49,851 is designed to allow water to be pumped directly from Chapman Creek Trib 2 (when flows are available "off-season") into the two off-stream reservoirs to be stored for subsequent re-diversion for irrigation use, or dilute the wastewater lagoons. Generally, the off-season irrigation months are from October 1 through June 30 of each calendar year. The requested rate of diversion of 2,000 gallons per minute appears to be reasonable to provide a large quantity of water in a short time period to fill the reservoirs and take advantage of high flow conditions on the stream, which may be of short duration. This direct diversion file will be conditioned such that during the period October 1 through June 30, the verbal or written permission of the Chief Engineer, or an authorized representative of the Chief Engineer, shall be obtained in order to divert water each time the applicant desires to divert water; and during the period July 1 through September 30 each calendar year, no direct diversions of surface water shall be permitted unless written permission is obtained from the Chief Engineer, or the Chief Engineer's authorized representative.

Application, File No. 49,852 is requesting to appropriate 109.2 acre-feet of surface water at the rate of natural flows to be stored in a proposed reservoir (West Dam) and redivert 109.2 acre-feet for irrigation use. The reservoir is located in the Southeast Quarter of Section 5. The dam is located on Chapman Creek Trib 2A (Smoky Hill). Runoff computations determined that the 131.1 acres of drainage area, will generate 109.2 acre-feet of runoff in 1 out of every five (5) years (a 20% chance). Therefore, per K.A.R. 5-6-5, this quantity **IS** the limiting factor, and the application was processed with this quantity.

Application, File No. 49,853 is requesting to appropriate 72 acre-feet of surface water at the rate of natural flows to be stored in a proposed reservoir (East Dam) and redivert 72 acre-feet for irrigation use. The reservoir is located in the Northwest Quarter of Section 4. The dam is located on Chapman Creek Trib 2B (Smoky Hill). Runoff computations determined that the 86 acres of drainage area, will generate 72 acre-feet of runoff in 1 out of every five (5) years (a 20% chance). Therefore, per K.A.R. 5-6-5, this quantity **IS** the limiting factor, and the application was processed with this quantity.

The total combined quantity of water for direct use (pump site and rediversion) is 501.2 acre-feet for irrigation use on 1,715 acres, obviously much less than the 1.2 acre-feet per acre, which is the maximum allowable in Clay County, Kansas, per K.A.R. 5-3-24. However, additional water will be provided by wastewater from the feedlot, and the quantity is reasonable for supplemental irrigation use.

The structures have been reviewed under structures program File Nos. DCY-0184 (East Dam) and DCY-0185 (West Dam). One of the dams was determined to be non-jurisdictional and the second dam qualifies for the hazard class A permit exemption specified in K.S.A. 82a-301(d)(1).

The applicant provided a list of landowners of the adjacent properties within one-half (½) mile upstream and downstream of his property. Notification letters were sent out on July 21, 2017. A telephone call was received from Mr. Van Scoyoc who wanted to know if this approval would impact his irrigation project located over 2 miles downstream in Section 17. Mr. Van Scoyoc is pumping directly from Chapman Creek, which drains a large area, and diverting from a couple of tributaries should not have a significant impact on Chapman Creek stream flow. There are no other surface water rights within a two-mile radius according to the WRIS database, other than the applicant's files. No senior water rights will be impaired with approval of these applications.

As allowed by K.S.A. 82a-706(c) approved water flow meters shall be installed on the secondary diversion works (pump sites) for File Nos. 49,852; and 49,953, and the direct pump sites under File No. 49,851. If any chemical or foreign substance is injected into the water pumped under these permits, check valves will also need to be installed.

In an August 23, 2017 discussion, Katie Tietsort, Water Commissioner, Topeka Field Office, stated that the referenced new applications should be approved. Based on the above discussion, that this area is open to new appropriations, the proposed appropriations of water are reasonable, the applications comply with rules and regulations, and no senior rights will be impacted, it is recommended that all of the referenced new applications be approved.

Dear Mr. Henry:

There are enclosed permits to appropriate water authorizing you to proceed with construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a), to divert such unappropriated water as may be available from the sources and at the locations specified in these permits, and to use it for the purpose and at the location described in these permits.

Your attention is directed to the enclosures and to the terms, conditions, and limitations specified in these permits, with specific reference to File No. 49,851 Paragraphs Nos 19 and 20, **which require you to obtain permission prior to diverting water.** In addition, **water meters are required on both the pumpsites and the re-diversion works from your reservoirs,** and you must install them prior to water being put to beneficial use in order for you to maintain accurate records of water use. The meters should be used to provide the information required on the annual water use reports. Failure to notify the Chief Engineer of the Division of Water Resources of the completion of the diversion works within the time allowed, or within any authorized extension of time thereof, will result in the dismissal of these permits. Enclosed are forms which may be used to notify the Chief Engineer that the proposed diversion works have been completed for each file.

All requests for extensions of time to complete diversion works, or to perfect appropriations, must be submitted to the Chief Engineer before the expiration of time originally set forth in these permits to complete diversion works or to perfect an appropriation. If for any reason, you require an extension of time, you must request it before the expiration of time set forth in these permits. Failure to comply with this regulation will result in the dismissal of your permits or your water rights. Any request for an extension of time shall be accompanied by the required statutory fee, which is currently \$100.00 per file number. There is also enclosed an information sheet setting forth the procedure to obtain Certificates of Appropriation which will establish the extent of your water rights.

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

1. That the priority date assigned to such application is **June 12, 2017**.
2. That the water sought to be appropriated shall be used for irrigation use on land described in the application, as follows:

3. That the authorized source from which the appropriation shall be made is surface water from an unnamed tributary to Chapman Creek, designated in the office of the Chief Engineer as Chapman Creek Trib 2 (Smoky Hill), to be withdrawn by means of three (3) pump sites located as follows: one in the Southeast Quarter of the Southeast Quarter of the Northeast Quarter (SE¼ SE¼ NE¼) of Section 5, more particularly described as being near a point 2,835 feet North and 588 feet West of the Southeast corner of said section; one in the Southwest Quarter of the Northeast Quarter of the Northeast Quarter (SW¼ NE¼ NE¼) of Section 5, more particularly described as being near a point 4,237 feet North and 1,199 feet West of the Southeast corner of said section; and one in the Northwest Quarter of the Northeast Quarter of the Northeast Quarter (NW¼ NE¼ NE¼) of Section 5, more particularly described as being near a point 5,046 feet North and 960 feet West of the Southeast corner of said section, all in Township 10 South, Range 2 East, Clay County, Kansas, located substantially as shown on the topographic map accompanying the application.

4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of **2,000 gallons per minute (4.46 c.f.s.)** and to a quantity not to exceed **320 acre-feet** of water for any calendar year.

5. That installation of works for diversion of water shall be completed on or before **December 31, 2018** or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee, which is currently \$400.00, when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee, which is currently \$100.00.

6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before **December 31, 2022** or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee, which is currently \$100.00.

7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.

8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.

9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.

10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.

11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

12. That an acceptable water flow meter shall be installed on the diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and ending of the report year).

13. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.

14. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.

15. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

16. That the stream flow shall not be stopped at the first riffle below the point of diversion while diversion is taking place under the authority of this water right or permit.

17. That diversion of natural flows shall not take place unless there is water available to satisfy all demands by senior water rights and permits.

18. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

19. That during the period October 1 through June 30, the verbal or written permission of the Chief Engineer, or an authorized representative of the Chief Engineer, shall be obtained in order to divert water each time the applicant desires to divert water.

20. That during the period July 1 through September 30 each calendar year, no direct diversions of surface water shall be permitted unless written permission is obtained from the Chief Engineer, or the Chief Engineer's authorized representative.

#### **RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW**

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (**i.e., within a total of 18 days after this Order was mailed to you**), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (**i.e., within a total of 33 days after this Order was mailed to you**), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.



If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.



This is to advise you that Henry Land & Cattle has filed the applications referred to above for permits to appropriate surface water for irrigation use. File No. 49,851 is requesting to appropriate 320 acre-feet of surface water per calendar year from a tributary to Chapman Creek, to be diverted at a maximum rate of 2,000 gallons per minute. Please note that the purpose of this application, if approved, would be to divert surface water during the "off-season" irrigation months (October 1 through June 30), to fill off-stream water storage facilities (reservoirs), which would be authorized storage under separate pending applications. Surface water will be diverted from three pump sites located in the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 5, Township 10 South, Range 2 East, and

File No. 49,852 is requesting to appropriate 109.3 acre-feet of surface water per calendar year to be stored in a proposed reservoir, and re-divert 109.3 acre-feet of the stored water for irrigation use. The proposed point of diversion (where the structure crosses the centerline of the stream) is located in the Northeast Quarter of the Southwest Quarter of the Southeast Quarter (NE $\frac{1}{4}$  SW $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section 5, all in Clay County, Kansas.

Records in this office indicate that you own land along the stream in this vicinity and you are being notified of receipt of these applications in order that you may be fully informed of the proposed location of the applicant's points of diversion and proposed use of water. 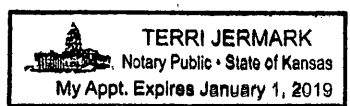

Therefore to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. Once review of your application has begun, we will contact you, if additional information is required.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water as proposed prior to approval of the application is unlawful. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

**Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.**

**(b) (1) The violation of any provision of this section by any person is a class C misdemeanor . . .**

**A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.**

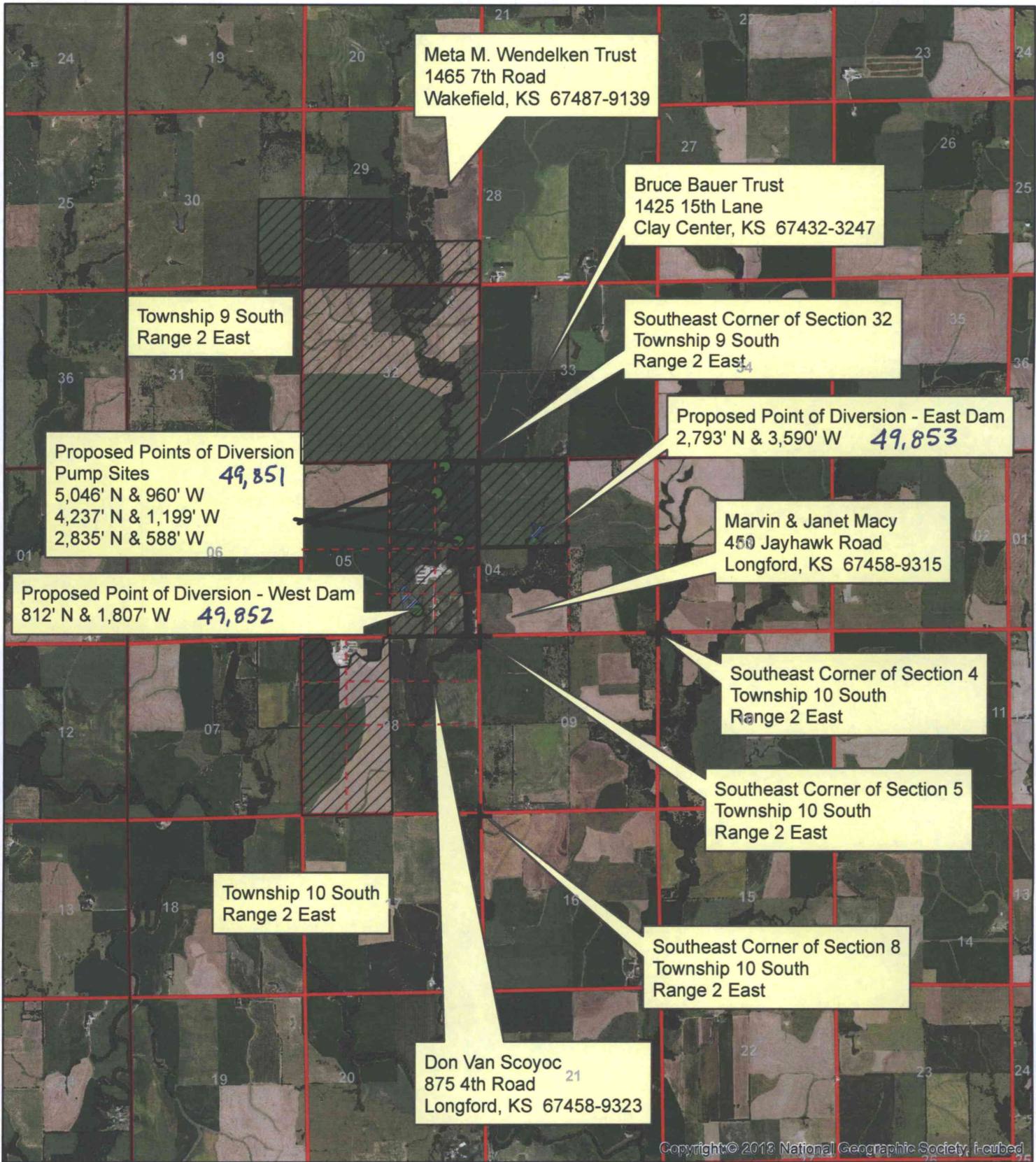
