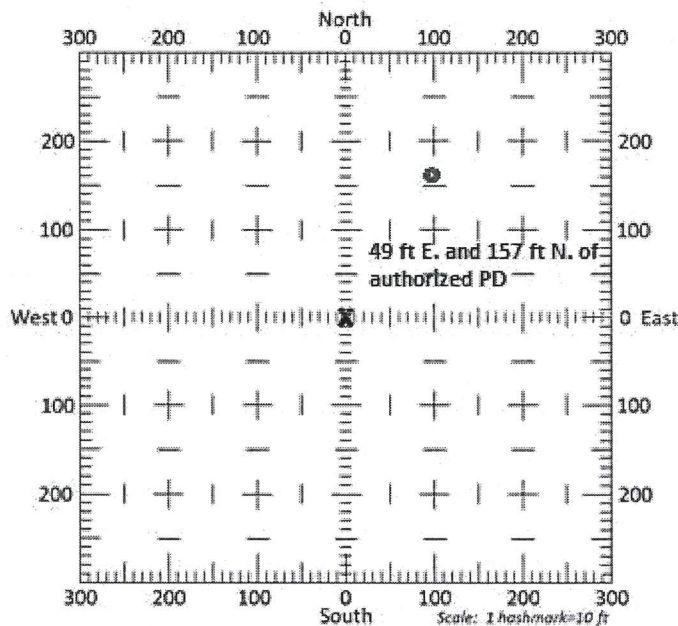

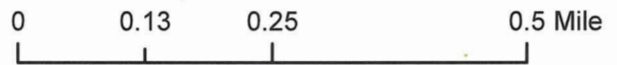
# POINT OF DIVERSION CHANGE FILE NO. 45,240
