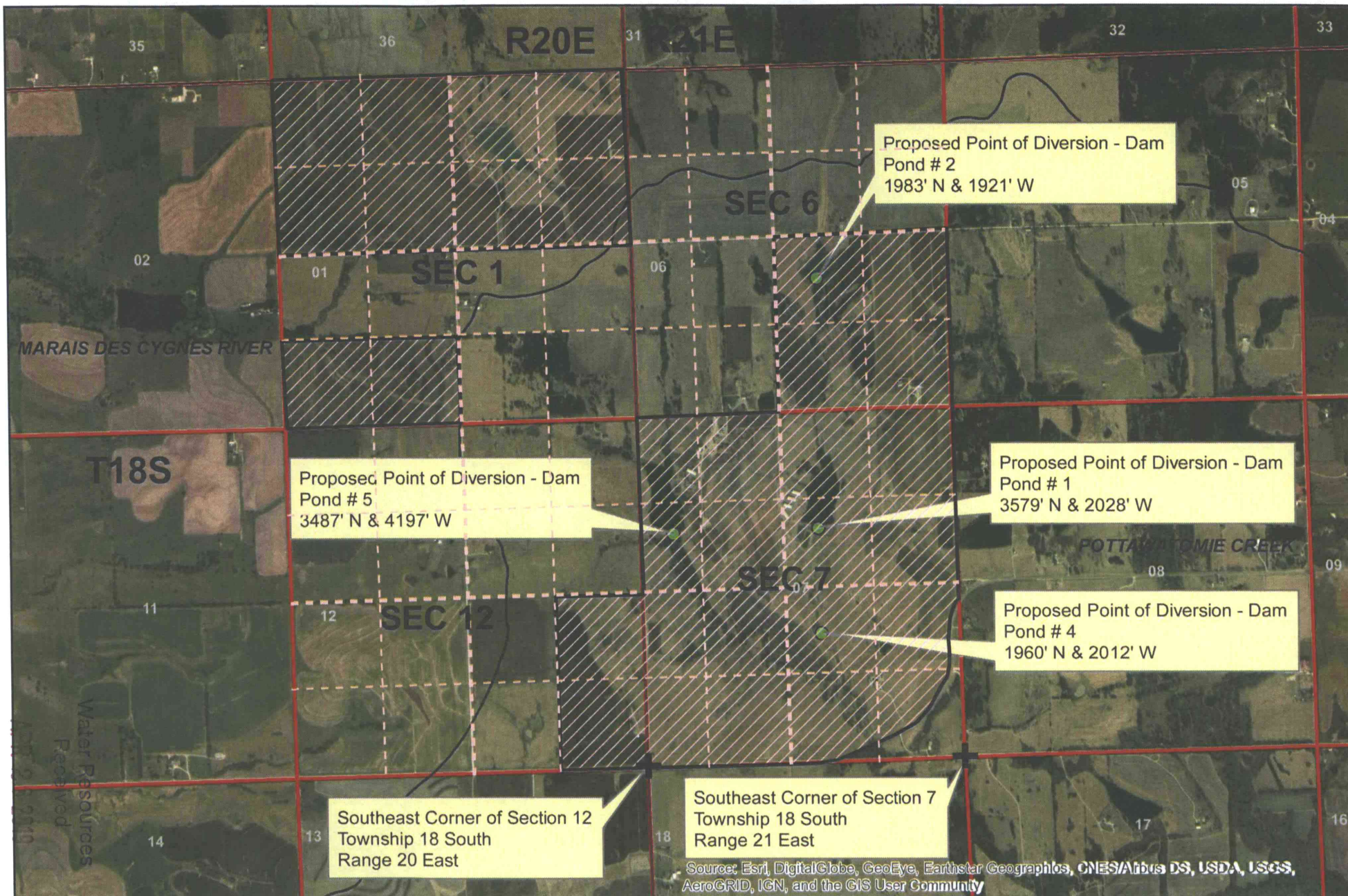

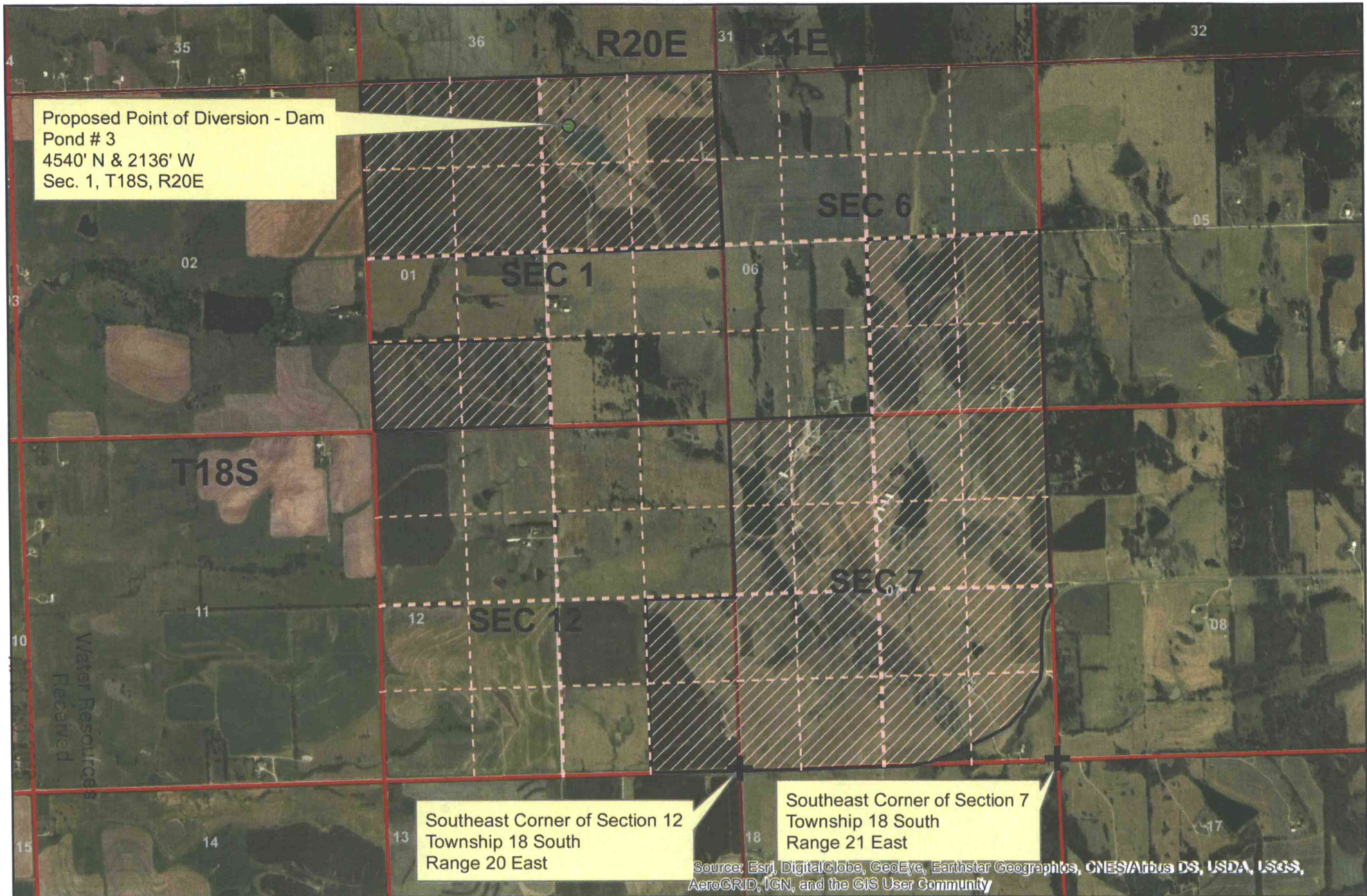


Proposed Point of Diversion
