Any use of water that is not as authorized by the water right or permit to authorize water **before** the chief engineer approves this application is a violation of the Kansas Water Appropriation Act for which criminal or civil penalties may be assessed. Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

**The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse.** If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.

In the event that all applicants cannot appear before one notary public, they may as necessary sign separate copies of the application before any notary public conveniently available to them. All copies signed in this manner shall be considered to be valid parts of the application.

If the request is signed on behalf of any Owner by someone with legal authority to do so (for example, an agent, one who has power of attorney, or an executor, executrix, conservator), it will be necessary to attach proper documents showing such authority.

**I declare that I am an owner of the currently authorized place of use as identified herein, or that I represent all such owners and am authorized to make this application on their behalf, and declare further that the statements contained herein are true, correct, and complete. By filing this application I authorize the chief engineer to permanently reduce the quantity of water and/or rate of diversion as specified in sections 14 and 15 of this application.**

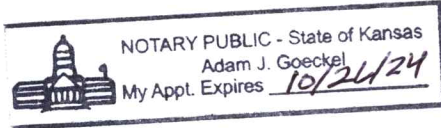

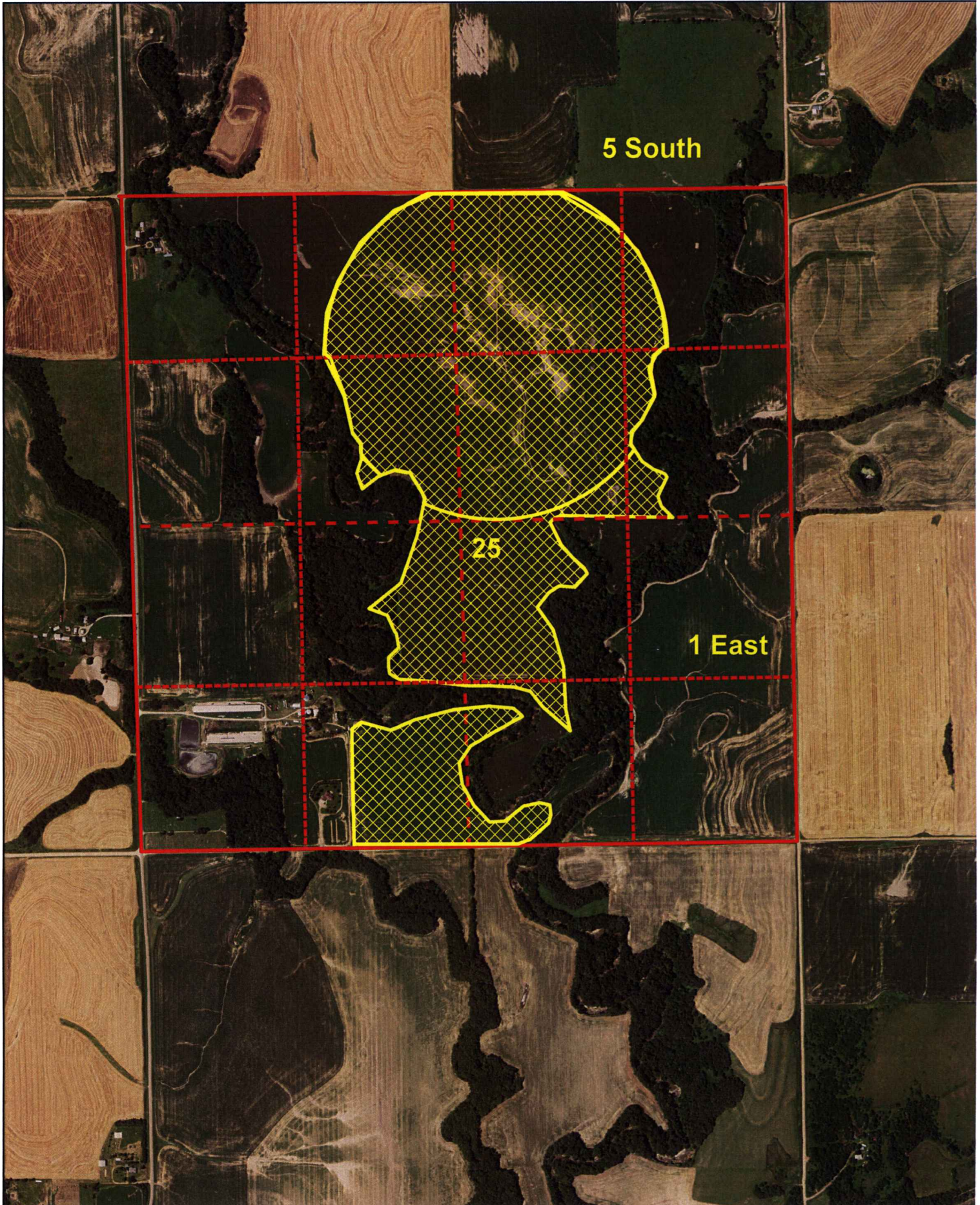

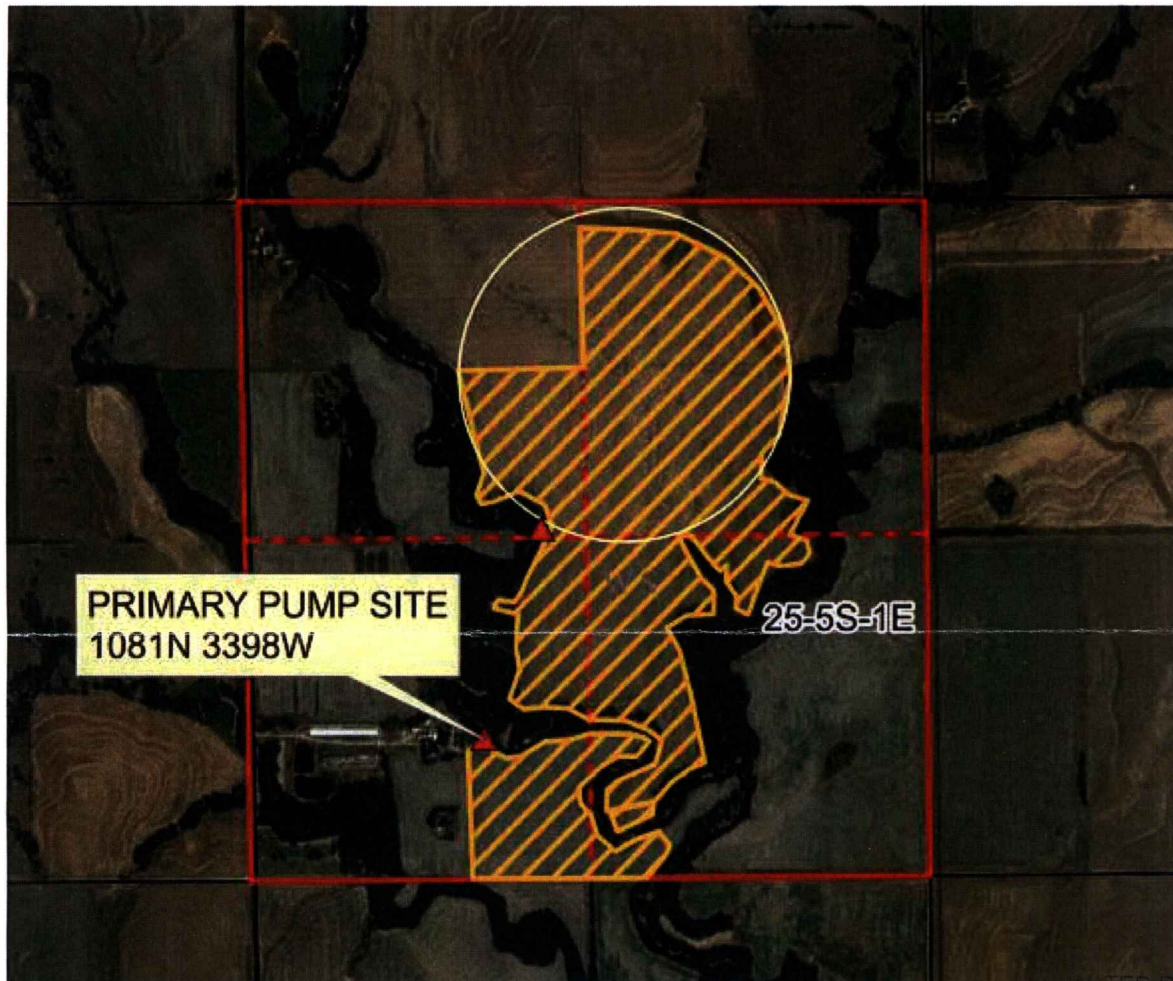

Dear Sir and Madam:

On January 19, 2022, a compliance investigation was conducted for File No. 19,362. The investigation identified that the place of use authorized under the water right appears to be out of compliance. Observations in the field and analysis of aerial photographs indicate that you are irrigating land that is not authorized under the water right. There is a pivot installed to the north that swings over land not authorized.

Based on this investigation, your Water Right, File No. 19,362 has been determined to be out of compliance as you are unlawfully irrigating acres not covered under the place of use.

To permanently remedy this situation and bring your water right into compliance you must make the necessary change application(s) to request to cover the land you are actually irrigating, if approvable, and bring your file into compliance. It may be necessary to file additional applications to cover the acreage, depending on how many acres not under the pivot you wish to irrigate. **To remedy this situation, please contact this office and file any necessary applications by a deadline of February 28, 2022** to avoid a Cease and Desist Order being issued.
