RE: Water Right File No. 43,487

Rural Water District No. 9, Leavenworth County, has filed an application for approval to change the authorized point of diversion under Water Right, File No. 43,487 authorized groundwater in the Stranger Creek Basin. The referenced change application was filed along with new Application, File No. 50,659.

Water Right No. 43,487 is currently authorized as one well located in the Southeast Quarter of Section 3, Township 11 South, Range 21 East. However, new application no. 50,659 was filed to add an additional two wells to Leavenworth RWD No. 9 as production from the well authorized by 43,487 has diminished over time. This change application was filed to move the point of diversion to overlap with a new battery of two wells under application no. 50,659.

The total limited quantity under File Nos. 19,460, 43,487, 43488, 43489 and 50,659 is 55.617 million gallons per year. There will be no additional volume with new application 50,659.


Nearby well owners were notified of the referenced change application on February 14, 2023 with multiple responses but only three responses were in writing. Both concerns described the low water pressure in the area along with the overall effect of the aquifer so that there was no decline in the future.

In e-mail dated April 13, 2021, Brett Bunger of the Topeka Field Office, indicated no objections to approval of the referenced change application.

A water flow meter is required. A check valve is required if chemigating.

Based on the above discussion that the changes are reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it is recommended that the referenced applications be approved.

# **Analysis Results**

The selected PD is in an area OPEN to new appropriations. The safe yield based on the variables listed below is 3,954.22 AF Total prior appropriations in the circle is 800.96 AF. 153.44-153.44=494.08 AF Total quantity of water available for appropriation is 3,153.26 AF **3,460.14 AF** 

# Safe Yield Variables

The area used for the analysis is set at 8,042 acres. The potential annual recharge at the circle center is estimated to be 5.9 inches. The percent of recharge available for appropriation is 100%.

Authorized Quantity values are as of 11-APR-2023 and are based on Appropriated and Vested ground water right and possible stream nodes for GMD #2. Domestic, Term and Temporary water rights have been excluded.

There are 10 water rights and 13 points of diversion within the circle.

### APPROVAL OF APPLICATION FOR CHANGE IN POINT OF DIVERSION WATER RIGHT FILE NO. 43,487

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Rural Water District No. 9, Leavenworth County, Post Office Box 295, Tonganoxie, Kansas, 66086, received in this office on January 17, 2023, for approval of a change in the location of the point of diversion under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, finds that the change is reasonable and will not impair existing rights, that the change relates to the same local source of supply and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the authorized point of diversion shall be described as:

a battery of two (2) wells, with a geographical center located in the Southeast Quarter of the Northeast Quarter of the Southeast Quarter (SE¼ NE¼ SE¼) of Section 3, more particularly described as being near a point 1,540 feet North and 200 feet West of the Southeast corner of said section, in Township 11 South, Range 21 East, Leavenworth County, Kansas, located substantially as shown on the topographic map accompanying the application.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

Both wells shall be located within a three hundred (300) foot radius circle, in the same local source of supply, and shall supply water to a common distribution system.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to File No. 43,487, for permit to appropriate for beneficial use, is as stated and set forth in the Certificate of Appropriation dated December 31, 2019.

Dear Mr. Lohman:

Enclosed is a permit authorizing Leavenworth RWD 9 to proceed with construction of the proposed diversion works and to appropriate water for beneficial use as set forth in the permit. The new application has been processed in conjunction with your application to change the authorized point of diversion, under Water Right File No. 43,487, the approval of which is also enclosed. Your attention is directed to the enclosures and to the terms, conditions, limitations, and requirements specified in the approved permit and the change approval order. Also enclosed are the Findings and Order by the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, dismissing Application, File No. 50,660, as requested in the District's form letter dated October 31, 2022.

For the approved permit and change approval, a notice must be filed on the enclosed form once the diversion works have been completed. Failure to complete the diversion works within the time allowed, or within any authorized extension of time thereof, will result in dismissal of this permit. If you need an extension of time, you must request it before the deadline for completion set forth in the permit. Any request for an extension of time must be accompanied by the statutorily required fee, which is currently \$100.00.

An acceptable water flowmeter must be installed on the diversion works prior to using water. An annual water use report must be filed with the Chief Engineer by March 1, following the end of each calendar year. If a complete annual water use report is not received by the deadline, then a fine may be assessed, and all water use under such permit or right may be suspended. Reports submitted in paper form will be assessed a \$20 per file number paper filing fee. In order to avoid this filing fee, you may submit your report online at *www.kswaterusereport.org*.

The approval of your new application constitutes a permit to appropriate water. It does not give authority to construct any dam or other stream obstruction regulated by K.S.A. 82a-301 through 305a. It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

### **RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW**

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may request an evidentiary hearing before the Chief Engineer, or request administrative review by the Secretary of Agriculture. Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Division, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
