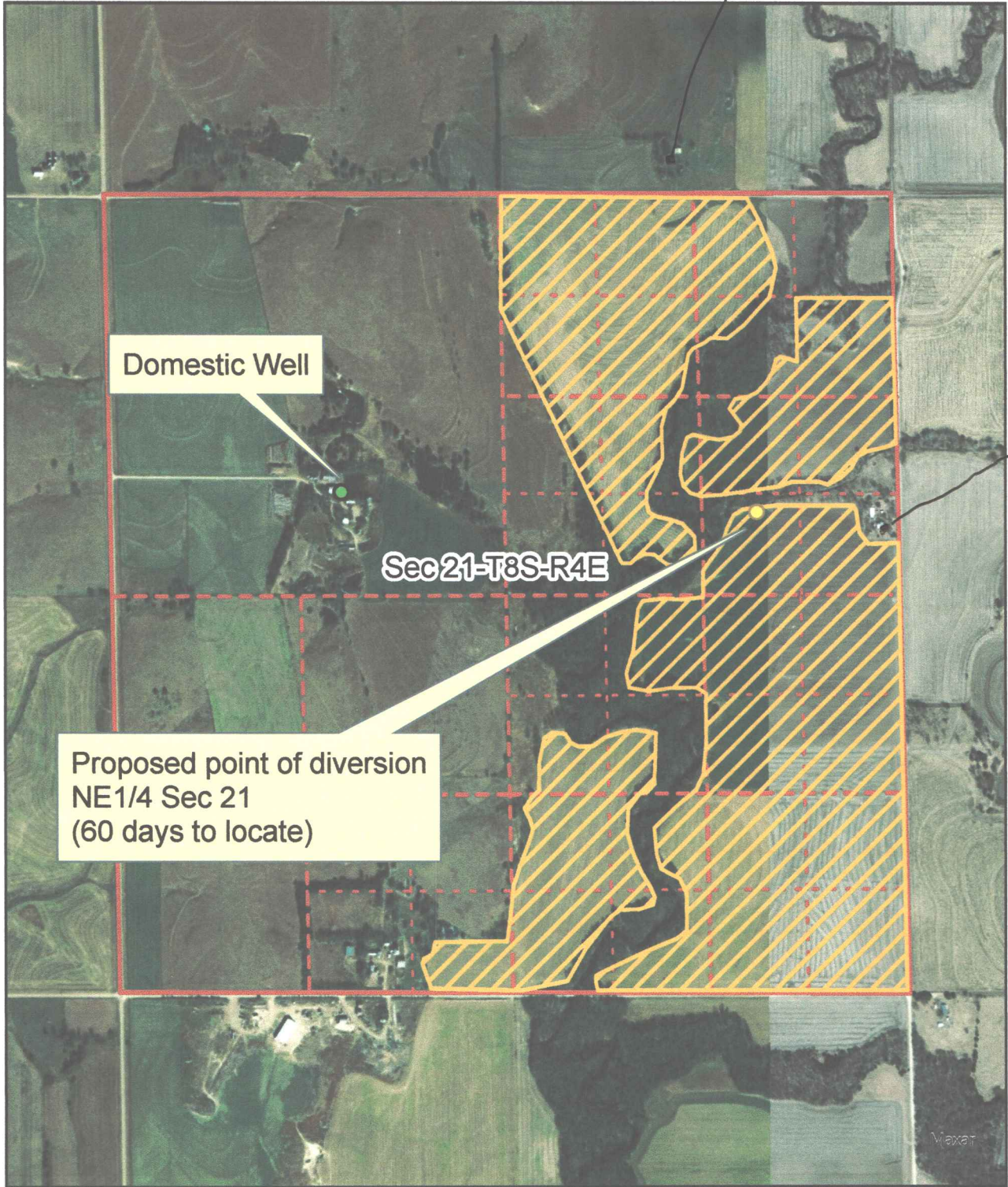

Livestock Well



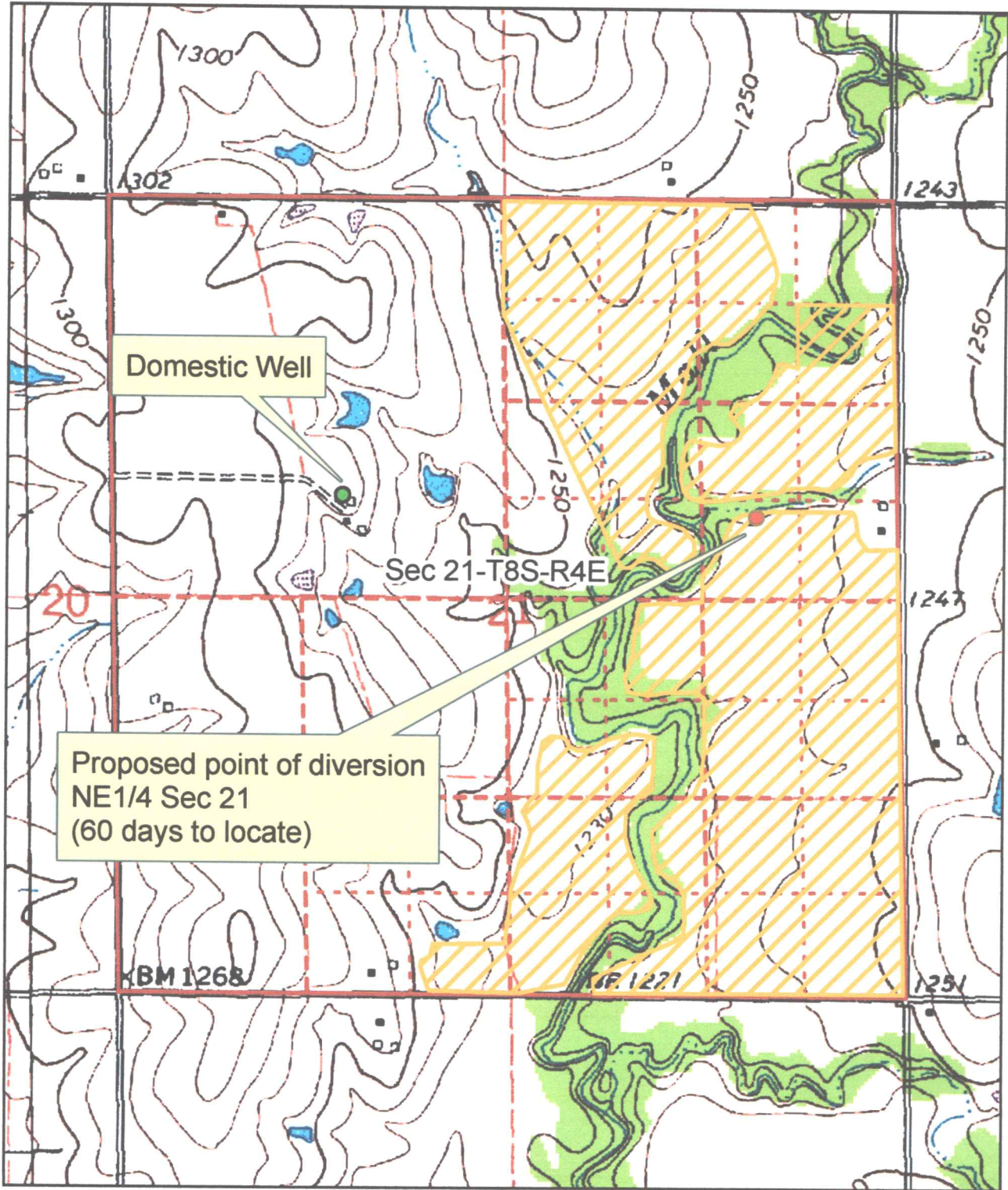
