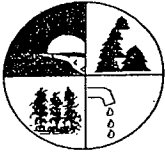

REGULAR MEETING

The regular monthly board meeting was called to order by Chairman Haag at 7:02 p.m. The agenda and roster were circulated to those present.

Items added to the agenda: 11e3) Range Practicum, 12c1)Equipment Request-Steve Melvin, 14d) Building for sale 11g2)HHS Letter

Official notice of the regular monthly meeting was published in the **North Platte Telegraph** and the **McCook Daily Gazette** and was posted in the **NRD office** and on the District Website at www.mrnrd.org. As a courtesy it was also announced on **local radio stations**.

MINUTES

The minutes for the regular board meeting and public hearing on April 13, 2004 were presented. Smith noted that, in the motion to approve the financial report, the motion should read "approve the March financial report" instead of the February financial report.

- ◆ A motion was made by Wertz and second by Fornoff to approve the minutes for the April public hearing and regular board meeting as corrected.

Ayes-10 Nays-0 motion carried
Anderjaska arrived at 7:07p.m.

LEGAL MATTERS

5 appeals of denials of variances, have gone to the Court of Appeals and returned to the District Court. Trial is set for June 11, 2004 for some of these appeals.

A third petition has been filed in Lincoln County.

Smith reported on a Water Seminar being held June 24 in Omaha. Smith and Schroeder are interested in attending. Registration is \$319 each. Jon Schroeder has indicated that if the District would pay for his registration fee, he would take care of all other expenses.

- A motion was made by Wertz and second by Dodson to approve Smith and Schroeder attending the Water Seminar in Omaha.

Ayes-11 Nays-0 motion carried

FINANCIAL ACTIONS

The financial report for April was presented. The County Treasurer's Balance was \$11,517.88. Smith reviewed the reports.

- ◆ A motion was made by Roberts and second by Harsh to approve the April financial report as presented.

Ayes-11 Nays-0 motion carried

The monthly budget comparison was presented and reviewed. A summary of the lawsuit settlement funds was also mailed to Directors.

OPEN FORUM

Mary Vontz, Eugene Anderson and Marilyn Anderson wanted to discuss with the Directors the issue of domestic versus irrigation use. The domestic wells in the area they live, south of the Meeker Canal, are going dry. They would like to know if the NRDs have jurisdiction over domestic wells. The City of McCook has indicated that they will not allow these residents to hook onto the City's system. Discussion was held on giving domestic users first right to the water. There are several irrigation wells in the same section. Madsen indicated that he had spoken to several of the neighbors and thought they had some possible solutions that they planned to pursue.

Don Roberts gave a brief history on surface irrigation, when it started and how it progressed. Roberts suggested considering a 10 inch allocation and allowing owners and operators the option to purchase additional inches for a cost that would go into a fund. This fund would be used for incentive payments to irrigators to retire acres. Roberts does not believe that the dryland farmers and community residents should have to pay taxes to subsidize irrigated acres being retired. Roberts believes the irrigators should pay for this program. Smith reviewed what options the District would have as allowed by legislation. There are other options that the Legislature is looking at the State level. Earl Johnston indicated that he would rather decide how to use his water on his own instead of having to pay more taxes. Johnston also indicated that irrigators need to know as soon as possible what the allocation is going to be. Haag indicated that the Directors would like to find a couple of options that irrigators can choose from based on what works best for their operation.

Claude Cappel noted that surface irrigators have to pay for water that they do not receive. Concern was expressed that, if a tax was levied to finance incentive programs or if irrigators were given the option to purchase inches of water, the cost would increase every year as it has with surface water. Cappel also expressed concern about the new acres that have come in since 2002. These users will receive water but have not been paying taxes on this land for irrigation. Questions were asked about what the criteria will be to buy out acres. Will all acres be eligible or will there be parameters that the acres will have to fall into?

Smith reviewed federal programs that could be used to compensate irrigators for reducing irrigator acres. There are also several options being looked at by the State and the District.

NRCS REPORT

Dave Griffith gave a report on NRCS activities. 211 applications in the District excluding Lincoln County were received for the EQIP program. The new technician in the McCook NRCS has resigned. A study is being done in the area on the long term effect of the drought on the range land. Requests will be going out to land owners requesting access to their land for this study.

NARD

Next meeting is June 21 in South Sioux City. Information for the annual basin tour that is scheduled for the same day was handed out.

Anderjaska updated the Directors on the insurance program. There will be a 20-25% increase in premiums. Deductibles and co-pays will be increasing. The Association is also looking at requiring 100% participation by the Districts. Some Districts currently pay employees the cost of the premiums if they do not take the Association's insurance. A summary of changes being considered was circulated. The Association is also considering changing insurance companys.

NACD

E-notes for 4-27-04 and 5-4-04 were mailed to Directors.

INFORMATION & EDUCATION

Griffith circulated thank-you notes the District has received. She reviewed the information and education report. Griffith is still working with the NERain program and taking applications for volunteers to place rain gauges in every township in the District. Results for the State Envirothon competition were circulated. No Honor Farm Conservation nominations were received.

Information on the 2004 Ranch Practicum was circulated. Steve Chitick contacted the office inquiring whether the District would sponsor a rancher to attend. Registration is \$600. This is a series of meeting from June to January on a variety of Ranch issues and worth 4 undergraduate hours. Registration was due May 3 for this year's practicum. Griffith will try to find more information and the Directors will consider looking at it for next year.

Four applications were received for the 2004 Camp Scholarships. All applications are from Medicine Valley High School. Two of the applicants graduated this year and have received scholarships in previous years. Griffith recommended selecting Kristy Kemp, who is a junior, and Georgia Herman, who is a freshman.

- A motion was made by Harsh and second by Moore to approve Kemp and Herman for the 2004 camp scholarships.

Ayes-11 Nays-0 motion carried

A brochure was circulated for the UNK water tour. Griffith may have some late applications for camp scholarships to be considered in June. There is also a teacher interested in attending as a sponsor.

NEBRASKA REPUBLICAN RIVER MANAGEMENT DISTRICTS ASSOC.

The next meeting will be July 22, 2004 in Alma. The economic impact report being done for the power districts will be released at this meeting.

OTHER AGENCIES OR ASSOCIATIONS

One more meeting is scheduled with the Indianola area communities. The District's involvement will be in an advisory capacity only.

A copy of the letter from HHS was circulated. No action was taken on the well driller involved with Bruce McDermott when McDermott's drilled the illegal wells. The letter indicated that HHS was concerned about the violation of the District's temporary suspension of well drilling. However, the Water Well Standards and Contractors Licensing Board determined that there was insufficient evidence to prove a violation by the well driller.

LEGISLATION

LB 962 as amended was signed by the Governor April 15, 2004. A report from Dean Edson and a report from NWRA concerning LB 962. The bill will take effect the middle of July.

GROUND WATER MANAGEMENT

The well permits report was handed out at the meeting. 2 permits were issued since the last meeting.

Merrigan presented a report on requests for certified acres. In addition to the acres presented on the report, requests were received for Emil Fritz for 130 acres in 23-3-27 and 108.1 acres in 14-2-30, Ferguson Family Trust for 334.4 acres in 6-2-29 and 311.5 acres in 5-2-29, and McCartney Trust for 54.8 acres in 4-2-29. These requests were received too late to be included on the report. This brings total certified acres to approximately 306,000 acres. Merrigan estimates that there is still about 14,000 acres not certified. Discussion was held on how to handle acres not currently certified. Discussion was held on unregistered wells in the District. Acres cannot be certified until the well is registered.

- A motion was made by Harsh and second by Fornoff to approve certified acres as reported with additions.

Ayes-9 Nays-Madsen, Roberts motion carried

A copy of the report is on file with the minutes.

Discussion was held on sending non-compliance notices to all well owners that have not certified the acres. Smith reviewed the options that the non-compliance would give these individuals.

- A motion was made by Anderjaska and second by Harsh to issue orders of non-compliance to all owners of wells that have not had the acres certified.

Ayes-11 Nays-0 motion carried

Smith reviewed the April 19 meeting. The report for this meeting as well as Patterson's response to the District's proposal was circulated. Smith reviewed the response. A summary of the acres certified and the points the Directors need to address was handed out. An update on the CREP program was discussed. DNR has recommended no more than a 14 inch allocation. This was based on 335,000 certified acres. If no reduction of acres or pumping is implemented, the allocation would have to be closer to 11 inches. Discussion was held on the various criteria that can be considered in treating acres or wells differently.

Smith presented a proposal similar to the one presented at the April board meeting. Smith updated the proposal to show the 14 inch allocation suggested by DNR. Discussion was held on the proposal.

- A motion was made by Harsh and second by Anderjaska to change the date from January 2001 to July 1, 1998 and change 1 inch less than base to 2 inches less than base on item 3 of the proposal.

Ayes-8 Nays-Fornoff, Moore, Roberts motion carried

- A motion was made by Fornoff and second by Anderjaska to change proposal #2 to 15 inches instead of the 14 inches DNR recommended considering that there are fewer certified acres than originally estimated.

Ayes-Anderjaska, Dodson, Fornoff, Harsh, Moore, and Wertz

Nays-Hoyt, Madsen, Peters, Roberts, and Haag Motion carried

Discussion was held on the further steps that would be needed to take for water short years. In water short years, actions need to be taken that will get a quick response. Roger Patterson, DNR, has indicated at numerous meetings that he will try to obtain funding to help the Districts ease the pain to the irrigators that the allocations will create. The CREP program, if approved for the area, requires a 20% match of local funds. This match could come from either the State level or from the District.

- A motion was made by Anderjaska and second by Moore to change proposal #4 to implement an additional 10% reduction in acres or pumping in the alluvial area and 5% reduction in acres or pumping in the upland areas in water short years conditional on funding from the State for incentive programs.

Ayes-10 Nays-Hoyt motion carried

Hoyt expressed concerns over making the changes to proposal #4 conditional on State funding. He is concerned that this could slow the process of coming to an agreement with DNR.

- A motion was made by Harsh and second by Peters to approve the proposal as corrected.

Ayes-11 Nays-0 motion carried

Discussion was held on where to limit certified acres.

- A motion was made by Madsen and second by Anderjaska to freeze certify acres at 320,000 acres.

Ayes-11 Nays-0 motion carried

The next settlement implementation meeting is schedule for May 14, 2004 in Cambridge.

Fornoff, Haag, Madsen, Moore, and Wertz plan to attend.

Discussion was held on scheduling informational meetings. These meetings would give the District an opportunity to update the public on the options the Directors are looking for and give the public an opportunity to give their input. It was recommended that these meetings be scheduled after the June board meeting. It was decided by general consensus that an informational meeting would be scheduled in Wallace, Hayes Center, Trenton, McCook and Curtis the week of June 14, 2004. These meetings will be advertised as special board meetings. Chairman Haag encourages Directors to attend as many of the meetings as possible. Griffith will work on setting up meeting places and will put a schedule of the meetings in the May newsletter.

OTHER GROUND WATER ACTIVITY

Steve Melvin, Frontier County Extension, would like to develop an additional Soil Moisture Monitoring site east of Curtis. A proposal for this site was circulated. Melvin is requesting the District contribute \$1873 for the purchase of additional equipment.

- A motion was made by Roberts and second by Wertz to approve funding Melvin's request for equipment to develop the Curtis site 100%.
- A motion was made by Anderjaska to fund only 50% of the project.

Motion failed due to lack of a second

Vote on original motion.

SOIL AND WATER CONSERVATION MANAGEMENT FUNDS

Smith reviewed the cost-share summary report and the cost-share summary report on flow meters. The cost-share summary report includes new applications for tree cost-share.

- ◆ A motion was made by Anderjaska and second by Moore to accept these reports as presented and approve the applications.

Ayes-11 Nays-0 motion carried

A copy of these reports is on file with the minutes.

CHEMIGATION

Smith reported that inspections are beginning.

TREE PLANTING

Smith reported that tree planting has been completed. Mulch is still being installed.

Anderjaska reported that he had received complaints about the way trees were planted in Hayes County. Smith indicated that the complaints had been discussed and handled in the office.

PERSONNEL & OPERATIONS COMM. RECOMMENDATIONS

A copy of the updated equipment needs list was mailed to Directors. Smith indicated that he was unsure if the Directors had approved the list with the recommendations at April meeting. General Consensus of the Board was that the list had been approved when the Committee recommendations were approved.


BUILDING FOR SALE
