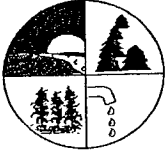

REGULAR MEETING

The regular monthly board meeting was called to order by Chairman Haag at 7:38p.m. The agenda and roster were circulated to those present.

Items added to the agenda: none

Official notice of the regular monthly meeting was published in the **North Platte Telegraph** and the **McCook Daily Gazette** and was posted in the **NRD office** and on the District Website at **www.mrnrd.org**. As a courtesy it was also announced on **local radio stations**.

MINUTES

The minutes for the regular board meeting and public hearings on June 8, 2004 were presented. Minutes for the informational meetings held the week of June 14, 2004 were also presented.

- ◆ A motion was made by Harsh and second by Fornoff to approve the minutes for the June regular board meeting, June public hearings and June informational meetings as presented.

Ayes-9 Nays-0 Abstain-Madsen motion carried

The meeting was recessed at 7:40p.m. to open the public hearing.

The meeting was reconvened at 8:17p.m.

CONSIDER VARIANCE REQUESTS

Merrigan reported that 310,410 acres currently certified. Discussion was held on the requests and where that would place the total acres figure.

- ◆ A motion was made by Anderjaska and second by Harsh to approve an additional 34.9 acres for Riley Morthole, 28.1 acres for Lloyd Benjamin, 6.8 acres for Jeff Brooks, and 35 acres for Gary Connell and to deny the 17.6 acres for Dean Berndt due to lack of history.

Ayes-9 Nays-Madsen motion carried

Peters arrived at 8:22p.m.

Discussion was held on the criteria that have to be met in order to certify acres.

- ◆ A motion was made by Roberts and second by Wertz to approve 335.9 acres for James Schmadeke, 652.2 acres for Larry Jeffers, 125 acres for David McConville, 65.7 acres for Don Follett, 32 acres for Bob Haag, and 219 acres for Robert Spencer and deny the request from Arlo Banzhaf due to lack of history and Gary Poindextor due to no testimony presented.

Ayes-7 Nays-Anderjaska, Madsen, and Moore Abstain Peters Motion carried

GROUNDWATER MANAGEMENT

Well permit report was mailed to Directors. There are new applications for 3 replacement wells.

Smith reviewed the July 9 meeting held by DNR. Approximately 120 people in attendance.

Smith reviewed the options that the committee had put together.

- ◆ A motion was made by Madsen to present the proposal to DNR but to allocate to only 75% of the acres in water short years.

The motion died due to lack of a second.

Anderjaska stated that he feels that the Directors should wait until after the meeting on Thursday between the Governor, DNR, NARD and Senator Shrock. Discussion was held on where the other Districts are in the process. The economic impact study will be released next week at a meeting in Alma. Patterson reported that he feels that the Directors could wait until after that meeting to make a decision. According to Patterson, DNR has suggested 5% less than historical use. Patterson believes that the proposal meets that requirement. There are incentive programs being looked at for retiring acres. Patterson suggests having something

ready for hearing by August 10. This will give Patterson an opportunity to visit with the other Districts involved. He would like to see the four NRDs move forward together. A decision on August 10 allows enough time for a hearing to be scheduled prior to the September board meeting.

Discussion was held on having a meeting with all three boards to discuss what each District is considering. Smith will be looking into planning a meeting. Dean Edson has offered to help any way possible with the meeting.

- ◆ A motion was made by Anderjaska and second by Fornoff to postpone any action until the August meeting.

Ayes-11 Nays-0 motion carried

Hoyt questioned whether the retired acres portion of the proposal had to be decided with the other rules or whether it could be considered at a later date. Smith indicated that it would be necessary to address it at some level in order to permit programs like CREP to provide incentive payments for retirement of acres.

Smith encourages the Directors to review the rules and regulations and submit corrections to him.

There are 30 sections in the Platte drainage that needs to be considered and addressed in the rules and regulations.

A time line for the hearing will be discussed at the August board meeting. A hearing separate from the board meeting will be scheduled. General consensus was to hold the hearing in McCook.

FOUNDATION

Smith has talked to a group that is trying to form a foundation that would possibly be able to assist the Republican Basin with incentive programs. Smith reviewed some of the concepts the group is considering. It is a statewide foundation.

LEGAL MATTERS

Smith gave an update on legal matters.

OPEN FORUM

Various members of the public presented some of their opinions concerning the settlement and the proposed new rules and regulations. The first speaker stated that the Directors should "Keep it simple" and give an allocation that can be lived with. The speaker felt that the District is doing all the giving. He felt that the State had not made any effort to compromise. The next speaker indicated that he thought the best solution was to get some State and Federal funds to retire some acres. He also thought that the allocation should be a percentage decrease of previous use instead of an inch amount for everybody. The speaker expressed the opinion that the current proposals will put the good farmers out of business.

The next speaker indicated that he hates to see decisions made based on statistics from the last 4 years that have been drought conditions. Many farmers already have cut usage by installing pivots. The speaker thought that it would be a good idea to wait on allocations until the impact of the pivot conversions is seen.

Another speaker raised the question as to why the Twin Platte has no responsibility in this lawsuit. Wells are being drilled in the Twin Platte. Concern was expressed that water would be pumped from the Twin Platte to the Middle Republican.

FINANCIAL ACTIONS

The financial report for June was presented. The County Treasurer's Balance was \$117,211.56. Smith reviewed the reports.

- ◆ A motion was made by Anderjaska and second by Dodson to approve the June financial report as presented.

Ayes-11 Nays-0 motion carried

The monthly budget comparison was presented and reviewed. A summary of the lawsuit settlement funds was also handed out.

BUDGET

A rough draft budget was mailed to Directors. Smith reviewed the budget. Some changes will need to be made after decisions are made on the hearing. The board also has an additional \$.01 taxing authority that could be used if so decided. The budget hearing will be September 14 prior to the regular board meeting. Smith will probably present two draft budgets at the August meeting depending on what the Directors decide to do with the rules and regulations.

AUDIT

Auditors will be in the office July 14-16. The same auditors as last year are being used. Smith reported that he overlooked the hiring of a new auditor as was directed by the board previously.

DUES

A list of dues paid during the fiscal year 2004 was mailed to directors. Smith reviewed the list.

- ◆ A motion was made by Roberts and second by Wertz to approve dues as submitted.

Ayes-8 Nays-Haag Abstain-Harsh, Moore Motion carried

NRCS REPORT

Dave Griffith gave a report on NRCS activities. Griffith reviewed the history of the EQIP program. Approximately \$1.7 million in applications were received. The initial allocation is \$1,000,000. Griffith anticipates that the District could receive an additional \$300,000 in allocations. 67 contracts have been written and are ready for signature. Work is still being done to get the CREP program in place.

This is Griffith's last meeting. He starts in Lincoln August 9. The State office is meeting this week to hire Griffith's replacement. Haag requested that a letter of commendation referencing the job that Griffith has done in the District be sent from the Middle Republican NRD to Steve Chick, NRCS.

NARD

The last Association meeting was scheduled June 21 in South Sioux City. Anderjaska reported on the meeting. \$400 deductible was the only difference in insurance benefits approved compared to what was presented at the June meeting. Fall Conference is scheduled for Sept. 26-28 in Kearney. August 25 is the deadline for resolutions. Madsen circulated a resolution that he would like the Directors to send to NARD. The resolution proposes changes to the Water Well Standards and Contractors' Licensing Act. The resolution looks at the issue of landowners drilling wells.

- ◆ A motion was made by Anderjaska and second by Dodson to support the resolution and submit it to NARD.

Ayes-8 Nays-Harsh, Hoyt, and Roberts Motion carried
Dean Edson, NARD, reported that he will be attending a meeting Thursday with Roger Patterson, Senator Shrock and the Governor to discuss Republican Basin issues. Discussion was held on scheduling a meeting with the four NRDs with Dean Edson present. Smith asked Edson to discuss the fee assessment. Edson reviewed section 79 of LB 962. The language in this legislation is very unclear as to whether the NRD has the authority to implement a per acre fee.

NACD

E-notes for 6-29-04 and 7-6-04 were mailed to Directors.

NNRC

The next meeting is scheduled for July 20 & 21 in York.

INFORMATION & EDUCATION

Thank you from Range Camp attendees circulated. There were 856 hits on the Districts website.

NEBRASKA REPUBLICAN RIVER MANAGEMENT DISTRICTS ASSOC.

The next meeting will be July 22, 2004 in Alma. The economic impact report that was done for the power districts is scheduled to be released at this meeting.

OTHER AGENCIES OR ASSOCIATIONS

Smith reported that the NRD's only involvement with the Rural Water Development in Cambridge and Bartley is as an advisor.

LEGISLATION

Dean Edson, NARD, sent a letter to all the NRDs reporting on the resolutions that have been introduced by the senators and committees to be studied during the interim. The letter Edson sent only shows the resolutions of interest to NRDs.

BUFFERSTRIP

The annual payments have been made.

SOIL AND WATER CONSERVATION MANAGEMENT FUNDS

Smith reviewed the cost-share summary report and the cost-share summary report on flow meters. A year end report, as well as a current report, was handed out to the Directors. Discussion was held on how to proceed with any wells not metered by December 31, 2004. \$26,000 of the State cost share funds were not used in fiscal year 2003-2004.

- ◆ A motion was made by Roberts and second by Wertz to accept these reports as presented and approve the applications.

Ayes-10 Nays-0 Abstain-Harsh motion carried
A copy of these reports is on file with the minutes.

WATERSHEDS

With the recent rains, some of the watersheds have had water in them. They will need to be inspected.

PERSONNEL

I & E position is still open. A number of applications were received. The position was offered to two people who both declined the position. The staff is currently informally looking for a person to fill the position.

CONSIDER BUILDING OFFER

At the June meeting the Directors approved offering \$18,000 for the building that adjoins the District's office in Curtis. Adkisson contacted Smith and offered a counter offer of \$23,000. Discussion was held on the price of remodeling.

- ◆ A motion was made by Peters and second by Roberts to offer \$20,000.

PLOTTER PURCHASE

The motion died due to lack of a second.

PUBLIC HEARING

Chairman Haag called the public hearing to order at 7:41p.m. The agenda and roster were circulated to those present.

OFFICIAL NOTICE OF THIS PUBLIC HEARING WAS PUBLISHED NOT LESS THAN TEN DAYS PRIOR TO THE HEARING IN THE NORTH PLATTE TELEGRAPH AND THE MCCOOK GAZETTE. INDIVIDUALS INVOLVED IN THE HEARING WERE NOTIFIED BY MAIL.

STATEMENT OF PURPOSE

The purpose of this hearing is to receive testimony concerning a complaint of non-compliance with the District's Ground Water Management Area Rules and Regulations, specifically late certification of irrigated acres not in accordance with Rule 8.

TESTIMONY

Robert Merrigan, assistant manager, presented testimony for the District. Merrigan reviewed the list of requests that he had received. There are two groups being represented. The first is people who have already certified but want to change their certification. The second group is those who have not certified any acres to date.

ADDITIONAL ACRES

Riley Morthole, Culbertson, requested an additional 34.9 acres. When Morthole certified his acres, he only reported the acres currently irrigated under the pivots that have been installed. He did not report the corners that could be flood irrigated. All of these acres are supplemental acres and Morthole still purchases surface water for all of the acres.

Dean Berndt, Danbury, requested an additional 17.6 acres. Berndt has 50 acres certified. He has recently installed a new pivot that irrigates 68.1. The extra acres were dryland until pivot was installed.

Lloyd Benjamin, presented testimony certified 108 acres when it should have been 136.1 acres. Benjamin purchased property in December 1999. Berndt reviewed the history on this land since he purchased the ground. A pivot was installed in 2002. There is 92 acres under the pivot. When water permits, he flood irrigates the corners. Berndt testified that he reported only what was irrigated in the current year (2003) instead of what is historically irrigated. The County Assessor records indicate that 134 acres are taxed as irrigated. Berndt is requesting an increase of 28.1 acres.

LATE CERTIFICATIONS

Merrigan testified that James Schmadeke received the certified letter for the June hearing the day after the hearing. They request 335.9 acres for two pivots. Merrigan reported that Bob Haag and Robert Spencer are requesting certified acres for wells that have just been registered.

Arlo Banzhaf requested certification of 53 acres. They would like to install a wiper. This ground irrigated 83 acres in 1989. It has not been irrigated since this time and is no longer carried by the Assessor as irrigated.

Larry Jeffers testified that he did not know that the acres on his 5 pivots were not certified. He is requesting a total of 652.2 acres for these 5 pivots. All the wells are metered.


David McConville testified that he received the certified letter for the June hearing the day after the hearing. McConville is requesting 125 acres. The land has not been irrigated for 6 or 7 years due to the need for terraces to be installed. It was irrigated prior to that.

Randy Hileman requested 65.7 acres for Don Follett. Follett has been ill and did not get acres certified. All the ground was irrigated in 1998 and 1999.

Bob Haag requested acres for a well that had never been registered. The well irrigates 32 or 33 acres. The well is now registered but still needs a meter installed.

Robert Spencer requested acres for 3 wells that had been drilled in the early 80s but was never registered. Spencer is requesting 219 acres. There is one pivot and the rest is flood. All but possibly 22 is currently irrigated.

Chairman Haag closed the hearing at 8:16 p.m.

NOW THEREFORE, the Governing Body of the Middle Republican Natural Resources District, by a majority vote, resolves that:

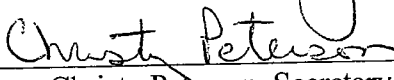
1. The 2004-2005 property tax request be set at \$618,396.00
